1. INTRODUCTION OF RSMML

2. ABOUT THE PRODUCT - LOW GRADE BENTONITE

Low grade Bentonite is being accumulated as inter-burden waste material during the mining of Lignite at Giral Lignite Mines situated at Barmer. 3. PRE-REQUISITE DOCUMENTS TO BE SUBMITTED WITH THE PROPOSAL OFFER

Any Indian buyer (i.e. individual, partnership, companies etc.) can participate by submitting their offer against the "Expression of Interest" (E.O.I.). They shall have to submit following documents to the office of Deputy General Manager (Marketing), RSMML, SBU & PC – Lignite, Jaipur :-

- (a) Copy of valid Sales Tax Registration Certificate.
- (b) Copy of PAN Card.
- (c) Copy of Audited Balance Sheet and Profit & Loss Account for last three (03) financial years.

Note: Above documents shall be the basis for qualifying to receive R.F.P.

4. QUANTITY

The interested parties are required to quote the desired quantity in Annexure-1 to be lifted from the stock available at the mines after inspecting the material at the site.

5. PERIOD

The period of lifting to be quoted in Annexure-1 during which the party desires to lift the complete allocated quantity.

6. PRICE

Expected Sale Price excluding applicable Royalty, Excise Duty and VAT etc. to be quoted in Annexure-1.

7. PAYMENT TERMS

Sale shall be executed on receipt of 100% advance payment.

8. SELECTION PROCESS/CRITERIA

Each offer received against the advertisement shall be evaluated on the basis of desired information provided by the party like expected sale price, quantity and period. Thereafter, after evaluation of the E.O.I. offers, R.F.P. to the eligible buyers shall be issued for submitting the price offer based on the terms & conditions mentioned in the R.F.P.

Successful bidder/bidders shall be selected amongst all the bidders who besides satisfying the above pre-qualification criterion also accept the following conditions:-

i) The reserve price shall be fixed by RSMML and made public to the eligible bidders at the time of issuance of the RFP document.

ii) The bidder shall be required to quote the sale price above the reserve price fixed by RSMML. Any Bidder quoting a price lower than the reserve price shall be summarily rejected.

iii) Precedence will be accorded to the highest bid price in the descending order (H1, H2, H3 and so on) as long as the offered quantity is available for allocation.

iv) If two or more buyers bid the same highest price, precedence for allotment will be accorded to the buyer who has placed the bid for the higher quantity.

vi) In case, two or more buyers bid the same price and the same quantity, the quantity shall be proportionately allocated to all such buyers.

9. QUALITY OF MINERAL

The sale will be executed on "As is where is, and no complaint basis". The quality of the mineral shall have to be ascertained by the interested buyer at their own level and submit the offer accordingly.

10. LOADING AND DESPATCH

Loading of Bentonite into the buyer's trucks shall be arranged by RSMML. The material shall be dispatched subject to issuance of Short Term Permit from Department of Mines & Geology, Rajasthan.

11. FORCE MAJEURE

The terms of this E.O.I. shall also be subject to standard force majeure conditions, which shall cover acts of God, fire, cyclone, riots, wars and acts of government, notified restrictions on production and sale of mineral etc. In case any party is hindered in completing its obligations, it will inform the same in writing.

12. PRE BID SUBMISSION MEETING

A meeting shall be held on 16.05.2016 at 11 A.M. at SBU & PC - Lignite, Jaipur to brief the potential bidders and to answer the queries of the bidders. The parties are requested to submit their queries in writing or by Fax; so as to reach the office of Deputy General Manager (Marketing), RSMML, SBU & PC - Lignite, Jaipur at least ten

(10) days before the scheduled date of the meeting. It may not be possible to answer the questions during the meeting if not received earlier.

Attendance at the Pre-Bid Meeting is not mandatory and not attending will not be a cause for disqualification of the bidder. It is, however, in the interest of the bidder to attend the Pre-Bid Meeting. The interested parties are required to submit their proposal as per the enclosed Proforma (Annexure-1); so as to reach us latest by 31.05.2016 upto 3 P.M. After evaluation of the proposal received, the pre-qualified parties shall be requested for detailed Request for Proposal (R.F.P.); for which a detailed R.F.P. document shall be given to the pre-qualified parties.
