(4+2) tube lights and 04 Nos. (2+2) 48" Fan of Havells/Crompton/Orient make with ICDP & MCB. Earthing pit with copper plate, wire and GI pipe as per standard speciation shall be constructed for the WB electrical equipments. Further, a separate suitable lightening arrestor with grounding/earthing as per CPWD specifications shall be constructed and provided by the supplier. The same shall be installed by supplier in proper manner. Electrical points and provisions for installation of two numbers split AC should be provided in the room. The electric wiring in building for equipments/ computers should be layed properly for UPS & Inverter.
