#### SECTION - I: INSTRUCTION FOR PREPARATION & SUBMISSION OF TENDER:

- **1.0** One copy of complete tender document should be sealed & signed as a token of acceptance for its terms and conditions and returned intact along-with part I (no page should be detached).
- **2.0** Tender must be submitted in two parts i.e. Techno Commercial (Part I) and Price Bid (Part II). The tender should be packed in four sealed envelopes as elaborated below:
- 2.1 Sealed Envelop No. 1: This envelop should contain DD/PO towards the tender document fee (incase the tender document has been downloaded from the website of RSMML) or the copy of cash receipt (incase the tender document has been purchased from the office of FA, CO and DD/PO towards requisite BID SECURITY as per provisions mentioned in the tender document. - **2.5** In case above mentioned pattern for submitting tender document is not followed by the tenderer, their tender is liable to be ignored.

#### **3.0 DELIVERY OF TENDER:**

The submission and delivery of tenders within the specified date and time will be the sole responsibility of the Tenderer. In case the date of submission/opening of tender happens to be a holiday, than tenders may be submitted/opened on the next full working day up-to prescribed time.

- **3.1 Late Tender:** The tenders received after specified due date & time of submission of tender will be treated as late tender and will not be considered at all.
- 3.2 RSMML will not be responsible for delay in delivery of the tenders through post/speed post/courier/personal or any other means. Tenderer should quote as far as possible in the form & pattern, as envisaged herein. It will help in making proper comparison & avoid any errors/emissions.
- 3.3 Tenders other than in the prescribed form and pattern described herein are liable to be ignored as it makes comparison difficult. Offers through Fax/e-mail /telegram will not be considered.

Printed conditions on the back of letters originating from Tenderer will be ignored.

#### 4.0 **EXCEPTIONS & DEVIATIONS:**

Tenderer are advised to submit their offer based on the terms & conditions and specifications contained in the tender document and not to stipulate any deviations. Offer containing stipulations of deviations to the terms & conditions are liable to be rejected. The tender will furnish the undertaking towards acceptance of specifications, all terms and conditions of tender in Annexure-IV.

In case it is absolutely unavoidable to deviate from tender conditions & if the tenderer desires to propose any addition/deviation /alterations to any of the terms and conditions contained in the tender document, the same must be expressed clearly in Annexure-IV and furnish along-with part-I of the offer, without making any correction on the body of the tender documents. In the absence of it, it will be deemed as unqualified acceptance by the Tenderer to all terms and conditions contained herein. Tenderer should mention the deviations at their risk of rejection only. Deviations mentioned anywhere else in the offer shall be ignored without any consequences to the company.

- **5.0** Quotation qualified by such vague and indefinite expressions as "SUBJECT TO IMMEDIATE ACCEPTANCE" or "SUBJECT TO PRIOR SALE" is liable to be ignored.
- **6.0** Tenders containing corrections and alterations are liable to be rejected unless all such corrections and alterations are sealed and signed by the tenderer.

#### 7.0 SUPPORTING DOCUMENTS:

The Tenderer should furnish the following supporting documents along with offer:

- i) DD/BC/PO or cash receipt towards tender document fee, as per 2.1.
- ii) Demand Draft/PO/BC towards bid security in the manner specified in tender as per clause no. 2.1 & 15.0.
- iii) Copy of complete tender document as issued duly filled and sealed & signed on each page by the tenderer as token of acceptance of specification, terms & conditions of tender
- iv) Supporting documents towards tenderer status.

- Note: Each & every page of document including copy of tender document & Annexure furnished along-with part I & Part II should be sealed & Signed by the authorized person of the tenderer.

#### 8.0 **BEFORE SUBMITTING TENDER:**

Tenderer shall be deemed to have satisfied himself of all conditions liable to be encountered during the execution of the contract or rates quoted in the offer are adequate and all inclusive with respect to all factors circumstances and conditions likely to be incidental to the execution of the contract, as per the scope and conditions given herein.

### **9.0 PRICE:**

- i) Tenderer is to offer most competitive rates giving maximum discount on the prevailing price list prices for supply of Lucas TVS & Lispart make Auto Electric items (as applicable on date of submission of tender), as per Annexure – VIII.
- ii) The details of Lucas TVS & Lispart make Auto Electric items given in price bid are only to determine economic bidder status. However, RC will be entered on the basis of prevailing price list.
- iii) Tenderers are requested to mention the rate of excise duty, CST/VAT or any other charges extra; the same must be specifically stated. In the absence of any such stipulation it will be presumed that the price includes all such charges and no claim for the same will be entertained.
- iv) The prices should be offered strictly as per price bid format (Annex. VIII). Tenderer is requested to submit duly sealed and signed blank copy of the price bid, in acceptance of the price bid format.
- v) Tenderer should not mention any conditions/deviation to the terms and conditions of tender in the price bid, if any same will be ignored.

# **10.0 PRICE VARIATION:**

Price applicable as per price list of OEM prevailing at the time of order. Variation on account of changes in Taxes & Duties by the Government will be considered on production of documentary proof. No variation on any other grounds whatsoever shall be considered or be admissible.

**Variation on account of Government Taxes & Duties**: The tenderer/bidder will indicate in his offer the applicable percentage of Taxes & duties at the time of opening of offer. In the event of any increase/decrease in the Taxes & duties by the Government within the delivery period, as offered in the price bid, the difference of the same shall be passed on to the Contractor/RSMML as the case may be. The subsequent increase shall be payable only on the production of authentic documentary proof by the Supplier.

Save and except as aforesaid, the tenderer shall not be entitled to raise any claim and/or demand and/or any dispute on account of escalation for increase in the prices of any other item or element.

#### 11.0 VAT:

In case the tenderer will raise VAT invoice charging VAT, then, as per the Gazette Notification dated 09.03.10 of Govt. of Rajasthan w.r.t. amendment of rule 38 and insertion of new rule 40A, the VAT amount of the invoices raised by the tenderer will be deposited to the concern department of Govt. directly by RSMML. In lieu, RSMML will issue a certificate in form VAT-41A to you towards the VAT amount so deducted/deposited for the necessary action at tenderer's end.

#### **12.0 AUTHORITY TO SIGN TENDER:**

The tender should be signed by the person who is legally authorized to enter into commitments on behalf of the Tenderer.

#### **13.0 OPENING OF TENDERS:**

Tenders will be opened on the fixed date and time in the presence of Tenderer or their authorized representative who may wish to be present at the opening of the tender at the place, time and date as specified in the schedule.

#### 14.0 VALIDITY:

The tenderer shall keep the offer open for acceptance by RSMML for a minimum period of 120 days from the date of opening of tender within which period the tenderer shall have no right to withdraw, amend or modify his offer. In case of withdrawal/amendment/ modification the earnest money deposited by the Tenderer, as per clause No.15 hereof shall stand forfeited. This validity period may be extended further if required by mutual consent from time to time.

In case, tenderer, after issuance of communication of acceptance of offer by RSMML, fails to execute the contract as per the conditions of the contract, such an event will be considered as the tenderer calculated willful breach of the contract, the cost & consequence of which shall be on the sole account of the tenderer. Moreover, RSMML have full right to claim damages thereof in addition to the forfeiture of EMD.

#### **15.0 BID SECURITY:**

The tenderer shall deposit (interest free) a sum of **Rs. 12,000/-** (Rs. Twelve thousand only) as bid security along-with the tender by Demand Draft/Banker's Pay order. It should be in favour of RSMML payable at Udaipur. Offers not accompanied with the bid security will not be considered. Cheque or Bank Guarantee will not be accepted towards Bid Security.

- **15.1** The BID SECURITY shall be forfeited in the following cases:
- a. If the tenderer cancels, withdraws amends or modifies the offer on its own after submission of tender.
- b. If the tenderer does not submit the prescribed security deposit cum performance guarantee.
- c. If it is established that tenderer has submitted any wrong information/forged document along-with the tender or thereafter.
- d. If the tenderer declines to accept the order placed by the Company, subsequent to acceptance of his offer.
- e. If the tenderer breaches any provision of code of integrity prescribed for bidders as per Annexure- B.
- **15.2** Bid security of unsuccessful tenderer will be refunded after finalization of tender/validity of the offer has expired. The bid

security of successful tenderer will be refunded after receipt of Security Deposit cum performance guarantee as per contract.

- **15.3** The Bid security of a tenderer lying with the company in respect of other tenders awaiting approval or rejected or on account of contract completed will not be adjusted towards Bid security deposit for the fresh tenders. However, the Bid security originally deposited may be taken into consideration in case tenders are re-invited.
- **15.4** In case of participation by Undertakings, Corporations, Autonomous Bodies which are controlled and managed by Govt., Govt. Undertakings and Companies of Union Govt. & Govt. of Rajasthan, they are exempted from deposition of Bid security.
- **15.5** Bid security will be taken @ 25% of the total value of Bid security of tender incase of participation by SSI unit of Rajasthan subject to that the tenderer has participated against the tender in a capacity of manufacturer of offered product.
- **15.6** Except above, no Bid security exemption will be given to any party on any grounds and their offer will liable for exemption.
- **16.0 RSMML RIGHTS:** RSMML reserves the following rights:
- a) not to accept any offer or reject any or all the offers.
- b) to cancel the tender, postpone it for another date, change the venue of the receipt/opening of the tender.
- c) to enter into parallel RC.
- d) entry into RC with more than one tenders.
- e) to reject the offer, if it is established that the tenderer has submit any wrong & misleading information /forged document along with offer or thereafter.

As a result of such change the Company will not entertain any claim of supplier whatsoever.

# **17.0 NEGOTIATIONS:-**

- i) Negotiations will be conducted with the lowest tenderer only. In case of non-satisfactory achievement of rates from lowest tenderer, RSMML may choose to make a written counter offer to the lowest tenderer and if this is not accepted, RSMML may decide to reject and re-invite fresh tenders or to make the same counter-offer first to the second lowest tenderer, then to the third lowest tenderer and so on in the order of initial bidding, and work order be awarded to the tenderer who accepts the counter offer.
- ii) In the case, when the quotations given by the tenderer during negotiations is higher than the original quotation of the tenderer then the tenderer will be bound by the lower rate originally quoted by the tenderer.
- iii) In case of negotiations, representative of the tenderer attending negotiations must possess written authority from the tenderer to the effect that he is competent to modify/amend the submitted tender deviations and rates offered by them.

iv) In the event the company does not find the lowest quoted rate, acceptable to it, then the tender will be scrapped and may be reinvited, or company may take any other suitable action as deemed fit looking to the exigency of the work.

### **18.0 TERMINATION:**

- a. In case of failure of tenderer to perform the job as required under this tender or observe breach of any of the terms and conditions by the tenderer, the company shall give a notice to rectify the default or breach within 10 days. Failure to rectify such default/ breach may result into termination of the contract and forfeiture of security deposit without any prejudice to the company's rights to claim damages/costs/loss etc caused by such default / breach. Such termination shall not absolve the supplier from the liabilities accruing till the date of such termination.
- b. The contract may also be terminated in the event the supplier is being adjudged insolvent or going into Liquidation or Winding up of their business, or making arrangement with their creditors.
- c. Notwithstanding anything contained herein above, the company in its absolute discretion may at any time terminate the order without assigning any reason thereof by giving Fifteen day's notice to the supplier at their last notified address. In such an event the supplier shall not be entitled to raise any claim or demand for compensation, loss of profit and/or damages and / or losses or costs by reason of such earlier termination on any ground whatsoever.

#### **19.0 FORCE MAJEURE:**

If at any time, during the continuance of the contract, the performance in whole or in part by either party (sub-vendors excluded) and/or obligations under this contract shall be prevented or delayed by reason of any war, Hostility acts of public enemy, civil commotion, sabotage, fires, floods, explosion, epidemics, quarantine restrictions, non-performance due to Acts of God or Acts of Government / statutory bodies (herein after referred as "Event") then provided a notice of the happening of any such event is given within **seven days** from the date of occurrence thereof neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damage against the other in respect of such non-performance or delay in performance and the deliveries and/or performance of the work under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist and decision of Company as to whether the deliveries and/or performance of the work have been so resumed or not shall be final and conclusive. Provided further that if the performance in whole or in part is delayed by reasons of any such events for a period exceeding thirty days either party may at its option terminate the contract.

**20.0 JURISDICTION:** The contract is subject to the jurisdiction of courts at Udaipur in the state of Rajasthan.

# Section II: SPECIAL CONDITIONS OF CONTRACT (SCC)

#### **1.0 SPECIFICATIONS:**

Specifications for supply of genuine Lucas TVS & Lispart make Auto Electric items & Lucas make Batteries to our SBU & PC, Jhamarkotra Mines on RC basis as per details given below:-

#### 2.0 SCOPE OF SUPPLY:

The scope of supply shall be the delivery of Lucas Auto Electric items by the supplier to our SBU & PC (RP), Jhamarkotra Mines, Udaipur in accordance with the agreed specifications, terms and conditions. The supplier shall be entirely responsible for the performance of the supply in all respects according to the intent and meaning of the specification data etc.

#### 3.0 NO COMPENSATION FOR ALTERATION OF DELIVERY SCHEDULE OR SUSPENSION OF SUPPLIES:

If at any time before commencement of the supply if the Company, for any reason, whatsoever do not require the whole supply or part thereof as specified in the PO, shall give notice in writing of the same to the supplier and the supplier shall not be entitled for any compensation and/or damage of any kind whatsoever on account for loss or profit etc. nor the contractor be entitled to any claim for compensation for re-scheduling of delivery period.

#### 4.0 SECURITY DEPOSIT CUM PERFORMANCE GUARANTEE:

- i) As security for the due, proper and faithful fulfillment of the obligations under the contract, the tenderer will furnish to RSMML Security Deposit cum Performance Guarantee equal to 5% of total value of contract by Demand Draft or in the form of Bank Guarantee in RSMML Performa (Format enclosed) from any Public Sector/ ICICI/HDFC/AXIS Bank, having its branch at Udaipur within 21 days from the date of issue of PO. The Bank Guarantee should be valid for contractual period including warrantee + 6 months claim period.
- ii) The BG shall liable to be invoked/amount of SD is liable to be forfeited wholly or partly at the sole discretion of the Company, should the supplier either fails to execute the work within the stipulated period or fails to fulfill the agreed obligations or fails to settle in full it's dues to the Company.

- iii) The Company is empowered to recover from the S.D. any sum due and /or any other sum that may be fixed by the Company as being the amount or loss or losses or damages suffered by it due to un-satisfactorily performance or non fulfillment of any of the conditions of the tender/contract.
- iv) The Bank Guarantee/S.D. shall remain in force and binding, notwithstanding, if any variation, alternation, modification is made to the contract or any extension of the contract period is granted by RSMML.
- v) RSMML shall not pay any interest on the Security Deposit. The security Deposit shall be released on application by the contractor after the expiry of guarantees and after discharge of all the supplier's obligations under the contract.
- vi) The said Security shall not in any way be construed as a limitation of the supplier's responsibility or liability pertaining to its obligations and guarantees under the contract and shall be without prejudice to any other remedies available to RSMML in terms of the contract and or as per the laws of the land.
- vii) S.D. should be send to the office of GGM (RP).
- viii) In case the tenderer is willing to furnish SD in the form of BG, that it should be on the non-judicial stamp paper of value equal to @ 0.1% of total SD amount or Rs. 200/- whichever is higher.

# 5.0 GUARANTEE/WARANTEE:

The Assy. /Sub assy. /spare parts supplied should be genuine spares of M/s Lucas and will be guaranteed/warranted against any manufacturing defects /workmanship as per the warrantee/guarantee terms of the manufacture. In the event of premature failure during the warranty/ guarantee period, tenderer will either replace / repair the same free of cost within one month from the date of information of premature failure. Similarly in the event of rejection of the material the same shall be replaced within one month of receipt of the rejection report.

#### 6. 0 DELIVERY SCHEDULE:

Tenderer should state the earliest delivery period they can offer. The supply has to be made as per delivery schedule placed by the Consignee or his authorised Officer during the period of contract. However, delivery schedule will be informed by the consignee on as and when requirement basis at least 30 days in advance. RSMML does not give any quantum towards Annual/Monthly quantity of items against RC.

#### 7.0 DELIVERY BASIS:

Terms of delivery shall be on the basis of f.o.r. destination. The quoted price shall be on f.o.r destination basis inclusive of packing, forwarding, transport and any other delivery charges

### 8.0 PERIOD OF CONTRACT:

One year from the date of issue of Rate Contract, this can be extended on mutual consent.

**9.0 INSPECTION:** Inspection shall be carried out at consignee end after receipt of the material at site. ## Additional Conditions of Contract

#### 1. Correction of arithmetical errors

- Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:
- i) if there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii) If there is an error in a total corresponding to the addition or subtraction of sub totals, the subtotals shall prevail and the total shall be corrected; and
- iii) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated bid does not accept the correction of errors, its bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

#### 2. Procuring Entity's Right to Vary Quantities

- (i) At the time of award of contract, the quantity of Goods, works or services originally specified in the Bidding Document may be increased or decreased by a specified percentage, but such increase or decrease shall not exceed twenty percent, of the quantity specified in the Bidding Document.
