



The uploaded bid document shall be considered valid for participation in the bid process subject to submission of required cost of tender document, e-Tendering processing fee & EMD and the same shall be reached to the office of undersigned on or before the time specified for submission of techno-commercial part of tender.

The tender shall be pre-qualified on the basis of documents furnished/uploaded along with Techno-commercial bid in support of above. The decision of the company will be final and binding in this regard.

It is mandatory that proprietor/all the partners (in case of partnership firm) / all the Directors of the Company become the members of the society to be constituted to carry out the job under Part A. The tenderer is required to furnish an undertaking, in proforma provided in tender document on non-judicial stamp paper of worth Rs. 100/-, in this respect, without which their offers would not be considered. Further, it is enjoined upon from such members that they cannot resign from the society until the contract period is over.

It is to be noted that, in case of Company registered under Companies Act, turnover of the Company shall only be considered. The Company reserves its right to call for any additional information so as to check the eligibility of the tenderer.

Joint ventures/consortium /partnership are allowed to participate in this tender subject to the jointly/severely responsibility, in such cases the turnover of partners/members should be considered.

The price bid of only those bidders shall be opened who qualify in technical bid as per criteria laid in tender & only qualified bidders will be informed about price bid opening.

The tenderer/bidder who has earlier been suspended, or, banned, or, whose contract has been terminated including those against whom any FIR has been lodged and is pending, and, has not been disposed off in favour of tenderer meaning thereby acquittal of the tenderer, by the date of opening of techno-commercial bid shall not be eligible to participate in this tender during the currency of the suspension or banned period, or, till favorable disposal of FIR.

Those tenderers &/or proprietors/any partners of firms /any members of co-operative societies/any Director of the Companies who are either customers of RSMML for Gypsum, or, are handling/liaisoning/transportation agents of RSMML'S customers of Gypsum; are involved in above referred business of handling/liaisoning/transportation agents of RSMML's customers for Gypsum will not be eligible for participating in this tender. Offers received from such tenderers shall be rejected.

#### SECTION-II

# **Definitions, Interpretations**

### **DEFINITIONS:**

In the contract (as hereinafter defined) the following words and expression shall have the meaning hereby assigned to them, except where the context otherwise requires.

- **2.01** "RSMML" or "COMPANY" or "EMPLOYER" or "OWNER" shall mean Rajasthan State Mines & Minerals Limited," having its registered office at C-89/90, Janpath, Lal Kothi Scheme, Jaipur (Rajasthan) and Corporate Office at 4-Meera Marg, Udaipur (Rajasthan) including its successors and assignees or its representatives authorized to act on its behalf for the purpose of contract.
- 2.02 **"Appointing Authority"** wherever the expression is used shall mean the Managing Director of the Company.
- 2.03 **"Managing Director"** shall mean the Managing Director of Rajasthan State Mines & Minerals Limited or his successor in the office so designated by the Company.
- 2.04 **"Group General Manager (Contract)"** shall mean Group General Manager (Contract) of RSMML or his successor in the office so designated by the Company
- 2.05 "Head of SBU &PC -Gypsum" shall mean Group General Manager for the SBU & PC Gypsum of RSMML or his successor in the office so designated by the Company.
- 2.06 "Agent" shall mean the Agent so designated for all Gypsum & Selenite Mines as notified by the company in this behalf.
- 2.07 "Engineer-In-Charge" or "Officer Incharge" or "Authorized Officer" shall mean the Officer so designated for the overall supervision, coordination, direction and administration of the contract work from time to time by the Company and shall also include the Head of SBU &PC-Gypsum.
- 2.08 **"Engineer's Representative"** shall mean any Resident Engineer or assistant to the Engineer-In-Charge appointed from time to time by the company to perform the duties set forth in the contract whose authority may be notified in writing to the Contractor by the Company.
- 2.09 "CEU Incharge" shall mean the Mining Engineer so designated for Group of Gypsum Mines of Rajasthan State Miens Minerals Ltd., Bikaner.
- 2.10 "Mine Manager" shall mean the Mining Engineer so designated for concerning Gypsum/Selenite Mines of Rajasthan State Mines & Minerals Ltd.
- 2.11 "Approved" shall mean approved in writing by the Company/ Engineer-In-Charge.
- 2.12 **"Attested"** shall mean attestation of the photocopy of documents by the First class Magistrate /Gazetted Officer/Notary Public.
- 2.13 "Clause" shall mean the clause & sub-clause of this document &/or agreement etc.
- 2.14 **"Tender"** shall mean the offer submitted by the tenderer or bidder against this inquiry for acceptance by the Company.
- 2.15 "Contract" shall mean the agreement between the company and the contractor for execution of the work/s including therein all documents such as invitation for tender/bid, instructions to bidders, general conditions of contract, special conditions of contract, job specification, general requirements, time schedule for completion of work, drawings, letter of acceptance / telegram awarding the work, alteration/variation order, agreed variations, if any etc. Any subsequent changes made in any of these documents, would be deemed to be a part of the contract.
- 2.16 **"Contract Document"** shall mean collectively designs, drawings, plans, specifications, agreed variations, if any and other documents constituting the tender and acceptance thereof.

- 2.17 **"Tenderer" or "Bidder"** shall mean the person, Firm or Company/Co-operative society submitted a tender/ bid against the "invitation for tender bid" & shall include his/it's their legal representative, administrators, successors and executors.
- 2.18 "Contractor" / "Successful Tenderer"/ "Successful Bidder" shall mean "Tenderer/Bidder" who have either participated in the tender/enquiry of RSMM or "Contractor" to whom order/Contract have been awarded by RSMML. "Contractor" / "Successful Tenderer"/ "Successful Bidder" includes a Public Limited Company, firm whether registered or not, an individual, a Co-operative society or an associates or group of persons engaged in any Commerce, Trade, Industry, etc.
- 2.19 **"Letter of Acceptance"** shall mean intimation by a letter/ telegram/fax/e-mail to successful bidder /tenderer his/ its offer has been accepted, in accordance with the provision contained in the letter/fax.
- 2.20 **"Commencement of Work"** shall be reckoned from the date of issue of letter of acceptance /DLOA whichever is earlier including the stipulated mobilization period.
- 2.21 **"Temporary Works"** shall mean and include all temporary works of every kind for the execution of the main work as incidental and ancillary thereto.
- 2.22 **"Tendered Rates"** shall mean rate entered in figures and words in schedule/s by the Contractor for execution/ performance of all contractual obligations as per terms of the contract.
- 2.23 "Contract Rate" or Schedule Rate" or "Tendered Rates" or Rate of Remuneration" shall means rate entered in figures and words in schedule/s by the Contractor and accepted by the Company as payable to the Contractor for execution/performance of all contractual obligations based on the finished product from the specified area/s on per metric ton basis.
- 2.24 **"Contract Period"** shall mean the period agreed & allowed for execution of the contract & settlement thereof. It shall also include the extension period if any.
- 2.25 "Notice in writing or Written notice" shall mean a notice written, typed or printed sent (unless delivered personally or otherwise proved to have been received) by registered post to the last known business address or registered / Head/ local office of the addressee and shall be deemed to have been received in the ordinary course of post.
- 2.26 "Alternation/Variation order" means, any order given in writing by the Engineer-In-Charge to the Contractor from time to time effect Alteration/Variation from given Scope of Work, such an order will be without any financial implication to the Company.
- 2.27 **"Financial Year"** means a period of twelve months commencing from 1<sup>st</sup> April of a calendar & upto 31st March of succeeding calendar year.
- 2.28 **"Material"** shall mean & include Gypsum or any other material specified by the company.
- 2.29 "Screened ROM gypsum" means Run of mine Gypsum produced/collected from mined out area and screened by mechanized means.
- 2.30 **"Powder Gypsum"** means the screened ROM Gypsum is grounded under supply of agricultural grade gypsum powder by mechanized grinding unit.
- 2.31 **"Agriculture grade powder Gypsum"** means and detailed as per BIS specifications IS: 6046-2023.
- 2.32 **"HDPE Bags"** means the High-density polyethylene (HDPE) bags of 50 Kg packing capacity to be supplied by the bidder for packing of agriculture grade gypsum powder at Grinding Unit.

- 2.33 **"Department of Agriculture (DoA)"** means the state department of Agriculture, Rajasthan procuring grounded gypsum under MoU with RSMML and shall be supplied through this tender.
- 2.34 "Transportation of powder gypsum" shall means the transportation of agriculture grade packed powder gypsum in HDPE bags from mines to supply point at single point in each district notified by DoA.
- 2.35 "Clear GR" shall means clear goods receipt of powder gypsum supplied of each truck/trolla and shall be given by authorized person of DoA appointed at supply point on receipt of material in good conditions as per specifications.
- 2.36 "Ton" shall mean metric tonne (1000 Kilograms).
- 2.37 **"Site"** shall mean the land or other place on, under, in or through which the work/s are to be carried out and other land or place or area/s provided by the Company for the execution of the contract.
- 2.38 **"Statutory obligations"** would include the entire obligations, which are to be complied with as per the provision of various existing legislation applicable to mine/ working areas &/or any new statute to those, which may come in force during entire period of contract.
- 2.39 "Specified /designed location/place" shall mean allocated area for specific purpose by the company and/or DoA time to time during contract period.
- 2.40 **"Weighbridge"** shall mean any weighbridge either departmental weighbridge/s & or public weighbridge/s authorized by the company for weighment of gypsum.
- 2.41 "Access Road" shall mean Kuchha road connecting excavating pit to mine approach road.
- 2.42 **"Approach Road"** shall mean Kuchha road, motorable road connected mines to nearest tar road for transportation of mineral Gypsum through trucks/ trollas/ tippers etc.
- 2.43 **"Final Certification relation to the work"** shall mean the certificate regarding the satisfactory compliance performance and fulfillment of all Contractual Obligations as issued by the Head of SBU &PC- Gypsum.
- 2.44 "Completion Certificate" shall mean the certificate to be issued by the Engineer-In-Charge when the work/s has been completed to his satisfaction as per terms of the contract.
- 2.45 Blood & Conjugal relative shall mean here father, mother, brothers, sisters' children and similar relations relating to spouses.

### 2.1 INTERPRETATIONS:

- 2.2.1 Whenever it is mentioned that the Contractor shall do or perform or cause to be done certain work/s or provide certain facilities or discharge certain obligation/s or make certain provision/s etc. it is expressly agreed and understood that each and every such work/s, facility, obligation/s or provisions etc. shall be made and/or provided by the contractor and liability thereof would be discharged to the satisfaction of the Company at the cost and consequences of the Contractor
- 2.2.2 Several clauses and documents forming the contract are to be taken as mutually explanatory. Should there be any discrepancy, inconsistency, error or omission in the contract or for any of the matter/s, the same shall be referred to in writing by the Contractor to the Head of SBU & PC Gypsum of the Company whose interpretation/s, decision in writing shall be conclusive, final and binding on the Contractor.
- 2.2.3 All headings and marginal notes to the various clauses of the contract are solely for the purpose of giving a concise indication and not a summary of the contents thereof, and

- they shall never be deemed to be part thereof or be used in the interpretation or construction thereof, or of the provisions of the contract.
- 2.2.4 In the contract, unless otherwise stated specifically, the singular shall include the plural and vice versa, wherever the context so requires, the words importing person/s shall include incorporated companies, registered association, body of individuals or partnership firm.
- 2.2.5 General conditions of contract shall be read in conjunction with the Special Conditions of Contract, Specification of work and any other documents forming part of this contract wherever the context so requires.
- 2.2.6 Notwithstanding the sub-division/s of the various clauses of the contract into the separate parts/sections, every part of such shall be deemed to be supplementary to and complementary of each and every other part and shall be read with and into the contract so far as it may be practicable to do so.
- 2.2.7 Where any portion of the General Conditions of the contract is repugnant to or at variance with any provisions of the Special Conditions of Contract, then, unless a different intention appears, the provisions of Special Conditions of the contract shall be deemed to over-ride the provision of the General Conditions of the Contract and shall to the extent of such repugnancy or variations, prevail.
- 2.2.8 The materials, designs and workmanship etc. shall mean the relevant Indian Standards and the job specifications contained herein and the Contractor shall, also satisfy codes referred to in the contract and the additional requirements, if any.
- 2.2.9 No Director or official or employee of the Company shall in any way be personally bound or liable for the acts or obligations of the Company under the contract or answerable for any default or omissions in the observance or performance of any of the acts, matters or things which are herein contained.
- 2.2.10 No verbal agreement or inference from conversation with any officer or employee of the Company before, during or after the execution of the contract shall in any way affect or modify the terms or obligations contained herein.
- 2.2.11 No amendments to the contract shall be valid unless specifically made as an amendment to the contract and signed by the authorized representative of the parties.
- 2.2.12 The meaning of word enclose/submit of any documents shall generally means to upload the attested scanned copy of the same on e-procurement site unless clearly specified to send original document in physical form.

### 2.2 DECLARATION BY THE CONTRACTOR

- 2.3.1 The Contractor do hereby confirm and declare that they have independently inspected Mines of the SBU Gypsum of RSMML and supply center of Department of Agriculture, Rajasthan, ascertained and obtained all relevant and necessary information, data, particulars, existing wage structure/categories, conditions of services of workmen and working conditions, facilities etc. existing industrial environment and other related aspects.
- 2.3.2 The Contractor has also assessed and satisfied himself as to the nature, condition, quantum, extent, scope and magnitude of the work, involved in the contract, working conditions of the area/s, availability of power supply, water supply, men and machinery requirement, availability of land etc. The Contractor do hereby agree and undertakes not to raise any dispute and/or objection at any stage on any ground whatsoever.

### Section-III

# **Instructions to the Tenderer**

### TENDERER TO OBTAIN THE INFORMATION HIS OWN:

### 3.1 Instructions to the Tenderer & General Conditions

- a) Tender is to be submitted online at <a href="https://eproc.rajasthan.gov.in">https://eproc.rajasthan.gov.in</a> in electronic form as prescribed in the tender form. Tender fees and processing fees will not be refunded in any case.
- b) The Bidder should go through the website <a href="https://eproc.rajasthan.gov.in">https://eproc.rajasthan.gov.in</a> and the link "help for contractors"," information about DSC', FAQs' and bidders manual kit" to know the process for submitting the electronic bids at website. The complete bid document has been published on the website <a href="https://eproc.rajasthan.gov.in">https://eproc.rajasthan.gov.in</a> for the purpose of downloading. The uploaded bid document shall be considered valid for participation in the bid process subject to submission of required cost of bid document and e-Tendering processing fee. A scanned copy of EMD declaration, e-Tendering processing fee and cost of bid document receipt must be uploaded along with the Technical Bid proposal failing which the bid will be summarily rejected.
- c) All communications/correspondences/documents including the bid document should be physically signed, stamped on each page before uploading and also signed digitally by the designated authorized representative of the bidder.
- d) The DD towards the cost of tender document fees, Earnest Money deposit and processing fees along with original affidavits as per annexure I, II & III of tender document should be kept in a sealed envelope addressed to Group General Manager (Contract), RSMML, Corporate Office, Udaipur. This envelope should be marked with NIT number & work, name and address of contractor, telephone number etc is to be written on the top of envelope for clarity. This envelope should be submitted in the office of the Group General Manager (Contract), RSMML, Corporate Office, Udaipur on or before the scheduled submission date and time as mentioned in the Notice Inviting Tender. The Company shall not be responsible for any postal delay. In case of non-receipt of same the offer of the tenderer shall be rejected.
- e) The tenderer while offering his tender, shall for all purposes, whatsoever, be deemed to have himself independently obtained all relevant and necessary information for preparing his tender. The correctness or completeness of the details, given in the tender document is not guaranteed. The details given in the tender document are basically for reference & guidance of the tenderer. The tenderer is required to satisfy himself in all respect, before the submission of offer.
- f) The tenderer shall be deemed to have examined the tender document, to have obtained his own information in all matters whatsoever that might affect directly or indirectly the carrying out the works at the contract rates and to have satisfied himself to the sufficiency of his tender. Any error in description or omission in the document shall not vitiate the tender or release the tenderer from his obligations. The tenderer is deemed to know and understood the scope, nature and magnitude of the works and requirement of materials, equipment, tools and labour involved and as to what all works he has to complete in accordance with these documents irrespective of any defect, omission or errors that may be found in the documents.
- g) The tenderer, at the his own responsibility and cost, is encouraged to visit and examine the Site of Works and its surroundings and obtain all information that may be necessary for preparing the offer and entering into a contract with company, in case he is awarded the work. He shall be deemed to have visited site and surroundings, to have

satisfied himself to the locations working & climatic conditions at the site, availability of water, electric power, labour etc. transportation facilities, probable sites for labour accommodation and store god owns etc and all other factors involved in the proper execution of works. The unit Incharge of work site may be contacted to familiarize with the work including visit to work site.

- h) The tenderer, if awarded the work, shall not be eligible for raising any dispute or claims, in case he is hindered in execution of work due to his negligence/omission/error in not collecting the details required for execution of work.
- i) All the provisions of Rajasthan Transparency in Public Procurement Act and rules made there under and modification to be issued by the competent authority from time to time will automatically be ipso-facto applicable

### 3.2 Tender Procedure

- a) e-Tender portal <a href="https://eproc.rajasthan.gov.in">https://eproc.rajasthan.gov.in</a> shall be used for all procedure related to the bidding.
- b) The prospective Bidders should register themselves in the e-Tender Portal and submit the Bids electronically through the e-Tender portal.
- c) The Bidders are requested to download the e-Tender help manual and user manuals from the Portal for reference.
- d) It is mandatory for the Bidders to possess a valid Digital Signature Certificate to complete the e- Tender Bid process as per the provisions of Government of India IT Act
- e) The Technical Bid form and Price Bid form will be available in prescribed format for downloading. The registered Bidders can log into the e-Tender system and download the Bid Forms.
- f) The Bid forms should be filled and submitted using the Digital Signature Certificates. The supporting documents as required in support of tender should be scanned and uploaded in the e-Tender system.
- g) The Bid Form should not be changed or altered or tampered by the bidder. If the Bid form found tampered, the Bids will be summarily rejected.

### 3.3 Tender Document Fee

The Tender document fee as mentioned in the NIT shall be paid by way of DD in favor of RSMM Ltd. payable at Udaipur.

### 3.4 e-tendering processing charges

- a) For each and every Bid submitted, a non-refundable Processing charge Rs. 2500/-should be paid by way of Demand Draft or Banker's Cheque drawn in favour of "MD RISL" payable at JAIPUR.
- b) The payment particulars should be entered in the e-Tender Portal by the bidder while bidding.
- c) At the time of the Technical Bid opening, the payment committed in the Bid should be factual and should match the physically submitted payments.
- d factual and should match the physically submitted payments.

  Even though the payment particulars are entered in the e-Tender portal, if the Bidder fails to submit the physical instrument prior to the submission of Part-I of tender, their bid is liable for rejection. ### GENERAL INSTRUCTIONS FOR FILLING THE TENDER:

- 3.6 The tender document shall be digitally signed by the tenderer or by a person holding power of attorney authorizing him/her to sign on behalf of tenderer before submission of the tender. All scan papers to be uploaded should also bear the stamp of the tenderer.
- 3.7 Tenderer, in their own interest are advised to read the tender document completely and carefully, to avoid submission of incomplete bid. Tender in which any of the particulars and prescribed information is mission or incomplete in any respect and/or prescribed conditions are not fulfilled are liable for rejection, at the sole discretion of the Company.
- 3.8 The Company takes no responsibility for delay, loss or non-receipt of tender fees and other document sent through Post/Courier service.

### CLARIFICATIONS OF CONTENTS OF TENDER DOCUMENT:

- 3.9 In case an intending tenderer require any clarification in connection with, or any point covered by, the tender documents, or as to any matter or work to be done or not be done by him in the event the contract for the work is awarded to him, he must submit a request for such clarification in writing so as to reach the Company at least 15 days in advance of the last date fixed for submission of tender. Copies of any such clarifications furnished by the Company will be supplied to all other intending tenderer and such clarification will constitute addenda/corrigenda to, and be read as part of the tender document.
- 3.10 The Company will not be bound by any verbal/ oral clarification or interpretation of the tender document or of any matter(s) connected with works to be executed in accordance with the tender documents, which may be made by any of its employee, representatives or agent.
- 3.11 Any neglect or failure on the part of the tenderer in obtaining necessary and reliable information upon the foregoing or any other affecting the contract shall not relieve him from any risks or liabilities or the responsibility from completion of the works at the scheduled rate/s & time and in strict accordance with the contract document/s.

### ADDENDA/ CORRIGENDA:

- 3.12 Addenda/Corrigenda to Notice Inviting Tender or to this tender document before expiry of the due date of submission of tender may be issued to clarify documents or to reflect modification in the specifications or terms & conditions or Scope of work or for any other reasons by the company.
- 3.13 Addenda/corrigenda to these tender documents, if issued by the company, shall form an integral part of this tender document.

### **CURRENCIES OF THE BID AND PAYMENT:**

3.14 The tenderer shall quote the unit rates and prices entirely in Indian Rupees.

### 3.15 TECHNO COMMERCIAL OFFER:-

The Technical Bid Form will be in online format. The tenderer should download Technical Bid Form, filled and signed using the Digital Signature Certificate (DSC). The Technical Bid Form should not be changed or altered or tampered. If the Bid form is tampered, the Bids will be summarily rejected. The Technical Bid Form should not contain any Price indications strictly, otherwise the Bids will be summarily rejected. Scanned copy of following document should be uploaded alongwith Part I of the offer: -

- a) Power of Attorney in favour of the authorized representative signing the tender, as required.
- b) Attested Certificate of Incorporation/ registration of the contractor duly certified by the Notary Public /Gazette Officer as the case may be.
- c) Scan copy of PAN (Income Tax) Number and GST Number.
- d) Attested copy of the Audited/ CA certified Balance Sheets for the financial years prescribed in the tender conditions in support of the turnover.
- e) "Exceptions & deviations statement" to be submitted by the tenderer.
- f) An undertaking on Non-Judicial Stamp Paper that "We (name of tenderer including their all partners/directors/members of the society) are neither customer of RSMML for Gypsum nor handling/liaison/transportation agents of RSMML'S customers of Gypsum. Further we shall not become handling/liaison/transportation agents of any customers of RSMML of Gypsum during currency of the contract in case the work is awarded to us" has to be submitted necessarily alongwith the Techno-commercial offer as per annexure-V.
- g) Tenderer should submit an undertaking on non-judicial stamp paper for formation of a co-operative Society as per annexure-I of tender (from proprietor/all partners/all directors as the case may be).
- h) Undertaking/affidavit as per annexure I ,II & III given in of tender document, duly signed forms1,2,3 of tender
- 3.22 A tenderer shall be fully responsible for consequences including rejection of his tender or cancellation of the contract if the required attested documents / attested copies of documents are not uploaded along with the techno-commercial bid or any information/ document is found to be false/ fabricated/ misleading.
- 3.23 The company reserves its right to call for any addition information for reference as it may deem fit, so to evaluate the technical capability of the tenderer.
- 3.24 It is to be noted that tender will be qualified on the basis of documents submitted alongwith the offer. The disqualification due to non submission of the requisite documents / duly attested / non legible documents alongwith the offer will be the sole responsibility of the tenderer.

# 3.25 PART-II 'PRICE BID (BOQ):

The 'Price Bid' shall be submitted online in the prescribed format only. The tenderer is to quote the rate only in relevant part of price bid for tendered work in the prescribed price format in BOQ as provided in the tender document otherwise their price bid may not be considered for award of the contract in spite of opening of the price bid or lowest offered rate. It is suggested to the tenderer to read carefully the instructions mentioned in the Proforma. Bidders are advised to downloaded the prescribed BOQ file available on the <a href="https://eproc.rajasthan.gov">https://eproc.rajasthan.gov</a> & fill the rates as instructed. In case the bid in any other format was uploaded by the bidder or BOQ format found tempered or modified the same is liable to be rejected and will not be considered for evaluation.

- ii) The rates are to be quoted in Rupees and in the prescribed price bid Proforma available online
- iii) While quoting the price under this part, the tenderer is deemed to have confirmed that the price quoted are for the total scope of work as described in the tender document and as required to be executed for site requirement.

### **DEADLINE FOR SUBMISSION OF BIDS:**

- 3.26 The Bids will be received up to the specified time only.
- 3.27 The Company may extend the deadline for submission of Bids by issuing an amendment in accordance with Clause mentioned elsewhere in the tender document, in which case all rights and obligations of the Company and of the Tenderer, which were previously subjected to the original deadline will then be subjected to the new deadline.

### **LATE BID:**

3.28 Any Bid after the deadline prescribed in NIT due to any reason whatsoever will not be accepted

### **OPENING OF THE TENDER:**

- 3.29 The Part-I Techno Commercial Bid of the offer will be opened as per the date & time mentioned in NIT.
- 3.30 If the date fixed for opening of tenders happens to be a holiday for any reason, the tenders will be opened on the next working day at the same time.

### **EXCECPTIONS AND DEVIATION:**

3.31 Tenderer are advised to submit quotations based on the terms and conditions and specifications contained in the tender document and not to stipulate any deviations. Bids containing stipulations of deviation to the terms and conditions are liable to be ignored. In case it is absolutely unavoidable to deviate from tender conditions then the tenderer should mention the deviations at their risk of rejection only in 'Form-4'. Deviations mentioned anywhere else in the bid shall be ignored without any consequences.

### **EARNEST MONEY (EMD):**

3.32 The tender must pay Earnest Money **as detailed out in NIT** in the form of crossed demand draft(validity of three months) in favour of the Company and drawn on any Nationalized /Scheduled bank at Udaipur and attach the same in original with the technical bid of the tenderer, failing which the bid is liable to be rejected. No interest shall be paid by the company on the earnest money so deposited by the tenderer. The earnest money of the tenders whose bid is not found to be acceptable on the basis of pre-qualifying criteria and/or on evaluation of their techno-commercial bids (or **disqualified bidder**) will be refunded at the earliest. The earnest money of the tenderer who are technically successful but not awarded the work shall be refunded after the acceptance of LOA/DLOA to the successful tenderer. The earnest money deposited by the successful tenderer will be refunded after acceptance of SD, if it is in the form of Bank Guarantee. If EMD is in the form of cash, then it will be appropriated towards a part of the Security deposit, but shall stand forfeited if the tenderer fails to furnish security deposit as per clause.

- 3.33 The earnest money of a tenderer shall be forfeited in the following cases:
  - i. If the tenderer withdraws or modifies the offer after submission of the tender.
  - ii. If the tenderer does not submit the prescribed Bank Guarantee or Demand Draft as security deposit within 21 days of the date of work order/LOA issued in favour of tenderer.
  - iii. If the tenderer does not execute the agreement, in the prescribed form within one month of the date of work order/LOA issued in favour of tenderer.
  - iv. If it is established that the tenderer has submitted any wrong information/ forged documents/non commencement along with the tender or thereafter.
  - v. If tenderer doesn't form the society before commencement of work.

### **VALIDITY:**

3.33 Tender submitted by tenderer shall remain valid for acceptance for a period **120** (**One Hundred twenty**) days from the date of opening of the tender (Part I of the offer). An offer with a validity period of less than 120 (One Hundred twenty) days is liable to be rejected.

The tenderer on its own shall during the period of 120 **days** or in extended period cancel and/or withdraw his tender nor shall he make any variation therein. In case of tenderer revoking, canceling, modifying and/or withdrawing his bid during the validity of bid, the earnest money deposited by him along with tender shall stand forfeited and tender will not be considered for further evaluation.

In exceptional circumstances, prior to expiry of the original time limit, the Company may request the tenderer to extent period of validity for a specified additional period. The request and the tenderer's responses shall be made in writing. A tenderer if agreeing to the request will not be required or permitted to modify his bid.

### **EXAMINATION OF BIDS & DETERMINATION OF RESPONSIVENESS:**

- 3.34 Prior to the detailed evaluation of Bids, the Company will determine whether each Bid:
  - i) Meets the eligibility criteria
  - ii) Is accompanied by the required securities; and
  - iii) Is substantially responsive to the requirement of the Bidding documents.
- 3.35 A substantially responsive Bid is one, which confirms to all the terms, condition, and specification of the Biding documents without material deviation or reservations. A material deviation or reservation is one:
  - i) Which affects in any substantial way the scope, quality, or performance of the work; and/or
  - ii) Which limits in any substantial way, inconsistent with the Bidding documents, the Company's right or the Bidder's obligation under the contract; and/or
  - iii) Whose rectification/acceptance would affect unfairly the competitive position of the other Bidders presenting substantially responsive Bids?

### **EVALUATION OF TECHNO-COMMERCIAL BID:**

3.36 The techno-commercial bids of substantially responsive tenderer's will be evaluated from all aspects. The RSMML reserves the right to assess the capability and competency of the tenderer based upon the information provided by the tenderer in the techno-commercial bid and the information that may otherwise be available to and/or gathered by the RSMML. The decision of the RSMML as to which tenderer is capable & competent to carry out the work shall be final. The tenderer should, therefore, see

- that he has required level of technical, financial & managerial competence & experience before submitting the tender.
- 3.37 If a Bid is not substantially responsive, it may be rejected by the Company at its sole discretion.
- 3.38 The tenderer shall be prepared to furnish clarification/information and attend meetings/ discussion as required by the company from time to time.

# CRITERIA FOR EVALUTION OF REASONABILITY/ WORKABILITY OF OFFERED RATE BY THE TENDERER:

3.39 Further, in case it is found that any bidder has quoted abnormally low rates & attempting to vitiate the tendering process then the company reserves its right to forfeit the EMD & debar such bidder for participating in future tenders of the company at its sole discretion.

### **CORRECTION OF ERRORS IN PRICE BID:**

- 3.40 Price Bid (Part-II) of substantially responsive will be checked by the Company for any arithmetical errors. Errors will be corrected by the Company as follows:
  - a) Where there is discrepancy between the amounts in figures and in words, the lower of the two would be taken; and
  - b) Where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern; and
  - c) Discrepancy in totaling or carry forward in the amount quoted by the contractor shall be corrected. The tendered sum so corrected and altered shall be substituted for the sum originally tendered and considered for acceptance instead of original sum quoted by the tenderer.
- 3.41 The amount stated in the Bid will be adjusted by the Company in accordance with the above procedure for the correction of errors and, shall be considered as binding upon the Bidder.
- 3.42 Price Bid (part-II) of techno-commercially acceptable tenders shall only be opened. Only such short-listed tenders will be informed about the date and time of opening of the price bids.

### PROCESS TO BE CONFIDENTIAL:

- 3.43 Information, relating to the examination, clarification, evaluation and comparison of Bids and recommendations for the award of a contract shall not be disclosed to the Bidders or any other person not officially concerned with such process. Any efforts by a Bidder to influence the Company's processing of Bids or award decision may result in rejection of his bid.
- 3.44 The tenderer may note that indulgence in submitting unsolicited offers or submitting unsolicited correspondence after submission of bid is liable to debar him from participating in RSMML tenders.

### NOTIFICATION OF AWARD AND SIGNING OF AGREEMENT:

- 3.45 The tenderer, whose Bid has been accepted, will be notified of the award by the Company, through postal communication or through facsimile confirmed by registered letter/speed post. This letter (hereinafter and in Conditions of Contract called the "Letter of Acceptance" will state the sum unit that the Company will pay to the Contractor in consideration of the execution and completion of the Works by the Contractor as prescribed in the Contract.
- 3.46 The notification of award will constitute the formation of Contract. The execution of agreement as per clauses below would be the formalization of agreement that was commenced with the issuance of LOA.

### SIGNING OF THE CONTRACT AGREEMENT:

- 3.47 The successful tenderer shall be required to execute an agreement on non-judicial stamp paper; of appropriate value under Indian Stamp Act with the company within 30 days from the date of intimation regarding acceptance of tender. LOA etc. The cost of execution of agreement including non-judicial stamp paper shall be borne by the contractor.
- 3.48 The contract agreement shall consist of
  - a) An agreement on non-judicial stamp paper of appropriate value.
  - b) Tender document, along with the addend/corrigenda, if any.
  - c) Telex/Letter of Intent & Detailed Letter of Intent/Work order.
  - d) Agreed Variation, if any,
  - e) Any other document as mutually agreed

### 3.49 INTERFERENCE WITH PROCUREMENT PROCESS

In case the bidder

- a) Withdraws from the procurement process after opening of financial bids.
- b) Withdraws from the procurement process after being declared the successful bidder
- c) Fails to enter procurement contract after being declared the successful bidder.
- d) Fails to provide performance security or any other document or security required in terms of the bidder documents after being declared the successful bidder, without valid ground,

Shall, in addition to the recourse available in the bidding documents or the contract be punished with fine under RTPP Act which may extend to fifty lakh rupees or ten percent of the assessed value of contract, whichever is less.

### **RIGHTS OF COMPAY:**

- 3.50 The Company reserves the right
  - i) to reject any or all the tenders, in part or in full, without assigning any reason, there to,
  - ii) not to accept the lowest tender or assign reasons for not accepting the lowest tender,
  - iii) To increase/ decrease the quantity and period of contract, without any additional obligation on it,
  - iv) not to carry out any part of work,
  - v) to reject the offer, if is established that the tenderer has submitted any wrong/misleading information or forged documents along with offer or thereafter.

The company may exercise any of the above right at any time prior to the award of contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the RSMML's action.

### **REFUSAL / FAILURE:**

3.51 In the event the Tenderer, after the issue of communication of Acceptance of Tender by the Company (LOI), fails/ refuses to accept the award and/ or commence execution of the work as herein before, the tenderer shall be deemed to have abandoned the contract and such an act shall amount to and be construed as the Contractor's calculated and willful breach of contract, and in such an event the Company shall have full right to claim damages/compensation thereof in addition to the forfeiture of Earnest Money/Security Deposit deposited.

### **SECTION-IV**

# GENERAL CONDITIONS OF CONTRACT (GCC)

### INTERPRETATION OF CONTRACT DOCUMENT:

- 4.01 Except if and to the extent otherwise provided by the contract, the provisions of the general conditions of the contract and special conditions of the contract shall prevail over those of any other documents forming part of the contract.
- 4.02 Several documents forming the contract are to be taken as mutually explanatory. Should there be any discrepancy, inconsistency, error or omission in the contract or any of the matter may be referred to the Engineer-In charge whose decision shall be final and binding.
- 4.03 In case of any inconsistency or contradiction between the provisions of General Conditions of Contract and Special Conditions of Contract, the Special Conditions of Contract shall prevail unless and until provided otherwise.

### **SECURITY DEPOSIT (SD):**

- 4.04 The successful tenderer shall furnish a Security Deposit equivalent to 10% of the contract value as work out by the awarded contract rate. The total contract value will be calculated on the basis of contract rate of remuneration payable to the contractor & tendered quantity for the total period of the contractor.
- 4.05 The successful tenderer shall furnish a security deposit as above through Demand Draft /Banker's Cheque /Bank Guarantee in favour of RSMML, Bikaner within 21 (Twenty-One) days of the issuance of such communication of acceptance of tender/letter of acceptance for due fulfillment of all or any of the terms & conditions of the contract. The Bank Guarantee shall be provided only in our approved format on non-judicial stamp paper on appropriate value under Indian/Rajasthan Stamp Act prevailing on the date of issuance of BG. from a public sector (except SBI)/AXIS/ICICI/HDFC bank having its branch at Bikaner. No amendment in this format shall be acceptable to the company. The Bank Guarantee shall be valid for the entire contract and / or extended period, if any, plus a grace period of six months. The Company shall entitle to encash the same and appropriate the whole of the amount or part thereof against its claims / dues or sums payable as contained herein.
- 4.06 The tenderer may also opt to furnish Bank Guarantee (B.G.) as above/ DD/Banker's cheque amounting to 5% of the value of contract within 30 days of the issuance of DLOA. The BG shall be valid for total contract period plus grace period of 6(six) months beyond the Contract period. In such option, balance security deposit of 5% of contract value will be deducted from the running bills of the contractor during the contractual period in 12 installments.
- 4.07 Fixed Deposit Receipt (FDR) equivalent to 10% of Total contract value issued from any Public sector bank (except SBI)/ICICI/ Axis /HDFC Bank having its Branch office at Bikaner. FDR shall be in the name of RSMML on account of Successful bidder and discharged by him in advance. The accepting authority shall ensure, before

accepting the Fixed Deposit Receipt, that the successful bidder furnishes an undertaking from the bank to make payment/premature payment of the Fixed Deposit Receipt on demand to the Company without requirement of consent of the contractor, in the event of forfeiture of the security deposit, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit without protesting by the contractor/him.

- 4.08 The entire Security Deposit shall be refunded after six months of the expiry of contract, provided always that the Contractor has been first paid all the bills including his final bill subject to deductions as are permissible under these terms and all other dues to the Company arising out of this contract. If any, have been fully met by the Contractor and the Contractor has rendered. "No claim and No dues Certificate" to the Company.
- 4.09 The Security Deposit shall be liable to be forfeited wholly or partly at the sole discretion of the Company, should the Contractor either fail to fulfill the contractual obligations or fail to settle in full, his dues to the Company, In case or premature termination of the contract due to defaulter of the contractor, the Security Deposit will be forfeited and the Company will be at liberty to recover the loss suffered by it from the Contractor.
- 4.10 The Company may deduct from the Security Deposit any sum due and any other sum that may be fixed up by the Company as being the amount of loss or losses or damages suffered by it due to delay in performance and/or non-performance and/or partial performance of any of the terms of the contract.
- 4.11 All compensation or other sums of money payable by the Contractor to the Company or recoveries to be made under the terms of this contract may be deducted from any sums which may be due to the Contractor from the company on any account and in the event of the such amount being insufficient the Contractor shall within ten days of such shortfall make good in cash, failing which the balance amount shall be recovered by way of invoking the bank guarantee furnished as security.
- 4.12 In the event of bank guarantee amount being insufficient, then the balance recoverable amount shall be deducted from any sum, then due or which at any time thereafter may become due to the Contractor. The Contractor shall pay to the company on demand any balance remaining due.
- 4.13 In case the Bank Guarantee is invoked for any reason/s, the Contractor is required to furnish a fresh Bank Guarantee in the same format for the same amount and for the same period as the original Bank Guarantee within a period of 21 (Twenty-One) days from the date of invoking of original Bank Guarantee.
- 4.14 In the event of security amount at any time during the currency of the contract falling short of the specified amount, the Contractor shall forth with make good the deficit on demand, so that the total amounts of Security Deposit will not at any time be less than the amount so specified. The Company may recover the same by way of additional deductions from bills.
- 4.15 No interest is payable on S.D. amount.

- 4.16 For execution of contract, it is required to form a Co-operative Society under Society Act for Part-A Job, & the bidder is to furnish security deposit for total Job for which it has given bid and shall be responsible for total execution of Job. The Security Deposit shall be liable to be forfeited wholly or partly at the sole discretion of the Company if the co-operative society is not formed & registered under Society Act.
- 4.17 In case of enhancement of quantum of work, due to any reason, the contractor shall furnish additional security amount. This security amount will be progressively recovered from the payment due to the contractor.

#### 4.18 ADDITIONAL PERFORMANCE SECURITY-

- 1. In addition to performance security as specified in rule 75 of RTPP act & rules, an additional performance security shall also be taken from the successful bidder in case of unbalanced bid. The additional performance security shall be equal to fifty percent of unbalanced bid amount. The additional performance security shall be deposited in lump sum by the successful bidder before execution of agreement. The additional performance security shall be deposited through e-Grass, demand draft ,bankers cheque , govt. security or bank guarantee. Explanation-

  - a. Unbalanced bid means any bid below more than fifteen percent of estimated bid value.
  - b. Estimated bid value means estimated value of the work as mentioned in bidding documents.
  - c. Unbalanced bid amount means positive differences of eighty five percent of estimated bid value minus bid amount quoted by the bidder.
- 2. The additional performance security shall be refunded to the contractor after satisfactory completion of the entire work. The additional performance security shall be forfeited by the procuring entity when work is not completed within stipulated period by the contractor.

# CONTRACTOR TO BE LIABLE FOR ALL PAYMENT TO HIS WORKERS/ **EMPLOYEES:**

4.19 The contractor shall be liable for payment of all wages and other benefits, such as leave with wages, contributory provident fund, bonus, free medical aid etc., to his employees and labour as per the statutory requirements as in force or, may be applicable from time to time during the currency of the contract.

The contractor shall bear all liabilities for employee and labour employed or retained by him as regards to their employment, litigation and any other action arising out of operation of this contract or at the termination/ completion of this contract.

The company shall not pay any additional amount on any such account. The only remuneration payable to the contractor by the company will be on the basis of accepted rates and work executed thereof.

#### **GOODS AND SERVICE TAX:** 4.20

The rate quoted by the bidder will be exclusive of Goods & Service Tax (GST). 4.21 However, the rates will be inclusive of any other levies and duties, as applicable on this contract (up to last date of submission of bid).

- 4.22 The rates quoted shall be on firm price basis during the pendency of the contract period and the contractor shall not be eligible for any escalation in rates on whatsoever ground.
- 4.23 The provision of GST should be followed by the Contractor as applicable and will be reimbursed on the submission of challan, failing which RSMML is free to deduct/recover/ retain such amount from the bills of contractor or any other amount due to him/ or from Security deposit, as the case may be.
- 4.24 Timely deposition of GST and filing of requisite tax returns of relevant tax period would be sole responsibility of the contractor. The contractor will also ensure that necessary credit on this account is available to RSMML in the next month. In case of any discrepancy where credit is not available to RSMML then company is free to deduct/recover/retain such amount from the bills of contractor or any other amount due to him/ or from Security deposit, as the case may be.
- 4.25 In case of reversal of Input Tax Credit (ITC) and imposition of penalty on account of payment of GST and default in filing of returns towards the payment for the work, contractor is liable to pay all such dues to the company, failing which RSMML is free to deduct/recover/ retain such amount from the bills of contractor or any other amount due to him/ or from Security deposit, as the case may be.
- 4.26 The contractor shall be responsible for the deposition of any and all contributions, duties, levies and taxes etc. with the concerned authorities of the Central or State Government authorities, applicable for execution of the works under the contract. All taxes/duties/levies as applicable should be taken into consideration while making the offer. Ignorance in it shall not qualify for any additional payment. RSMML will reimburse/recover at actual any taxes/duties which are imposed/increased /withdrawn /decreased after the date of submission of offer & are directly applicable to this contract & payable by the contractor/recovered by RSMM & determined on the basis of bills raised by him upon the company, if applicable, subject to the furnishing of documentary proof.

# WAIVER AND LIABILITY TO PAY COMPENSATION:

- 4.27 In any case in which any of the powers conferred upon the Company shall have become exercisable and the same have not been exercised, the non exercise thereof shall not constitute a waiver of any of the conditions hereof and such powers shall be exercisable in the event of any further case of default by the Contractor, the contractor shall be liable to pay compensation amount to the extent of the whole of his Security Deposit, Performance Guarantee etc. and the liability of the Contractor for past and future compensation shall remain unaffected.
- 4.28 In the event the Company exercising the powers vested in it under the aforesaid clause, it may, take possession of all of any tools and equipment, materials and stores lying in or upon the works or the site thereof belonging to the Contractor or procured by him and intended to be used for the execution of the work or any part thereof the same be taken by paying reasonable compensation as decided by Engineer-In-Charge, otherwise the Engineer-In-Charge may give notice to the Contractor, requiring him/ it to remove such tools, equipment, materials or stores from the premises (within a time to be specified in such notice), and in the event of the contractor failing to comply with such requisition the Engineer-In-Charge may remove them at the contractor's

expenses or sell them by auction and/or private sale on account of the contractor and at his / its risk in all respects without any future notice as to the date, time or place of sale and the certificate of the Engineer-In-Charge as to the expenses of any such removal and the amount of the proceeds and expenses of any such sale shall be final, conclusive and binding on the Contractor.

### COMPANY NOT LIABLE TO PAY COMPENSATION:

4.29 The Contractor shall have no claim against the Company for any business loss, idle charges, compensation upon failure, delay, omission etc. on the part of the Company to carry out any or all the provisions of the contract for any reason whatsoever. The Company's decision in the matter shall be final and binding on the Contractor.

### NO CLAIM IF WORK IS ABANDONES OR POSTPONED:

4.30 The Contractor have no claim, whatsoever against the Company if the work or any part thereof covered by the contract is postponed to any later date and/ or withdrawn in part in the overall interest of the Company or for security or for any other reason/s. The Company's decision in this regard shall be final and binding on the Contractor.

# NO COMPENSATION FOR ALTERATION IN OR RESTRICTION OF WORK:

4.31 If any time after the commencement of the work the company shall for any reason or under instructions of Directorate General of Mines Safety in case of mining contracts or any other statutory authority for mining and other contracts, whatsoever required not to do the whole work or part thereof as specified in the schedule of work to be carried out, the Engineer-In-Charge shall give notice in writing of the fact to the contract, who shall have no claim to any payment or compensation whatsoever on any account or profit or compensation or advantage/s which he might have derived from the execution of the work in full, but which he did not drive in consequences of the full amount of the work not having been carried out, nor shall have any claim or compensation by reason of any alternations having been made in the original specification, drawings, designs and instructions which shall involve any curtailment of the work as originally contemplated.

### **INSURANCE:**

- 4.32 Under the insurance scheme the contractor shall be required to get comprehensive insurance plan, Universal Health Insurance policy for all the persons and equipments engaged in work to meet the liability arising out of workman compensation Act. Copy of insurance policy must be submitted to RSMML for record. The management on this account shall reimburse no amount.
- 4.33 The material will be delivered at the destination/designated locations in each district under this tender in perfect condition. The material supplied under the Contract shall be fully insured against loss by theft, destruction or damage incidental to manufacture or acquisition, transportation, storage, fire, flood, under exposure to weather and delivery at the designated project locations, in accordance with the applicable terms. The insurance charges will be borne by the bidder. The Material will be delivered at the FOR destination in perfect condition.

### **DISCREPANCIES BETWEEN INSTRUCTIONS:**

4.34 Should any discrepancy occur between the various instructions furnished to the Contractor, his agents or staff or any doubt arising as to the meaning of any instructions or should there be any misunderstanding between the Contractor's staff, the Contractor shall refer the matter immediately in writing to the Engineer-in-Charge whose decision thereon shall be final and conclusive and no claim for losses alleged to have been caused by such discrepancies shall in any case be admissible.

### **CONTRACTORS OFFICE AT SITE:**

4.35 The Contractor shall provide and maintain an office at the site. Such office shall be opened during working hours/at all reasonable hours to receive instructions, notices and / or other communications etc. on its behalf from the Company.

### **SAFETY, SANITARY & MEDICAL FACILITIES:**

- 4.36 The Contractor and/or his sub-contractor and their employees, at Contractor's cost shall fully comply with the safety rules, regulations or statutory directions and provided sanitary and medical facilities, prescribed by law or as may from time to time be prescribed by the Engineer-in-Charge with the object of securing the safety and health of the employees and the local community. In case of violation or non-observance of any of the aforesaid provisions by the Contractor the same shall be enforced by the Engineer-in-Charge at the Contractor's expenses.
- 4.37 The Contractor shall be responsible for the safety and discipline of his employees in all face of the work and shall provide at his cost and enforce the use of safety belts, safety boots, guards, helmets, goggles and other safety devices etc that may be required by the Acts & Rules and regulations for the time being in force, or will come in force during the pendency of contract.
- 4.38 The Contractor shall promptly and immediately report serious accidents to any of his employees to the Engineer-In-Charge / Mines Manager and shall make at his cost immediate arrangements to render all possible medical and other assistance to such affected employees/persons.
- 4.39 All portions of the work shall be maintained in neat, clean and sanitary condition at all times. The Contractor shall provide toilets for the use of the employees at the work site at his cost.
- 4.40 First aid facilities and supplies as required by the rules for the time being in force or will come in force in near future shall be kept on the work site by the Contractor at his cost. The Contractor at his cost, as required under the rules, shall undertake medical check-ups of employees/ persons working with the contractor.

# **DAMAGE TO PROPERTY:**

4.41 The Contractor including his sub-contractor/s, if any, shall be responsible for making good at his cost to satisfaction of the Company any loss or any damage to building, structures, equipment, installations, properties etc. belonging to the company or being executed or procured or being procured by the Company or of other agencies within the premises of the Company, if such losses or damages is due to fault and/or negligence or willful acts, omission, and/or any other reason whatsoever of the Contractor and/or his sub-contractor/s, their employees, agents, representative etc.

### **POWER OF ENTRY:**

- 4.42 During execution of Contract, if in the opinion of Engineer-In charge, it is found that:
  - i. Contractor has failed to execute the Contract in conformity with contract document or
  - ii. Contractor has substantially suspended work or the works for a continuous period of 15 days without permission from the engineer In charge, or
  - iii. Contractor has failed to carry on and execute the works to the satisfaction of the Engineer In Charge, or
  - iv. Contractor has committed or suffered or permitted any other breach of any of the provisions of the contract on his part to be performed or
  - v. Contractor has abandoned the work; or
  - vi. Contractor during the continuance of the contract has becomes bankrupt, then in any of such events, the Company shall have the power to enter upon the works and take possession of the materials, spares, equipment, tools and stocks thereon, and to revoke the Contractor's permission to continue to execute work by his agents. The Company shall then be free to take appropriate action against the contractor as per provisions of contract.

### **COMPANY MAY DO PART OF WORK:**

4.43 Upon failure of the contractor which includes sub-contractor/s, if any, to comply with any instructions given in accordance with the provision of the contract, the Company retains the right instead of assuming charge of entire work, to place additional labour force, tools, equipment and materials etc. on such parts of the work, as the company may decide/ designate or also engage another Contractor to carry out the work at the risk and cost of the Contractor. In such cases, the Company shall deduct from the amount due or which otherwise might become due to the Contractor, the cost of such work and materials etc, plus 15% additional charges thereon to cover all departmental charges/ expenses and the Contractor shall be bound by such decision of the Company.

### POWER TO ORDER SUSPENSION OF WORK:

The Company may, from time to time, by direction in writing and without in any way 4.44 invalidating the contract, order the contractor to suspend the work or any part thereof at any time and for such times and for such reasons as he may consider necessary. After such directions to suspend the work, or any part thereof, has been given the Contractor shall not proceed with the work or part thereof directed to be suspended until he receives a written order from the Company to so proceed. In the event of suspension exceeding three days the Company may under the provision of the contract extend the time for completion of work or part thereof by such time as it may find reasonable. The decision of the Company in the matter shall be final and binding on the Contractor. The Contractor shall not be entitled for any extra payment in case of such suspension. The Contractor without prior knowledge and approval of the Company thereof shall not suspend the work of any other part. If the Contractor is compelled to suspend the work or any part thereof he should report to the Engineer-in-Charge, furnish the reasons, necessitating such granted to the contractor if he proposes to suspend the work or any part thereof, on his own. In case such suspension is necessitated for reasons beyond control and period of suspension becomes more than 3 months at a stretch then Company may consider making some adhoc/ advance payment against the work done. The quantum and mode of payment shall be mutually decided. It will be however, sole discretion of company & will not be available as right of the contractor.

### **CHANGE IN CONSTITUTION:**

4.45 The Contractor shall prior inform the Company before any change is made in the constitution of the Co-operative Society/Firm/ Company or induction or retirement of any of the partners/ directors at the earliest.

### **COMPLIANCE IN RESPECT OF VARIOUS ACTS:**

- 4.46 The contractor shall at his own cost, observe, perform and comply with the provisions of the Acts applicable during the execution of the Contract, and Rules/Bye-laws framed hereunder, which are amended time to time & updated as applicable to this work, including but not limiting to the following and shall maintain such registers and documents, as are required under the various statutes, for production of the same before the company and/or other statutory authorities prescribed in this behalf, as and when required. Non-compliance of the provisions/ stipulations of those Acts and rules made there under including the following will render the Contractor liable to payment of necessary compensation/penalty, as deemed fit by the Company.
  - i) The Contract Labour (Abolition & Regulations) Act, 1970
  - ii) The Payment of Wages Act, 1936
  - iii) The Mines Act, 1952
  - iv) The Payment of Workmen's Compensation Act, 1923
  - v) The Minimum Wages Act, 1948
  - vi) The Forest Conservation Act, 1980
  - vii) The Air (Prevention and control of Pollution) Act.1981 & Water (Prevention and Control of Pollution) Pollution Act 1974.
  - viii) The Mines Rules, 1955
  - ix) The Metalliferous Mines Regulations, 1961
  - x) The Mines Vocational Training Rules, 1966
  - xi) The Mines & Minerals (Regulation & Development) Act, 2015
  - xii) The Rajasthan Minor Mineral Concession Rules, 2017
  - xiii) The Mineral Conservation & Development Rules, 1988
  - xiv) The Fatal Accident Act, 1985
  - xv) The Motor Vehicles Act, 1939
  - xvi) The Industrial Dispute Act, 1947
  - xvii) The Standing Orders Act, 1946
  - xviii) Rajasthan Society Act
  - xix) Rajasthan Transparency in public procurement Act 201 & Rules 2013
- 4.47 It will be the sole responsibility of the Contractor to ensure all sorts of payments to his workers and submission of returns in time, as required by various Statutory Authorities concerned. In case of default by the Contractor in making statutory payments in time, the Company reserves the right to deduct necessary amount from the Contractor's bills towards such payments without prejudice to the rights & remedies of the Company.
- 4.48 The Contractor should obtain all requisite licenses as early as possible on award of work and preferably prior to commencement of work so to avoid any breach of law.

- 4.49 All persons other than his regular employees engaged by the Contractor in connection with the performance of the contract shall be deemed as his employees for purposes of payment/remuneration employees and no claim shall lie against the company in respect of delay, deduction and non-payment of wages and /or remuneration/compensation by the Contractor to them.
- 4.50 The Contractor shall take all necessary steps and precautions to ensure that his workers and employees (including deemed employees) engaged for the work under the terms of the contract shall work within the mines in accordance with the provisions of the Mines Act, 1952 and Rules and Regulations framed there under and shall also maintain necessary records and registers as required under these provisions and shall be responsible to the Engineer-in-Charge in this regard. The Contractor shall perform the work under this contract in accordance with all-applicable codes, statutory regulations and engineering/ mining practice. The Contractor shall be required to ensure vocational training to his workmen before they are put to work as required under Mines Vocational Training Rules, 1966.

### **COMPENSATION AND LIABILITY:**

- 4.51 The contractor at his cost shall affect insurance for all the contractor's employees and persons engaged in the performance of the contract. If any of the work is sublet the contractor shall require the sub-contractor to provide for workman's compensation and employer's liability insurance for the latter's employees if such employees are not covered under the Contractor's insurance.
- 4.52 In case of an accident in respect of which Workman's Compensation Act or Motor Vehicles Act, Fatal Accident Act or Mines Act etc. applies it shall be lawful for the Engineer-in-Charge to retain money out of due and payable amount to the contractor, such sum or sums of money as may in the opinion of the Engineer-in-Charge shall be final in regard to all such matters arising under this clause and the Contractor shall be bound by such decision of the Engineer-in-Charge.
- 4.53 The Company shall not be liable for or in respect of any damages or compensation payable as per law in respect of or in consequence of any accident or injury to any workman or other person in the employment of the contractor or any of his subcontractor or third party etc. and the Contractor shall indemnify and keep indemnified the Company against all such injury, damages and compensation and against all claims, demands, proceedings, costs, charges and expenses, whatsoever in respect of or in relation thereto.

### LIABILITY FOR ACCIDENT TO PERSONS:

4.54 Besides the liabilities of the Contractor under the "Workmen's Compensation Act", Fatal Accident Act, M.V. Act, and "Mines Act", the following shall also apply to the Contractor. On the occurrence of any accident resulting in death or bodily injury to a workman employed/engaged by the contractor, the Contractor shall promptly and immediately intimate happening of such accident/s in writing to the Engineer-in-Charge the fact of such accident, besides taking immediate remedial measures. The Contractor shall indemnify the Company, against all claims/ compensation, loss or damage sustained by the Company resulting directly or indirectly from his failure to give intimation in the matter aforesaid, including the penalties or fines, if any, payable by the company as consequences of workmen's Compensation Act, Fatal Accident Act, Motor Vehicle Act, Mines Act or otherwise to conform to the provisions of the said Act/s in regard to such accident.

### **FORCE MAJEURE:**

4.55 Neither the Contractor nor the company shall be considered to be in default in the performance of their respective obligations under this contractor if such performance is prevented or delayed because of the conditions constituting force Majeure which shall include but not limited to notice/s from the Directorate of Mines Safety, other Statutory Authority, Civil Commotion, Fire accidents, epidemics, war, acts of God or because of any law, order, proclamation or ordinance of any Government or any authority thereof or forced stoppage of mining, loading operations, accumulation of stock of mineral, non-availability of mineral at mines and other places due to reasons like sand dune/ storms/ other causes and for failure of transportation or for any other cause beyond reasonable control of the party affected, provided notice of such cause is given in writing by the party affected within 14 days of the happening of the event. In case it is not possible to serve the said notice within the said period of 14 days then within the shortest possible period. Power cuts/ partial power failure/interruption shall not be construed as force Majeure for this purpose and the same shall not affect in any way the performance of the Contract. As soon as the cause of force Majeure has been removed, the party whose ability to perform its obligation has been affected shall notify the other of such cessation. Should one or both the parties be prevented from fulfilling their contractual obligations by state of force Majeure lasting for a continuous period of three months both the parties shall consult each other and decide about the future course of action regarding the contract.

### SERVICE OF NOTICE ON CONTRACTOR:

4.56 Any notice hereunder may be served on the Contractor or his/its duty authorized representative at the work site or may be served by registered main directly to the address furnished by the Contractor. Proof of issue of any such notices shall be conclusive of the fact that the Contractor having been duly informed of all contents therein. The contractor shall furnish to the Company, the name, designation and addresses of his/its authorized agent at the work site as well as Bikaner.

# SERVICE OF NOTICE AND COMMUNICATION WITH THE COMPANY AND THE ENGINEER-IN-CHARGE:

- 4.57 Notice and communication addressed to the Company or the Engineer-in-Charge, as the case may be, shall be deemed to have been duly delivered.
  - (a) In the case of the Company, if dispatched by registered AD/Speed post to the Company's Head & In Charge (Gypsum) at Bikaner and copy to authorized representative.
  - (b) In the case of the Engineer-in-Charge, if dispatched or left at or posted to the address of his/its authorized representative, in the case of posting on the day on which they would have reached such address in the ordinary course of business, and in other cases on the day on which they were delivered to or left at such address.
- 4.58 Notice and communication addressed to the Company shall be valid only if duly signed by the Contractor or his duly authorized partner or his principal officer acting for him on his behalf.

### **TERMINATION:**

4.59 If the Contractor fails to execute the work or any part thereof with such diligence as will ensure its completion within the time specified in the contract, or extension thereof, or fails to complete the said work within such time or fails to perform any of

- his obligations under the contract or in any manner commits a breach of any of the provisions of the contract, it shall be open to the Company in its option, by written notice to the contractor: -
- (a) To determine the contract; in which event the contract shall stand terminated and shall cease to be in force and effect on and from the date notified by the company in this behalf, whereupon the contractor shall stop forthwith all or any of the contract work, then in progress and the Company may on its part, may take over the work remaining incomplete by the Contractor and the contractor and his sureties if any, shall be liable to the company for any excess cost occasioned by such take over and completion by the Company or by appointing any other agency over and above the rates of remuneration payable under the contract.
- (b) Without determining the contract, to take over the work of the Contractor or any part thereof and complete the same through any other agency at the risk and cost of the contractor and the contract, and his sureties shall be liable to the company for any excess cost/ additional cost occasioned by such work having been so taken over and completed by the Company and/or through any other agency over and above the remuneration payable under the contract.
- 4.60 Before determining the contract, as aforesaid, and provided that, in the judgment of the company, the default or defaults committed by the contractor is or are curable or may be cured by the Contractor if any opportunity is given to him to do so, the Company may, by notice, in writing, call upon the Contractor to cure the default within such time as may be specified in the notice.
- 4.61 In the event of the Company proceeding in the manner herein above prescribed-
  - (a) The whole of the Security Deposit and Performance Guarantee furnished by the Contractor or retained by the Company shall be liable to be forfeited, without prejudice to the right of the Company to recover from the Contractor, the excess cost referred to aforesaid. The Company shall also have the right to take possession of the sites for completing the work or any part thereof, with any or all such materials, equipments, machinery tools and tackles belonging to the contractor, as may be deployed / used for the work.
  - (b) The money that may have become due to the Contractor on account of work executed by him/its already shall not be payable to him/its until after the expiry of six calendar months reckoned from the date of determination of contract or from the taking over of the work or part thereof by the company as the case may be, during which period the responsibility for fully workmanship in respect of such work shall, under the contract rest exclusively with the Contractor and shall be subject to deduction of all amounts due from the Company to the Contractor, whether under the terms of the contract or otherwise, authorized or required to be recovered or retained by the Company.
- 4.62 The Company shall also have the right to proceed in the manner prescribed in subclauses above, in the event of the contractor abandoning the execution of the contract work for a continuous period of one month, or becoming bankrupt or insolvent, or compounding with his creditors or assignees the contract in favour of his creditors or any other person or persons, or being a firm or a corporation goes, into voluntary liquidation, provided that in the said event, it shall not be necessary for the Company to give any prior notice to the Contractor.
- 4.63 Termination of the contract as aforesaid shall not prejudice or affect the rights of the Company which may have accrued upto the date of such termination.

### **DISPUTE, JURISDICTION:**

- 4.64 The place of the contract shall be Bikaner (Rajasthan). In cases of any differences, the same shall be resolved by mutual discussions and agreement. However, the decision of the company shall be final and binding.
- 4.65 No courts other than the courts located at Bikaner- Rajasthan shall have jurisdiction over any matter concerning any aspect of the work under this tender.
- 4.66 The contractor shall not stop or abandon the work due to and during the pendency of such disputes or differences.

### **APPEALS:**

4.67 Subject to section 40, of Rajasthan Transparency in Public procurement Rules 2013, if any bidder or prospective bidder is aggrieved that any decision, action or omission of the procuring entity is in contravention to the provision of this act or the rules or guidelines issued there under, he may file an appeal to designated First and Second Appellate Authority with in a period of ten days from the date of such decision or action, omission as the case may be clearly giving the specific ground on which he feel aggrieved on the form no. 1 (see rule 83) –Memorandum of Appeal under the Rajasthan Transparency in public procurement Act -2013 with prescribed fees.

# Chapter 2 TECHNICAL

  - b) List of equipment/machinery etc. along with its technical specification/ Purchase Invoices/ Registration Certificates & comprehensive insurance policy.

# MAINTENANCE & SUBMISSION OF RECORDS, REPORTS & REGISTERS:

- 5.4. The contractor shall have to ensure that its supervisory members maintains all records, registers, details etc., as required by the Company and/ or under the various Acts, Enactments, Statutes, Rules, Regulations, etc., as applicable to this contract and make available the same to the Company and/ or its authorized representative at such place & time as may be directed.
- 5.5. The contractor shall submit daily progress reports in the format as approved by the Engineer Incharge/ concerned Mines Manager alongwith computerized weighment slips of the Powder Gypsum/screened ROM Gypsum produced.
- 5.6. Authorized representative of the company shall have full authority to inspect such records at any time during the contract period.

# LIABILITIES IN RESPECT OF CONTACTOR'S MACHINERY ETC.: 5.7. FIRE EXTINGUISHERS:

Equipment deployed for the contractual work shall be fitted with automatic fire extinguisher/s include refilling if any, of a type approved by the DGMS. The company may not allow deployment of any equipment not fitted with such an automatic fire extinguisher in proper working order. The contractor shall take all reasonable precautions to prevent fires of any nature in general & particular in vicinity of his operations shall be responsible for all damages from fires directly or indirectly due to his own activities or to those of his employee or to the activities of its agents or its employees.

### 5.8. **DUST SUPPRESSION:**

The contractor shall have to take effective measures at its own cost and expenses for suppression of dust generated during the process of excavation, grinding, transportation & loading into trucks etc. in the working areas by means of water sprinkling, or any other suitable method, etc. so that the dust concentration in such places do not exceed the limits prescribed under the MMR, 1961/Air (Prevention & Control of Pollution) Act 1981. For this purpose, the contractor will ensure that all dust generation points in the working areas are fully suppressed and so designed and operated so as to ensure dust concentration in air within the limits prescribed under mining & environment laws, including circulars issued from time to time for the purpose by DGMS office, Ministry of Environment & Forest and Rajasthan State Pollution Control Board.

In case of failures of the contractor to ensure dust suppression as required above, the Company may make such arrangements for dust suppression at risk and cost of contractor, apart from taking other actions as per the contract.

### 5.9. NOISE LEVEL:

The noise level of any machine (as measured inside the operator's cab or in nearby areas) shall not exceed the standard prescribed in the MMR-1961 and DGMS circular issued in this regard. The Company may stop operation of any machine the noise level of which is found to be above the prescribed limit.

### 5.10. MINE LIGHTING:

The contractor shall be provided & maintained lighting arrangement at working pit/s of the mine as per provisions of MMR-1961 and DGMS circular issued in this regard.

### 5.11. OTHER RESPONSIBILITIES OF CONTRACTOR:

- a) The contractor shall be responsible for providing shelter, accommodation, drinking water, medical aid etc to his /their employees at his own cost.
- b) The contractor shall be responsible for providing tools, tackles, implements etc. required for accomplishment of work.
- c) The contractor shall be responsible & liable for any accident & /or damage to equipment, employees or any other third parties at the mine in course of performance of the job under this contract & consequence claims.
- d) The contractor shall have to arrange fuel, lubricants etc. & power required for carrying out the work as required herein.
- e) The contractor alone shall be responsible & liable for payment of wages, charges etc in discharge of legal obligation in respect to staff employed by him at all times during the contract & termination /completion of the contract.
- f) The contractor shall be fully responsible for any litigation on account of pollution due to excavation, grinding, transportation, loading into trucks etc. of gypsum & abide pollution control norms.
- g) The contractor shall be responsible for safety, watch & ward etc. of the companies' properties under the possession of the contractor if any.
- h) In case of break down or default of any equipment /machine, same shall be repaired or replaced by the contractor immediately within 72 hours, failing which the company may carry out the work at the risk & cost of the contractor alongwith the 10 % service charges thereof and same shall be recovered from the running bills and / or security deposit (SD) amount lying with the company.

### Chapter 3 SCOPE OF WORK

# CONTRACT WORK UNDER PART-A TO BE EXECUTED BY THE CO-OPERATIVE SOCIETY ONLY:

- 5.12. In view of the prohibition of employment of contract labour in Gypsum raising etc. this tender has been called from such a co-operative Societies only which are registered under the Co-operative Societies Act, 2001 or any other Co-operative society Act of India or tenderers who forms the Co-operative society and get that registered and produce the relevant certificates along with the list of members of the Co-operative Society, within 30 days from issue of LOA / DLOA before commencement of work. No person who is not a member of the Co-operative Society shall be allowed to work in the mines under the Contract (Regulation & Abolition) Act-1970.
- 5.13. It will be at the discretion of the Company to withdraw the specified working area/mines allotted to the contractor at any time without assigning any reason whatsoever and alternative area/mines may be given, if considered necessary by the Company. No compensation would be payable to the contractor for damages, expenses on shifting of machineries like scrapper, excavators, tractor mounted grinding/screening attachments unit, transportation, loading into trucks etc. etc., that may arise out of the aforesaid withdrawal of the working area/mines or change of the area/mines.

### **SCOPE OF WORK:**

- 5.14. RSMML is intending for supply of Agricultural Grade of gypsum powder confirming BIS 6046-2023 (Minimum 50-70% Calcium Sulphate & 60 mesh size) from mines to designated place located in each district to Department of Agriculture (DoA), Rajasthan under MoU. The contractor so appointed by RSMML under this tender is responsible to produce required grade and quantity of gypsum powder in scheduled manner and deliver it at Grinding Unit at Mines and supply it by transportation at designated place in each District of DoA at single point and collect clear Goods receipt.
- 5.15. The contractor is liable for any deductions made by the DoA as per the terms & conditions of the MoU with RSMML. Thus, this MoU shall be the integral part of the contract agreement. Thus, contractor must maintain proper liaison with DoA for timely execution of the work and payment to the RSMML. Any deduction made by the DoA from the invoices of RSMML shall be recovered from the bills of the contractor

The scope of work under this tender broadly include two part: -

# A. <u>Part A Collection/removal of RoM Gypsum in mined out areas and its Screening</u> for production of Screened RoM Gypsum, Internal Transportation of Screened RoM gypsum, Grinding of Screened RoM Gypsum:

a) Collection/removal of ROM gypsum by Deploying suitable machineries like hydraulic excavator/JCB (with back-hoe attachment), water sprinklers, tractor scrapper attachment, etc. & other allied machineries to be utilized at Mines, leveling of worked out areas & sprinkling of water on haul road/s etc. in the allocated mined out areas/mines & as may be directed by the company from time to time. As per work requirement, machineries may require shifting within mine areas with no extra cost & expenses.

- b) Mechanized Screening/sorting of ROM gypsum at mine pit & to maintain quality as per work requirement under the tender. While screening/sorting, contractor/society will ensure maximum recovery from the ROM Gypsum to recover mineral gypsum of agriculture grade. The contractor will maintain the quality of Gypsum as available and shall not make/ cause/ allow any contamination/ dilution.
- c) Loading & Internal transportation of this screened Gypsum from mine pit to Grinding Unit/s and its unloading there.
- d) Contractor shall arrange of gypsum-bearing lands on behalf of RSMML from the private cultivators, if required, by way of having dialogue with the land owner and convince them to allow smooth & un-interrupted mining operations in the lease area of RSMML. However the mutual agreement shall be executed between concerned Mines Manager and Khatedar only.
- e) The contractor shall also arrange the land for movement of the trucks/trollas in leasehold areas at his own cost.
- f) Presently company is paying land & crop compensation @ Rs. 70/- PMT to the private landowner/s for the gypsum excavated from their private lands. The rate quoted by bidder in price bid is exclusive of payment for land & crop compensation to private land owner/s. In case of excavation of gypsum is being carried out in private land, contractor shall make payment of the land & crop compensation amount on rates mutually agreed rate between him and the Khatedar and the same shall be reimbursed to contractor @ Rs 70/- per metric ton on submission of documentary evidences along with respective bills.
- g) Back filling of overburden/ interburden/ waste material in pits shall be as per direction of the company's representative.
- h) Haul road/s in the pit shall be constructed and maintained including water sprinkling within the lease hold area of RSMML by the contractor at its own cost and in accordance with the provisions of Mines Act. The alignment & gradient of the haul road (including the ramp) shall be as per directions of the Company.
- i) For non-maintenance of haul road/s or access road/s or motorable road/s as constructed by the contractor / or already constructed by RSMML, then RSMML shall carry out the work at the risk & cost of the contractor along with the 10% service charge thereof and same will be recovered from the running bill/s of the contractor.
- j) Mechanized Grinding (using impact crusher with grate) of screened Gypsum; followed by screening (whole system attached with tractor) to produce particle size having 100% of the powder passes through 2 mm sieve & more than 50% passes through 0.25 mm sieve as per IS: 6046-2023 with latest amendment or equivalent standard. Sufficient Grinding/ screening Unit shall be deployed at each location in mines as per the work requirement to accomplish the job quantity as per schedule given under MoU by DoA.
- k) Packing of gypsum powder into 50 Kg HDPE bags, its weighment, stitching and proper stacking at Grinding Unit in 500 tonne stock. Each bags should be properly filled with 50 Kg weight.
- l) Loading after weighment of packed gypsum powder bags into tippers / trucks / trollas / dumpers deployed at Grinding unit. Only approved packed gypsum bags shall be loaded from each stack from grinding units which are confirming to BIS specifications IS:6046/2023. The contractor shall provide the trucks/ trollas for loading of Packed Gypsum Powder Bags from approved stocks only at Grinding

- Unit. No sub slandered material shall be loaded & supplied from the Grinding unit by the contractor/society.
- m) The Gypsum shall be sampled and analyzed by RSMML or its representative for quality aspects. Contractor shall provide all assistance during sampling of the material at mines/Grinding Unit sites
- n) Gypsum shall be checked for proper quality either by departmental or by third party analyst. The loaded tippers/ trucks / trollas /dumpers approved on account of quality shall only be allowed for grinding. However, those tippers/ tippers/ trucks / trollas /dumpers rejected on account of quality shall be unloaded at separate designated stacking yards for which no payment shall be given, and royalty and taxes will be recovered, if applicable.
- o) Contractor shall be responsible for safety, security and watch & ward etc. of the company's properties under the possession of the contractor.
- p) Loading hours can be round the clock, as per the requirements.

# B. Part-B Supply of HDPE Bags,

Supply of HDPE bags of capacity 50 Kg. lining bags of 110 gm. in weight. The bags marked with the details of the suppliers' Company name i.e. RSMML & its Logo with type of mineral and specifications with lot number and have to be arranged by the bidder himself. The capacity of bag shall be to hold 50 Kg. of Gypsum Powder. However, for reference broad specifications are provided at Annexure-E. The tentative requirement of number of bags will be sufficient for packaging of 50000 MT of Gypsum in 50 Kg packaging. The Contractor will bear all responsibilities for any damages/wastages incurred to the HDPE bags during packaging, no claim of whatsoever nature will be entertained in this account.

- C. <u>Part -C</u> transportation of Packed Powder Gypsum loaded trucks to single point destination of DOA at each district, unloading and stacking, obtaining clear GR at receipt and other related works: -
- a) Temporary proper Stacking of packed gypsum powder bags minimum of 100 MT.
- b) The company or its representative shall draw samples of material from each lot as well as at the destination to determine its various parameters as per BIS specifications for agriculture grade of gypsum (like constituents and moisture, physical parameters and weight of each bags etc.). The contractor shall be responsible to ensure that the qualitative property of the material is not lost during the transit due to contamination with external foreign material.
- c) The contractor is expected to maintain close co-ordination with company's officials and DoA for day-to-day work.
- d) Unloading hours can be round the clock, as per the requirements.
- e) The contractor shall make arrangement by deploying of sufficient trucks/trolla for transportation of packed agriculture grade gypsum powder from mines to designated districts at a single point and its unloading and stacking at the point and hand over to concern authority.
- f) At supply point DoA shall also carry out lot wise sampling and analysis of the material supplied by contractor and its results shall be made available to RSMML within seven days' time. Their results shall be considered final for release of payment of the respective quantity. Contra tor shall maintain close liaison with the officials of DoA and also representative of RSMML during sampling at supply point and collect

- the results along with Goods receipt as supporting document to submit RSMML along with bill.
- g) The payment of sub-standard material supply which shall not be confirming to BIS specifications for agriculture grade at destination point, shall not be considered for payment.

# 5.16. **QUALITY ASPECTS:**

- a) The contractor will ensure that the contents of CaSO4.2H2O in the produced Screened RoM Gypsum do not fall as per requirement of agriculture grade of gypsum for plus 70% grade and also ensure supply of agriculture grade powder Gypsum of plus 70% grade. The contractor will have to exercise due care and follow the directions as may be given by company's site officials.
- b) In any case the grade contents of CaSO4.2H2O should not be less than 50% under the supply.
- c) The Contractor shall only ground desired grade of Screened RoM Gypsum to produce Gypsum powder as per specification of BIS:6046-2023 & pack into HDPE bags.
- d) RSMML or by third party analyst so appointed by RSMML for the purpose will carry out sampling at Grinding Unit and at supply locations of DoA in ach district in presence of the representative of contractor for each lot of 100 tonne to assess the quality of the grounded gypsum and shall be analyzed at laboratory. DoA may also carry out cross check sampling and analysis work at mines/grinding unit site. Any rejection of the lot will not be dispatched by contractor/society under the supply to DoA. The rejected quantity will not be calculated in the total executed quantity & for such rejected lot, no payment shall be made to the contractor.
- e) Any deduction on account of quality/quantity by DoA as per MoU with RSMML, the same shall be recovered from the running bills of the society.
- f) DoA may also carry out check sampling at supply point i.e. at Grinding Unit to conform to the specifications and any rejection on account of quality of quantity shall attract nonpayment under the supply by DoA to RSMML under MoU and the same shall be recovered from the contractor.
- g) The quantity for payment to the contractor shall only be considered for the accepted quality of powder gypsum by DoA at their supply point. The decision of DoA under this reference shall be final for the purpose.

### 5.17. MOBILISATION & COMMENCEMENT OF WORK:

- a) In the event of the award of the contract, the contractor shall have to commence the work for excavation/collection/screening/grinding of gypsum within 30 days from the date of issue of Letter of Acceptance (LOA/DLOA). Contractor shall have to mobilize their equipments/manpower/resources for commencement of work within 30 days from the date of acceptance of its offer.
- b) In exceptional circumstances & at its sole discretion, the company may extend the mobilization period if so requested by the contractor. In case of failure to commence the work within the stipulated period, the company shall have absolute discretion to withdraw the letter of Acceptance and forfeit the earnest money deposit (EMD) &/ or security deposit (SD).

### Chapter –4

## QUANTUM OF WORK, PERIOD OF CONTRACT, TIME SCHEDULE, COMPENSATION FOR DELAYS, SHORTFALL, BILLING & PAYMENTS ETC.

### 5.18. QUANTITY & PERIOD OF CONTRACT:

a) Quantum of work and period of contract envisaged under this contract is as under:

The quantity and distances are only indicative. Before submission of offer, the bidder has to verify the distances from mines to supply center in each district under this bid. The payment will be made on actual basis.

The schedule may further be divided into monthly/quarterly schedule as per the requirement and as per the directions of Engineer-In-Charge. However, this quantity is only indicative & susceptible to variation from time to time at the absolute discretion of the company. It can even vary substantially on month to month basis as per market reason/demand. The demand of this agriculture grade gypsum under the job is seasonal. Rainy season is lean season of demand of powder gypsum under the contract. Maximum supply shall be made under MoU with DoA during period of pre & post monsoon season in the year.

- c) In the event, quantum of work is required to be varied beyond the above tendered quantity, then the company will notify the same at least with 15 days' notice.
- d) The period of contract shall be one year from the date of issuance of letter of acceptance by the Company. The company may at its sole discretion extend the period of contract at its sole discretion as per provisions of RTPP Act, 2013
- e) In case of failure to commence the work within the stipulated period, the company shall have absolute discretion to withdraw the letter of Acceptance (LOA) & forfeiture of the Earnest Money & / or Security Deposit & also to award the contract to any other party without prejudice to right of the company to claim compensation & other costs from the contractor in whose favour the work was awarded.
- f) Quantity mentioned above may change depending upon the requirement of the company and/or demand of gypsum from buyers. No guarantee regarding overall, annual, monthly, weekly or daily quantum of work can be given. The contractor shall neither be entitled nor be eligible to raise any claims on account of their vehicles/equipments/menpower being idle on any day or for any period during the contractual completion period.
- g) The company reserves the right to make any alteration /addition in the area for the contracted quantity as above including allotment of work in other alternate area.

### 5.19. CRITERIA FOR DECIDING LOWEST TENDERER:

The lowest quoted offered in totality shall be the criteria for deciding lowest tenderer under the tender.

- i. The composite remuneration payable under total work i.e. arithmetic summation of total offered remuneration as quoted for item Nos. Part A, Part B & Part C of the Price Bid (Form-6)/BOQ shall only be considered for deciding the successful tenderer. The remuneration will be calculated on the basis of tendered quantity and offered rate for each item.
- ii. The price bids of only techno-commercially acceptable tenderers will be evaluated. The lowest tenderer for the entire work will be the one whose rate will result into minimum financial out go to the company. Financial out go shall be computed as sum total of "item wise quoted X Rate respective tendered quantity."

### **NEGOTIATION.**

- 5.20. Negotiations, if required, will be conducted first with the lowest tenderer. In case of non-satisfactory achievement of rates from lowest tenderer, RSMML may choose to make a written counter offer to the lowest tenderer and if this is not accepted, RSMML may decide to reject and re-invite fresh tenders or to make the same counter-offer first to the second lowest tenderer, then to the third lowest tenderer and so on in the order of initial bidding, and work order be awarded to the tenderer who accepts the counter offer first.
- 5.21. In case, when the quotations given by the tenderer during negotiations are higher than the original quotation of the tenderer; then the tenderer will be bound by the lower rate originally quoted by the tenderer.

5.22. In case of negotiations, representative of the tenderer attending negotiations must possess written authority from the tenderer to the effect that he is competent to modify/amend the submitted tender for deviations, exceptions and rates offered by them.

### 5.23. COMPENSATION FOR SHORTFALL IN THE TENDERED QUANTITY:

### a) For Delay in commencement

In case of failure to commence the work within the stipulated period, the company shall have absolute discretion to levy pre-determined compensation @ 0.5% of the total contract value on weekly basis subject to maximum of 2%... In the event the compensation exceeds 2% of total contract value, then other provisions including termination of contract, forfeiture of EMD, withdrawal of DLOA shall apply at sole discretion of Company

### b) For Shortfall in tendered quantity

The contractor shall adhere the schedule production targets of the supply of agriculture grade Gypsum powder on annual basis of total scheduled quantity, as mentioned in scope of work. In case contractor fails to produce the scheduled/targeted production on annual basis, then company may withhold predetermined & agreed compensation @ 10% of the value of the actual shortfall during the respective year. The value of compensation shall be determined considering the applicable Sale rate of powder Gypsum for Department of Agriculture for particular district in which the short fall occurs during that period multiplied by actual shortfall quantity. However, the total compensation shall not be more than 10 % of the contract value.

- c) The said amount of compensation shall be payable by the contractor to the company forthwith on first demand without any demur or protest and without there being any proof of the actual loss or damages caused such delay/breach. The company at its sole discretion shall be justified to adjust such damages against the security and/or running and/or final account bills of any sum due or will become due with the company on account of any work of the contractor and the contractor shall be bound by such decision of the Company. The above recoveries will be without prejudice to the other right and remedies available in the contract.
- d) Over and above the compensation on shortfall in execution of work, the company may at its sole discretion get the balance quantity of overall unexecuted work executed from any other agency at the risk and cost of the contractor and in that event, the company shall be entitled to recover from it the full difference of cost of making such alternative arrangements and/or forfeit the whole or such portion of the security deposit as it may consider fit.
- e) The Compensation so paid/and/or adjusted by the company shall not relieve the contractor from his/ its obligations to complete the work under the contract or from any other obligations and liabilities under the contract.

### 5.24. RIGHT TO REVIEW PERFORMANCE:

a) The Company reserves the right to review and assess the performance of the work at any time during the contract period. In case of poor or unsatisfactory performance and/or breach of any terms and conditions of the contract, the company in its absolute right and discretion may take appropriate action including termination of the contract.

b) The company shall have absolute right to determine and ascertain the damages or losses suffered by it due to poor performance or breach of the terms and recover the costs thereof from the contractor from the security deposit or any sum due to the contractor from the company. The Company shall also have absolute right to get the work done from any other agency at the risk and cost of the contractor, in case, the contractor fails to perform the work continuously for more than 3 (three) days.

### 5.25. WEIGHMENT:

- a) All trucks /tippers/trollas etc. empty as well as carrying Gypsum Powder /Screened RoM Gypsum as the case may be, shall be weighted on the departmental weighbridge/s or weighbridge notified by the company. The weight recorded in the weighment slips of the weighbridge specified by the company shall only be considered for determination of monthly payment for the above work under this contract. - d) The rate of remuneration shall be deemed to include & cover the risk of all possibilities of delay & interference with the contractor's conduct of which occur from any cause including orders of the company in the exercise of his/its powers & on account of extension of time granted due to varies reasons & for all other possible or probable cause of delay/s in execution of this work by the contractor. The contractor shall not entitle to raise any claims &/ or dispute on account of any rise in the price of equipment/s, spares, oils, lubricants, tyres, tubes, statutory or otherwise on any ground or reason or accounts whatsoever.

- e) Any deduction on account of quality/quantity by DoA as per MoU with RSMML, the same shall be recovered from the running bills of the society.

- d) Final payment including the security deposit will be released to the contractor only on furnishing the Final Certificate by him/ it within one month.

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued thereunder, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

### **Additional Conditions of Contract**

### 1. Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. if there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.
- ii. if there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its EMD shall be forfeited or its Bid Securing Declaration shall be executed.

### 2. Procuring Entity's Right to Vary Quantities

- (i) At the time of award of contract, the quantity of Goods, works or services originally specified in the Bidding Document may be increased or decreased by a specified percentage, but such increase or decrease shall not exceed twenty percent, of the quantity specified in the Bidding Document. It shall be without any change in the unit prices or other terms and conditions of the Bid and the conditions of contract.

### SPECIFICATIONS OF HDPE BAGS FOR PACKING GYPSUM POWDER

#### 1.0 TYPE OF BAGS:

The HDPE Bags should be made out of fabric on circular looms. The fabric used for the manufacture of the HDPE bags shall be single piece of colour to be specified by FAGMIL at the time of placing order. The fabric should be as per IS; 9755 - 2016 & revision upto date. The tape used for fabric should confirm to IS: 6192 - 1984 & revision upto date. The construction of the fabric should be as detailed below:

(i) WIDTH OF TAPE (Min.) : 2.5 mm (ii) MESH per Inch (Min.) : 10 x 10 (iii) DENIER OF TAPE (Min.) : 1000

1.1 If it is proven that any supplier has supplied any PP bags, even if payment is released for that supplies and later on report by the Inspection Agency proves that the bags supplied were poly propylene, deduction on account of wrong supplies would be made from subsequent supplies. No PP Bags would be supplied by any supplier since the bagged powdered material is kept in the mines in open condition which are subject to rain/sunshine and the bags are likely to disintegrate on exposure to weather condition.

#### 2.0 CAPACITY AND SIZE:

2.1 The capacity of bag shall be to hold 50 Kg. of Gypsum Powder. The inside dimensions of each bag shall be as follows:

Length : 787 mm (Inside dimension) Width : 559 mm (Inside dimension)

2.2 Tolerance for length and width shall be +20 mm and -10mm.

### 3.0 WEIGHT OF THE BAG:

3.1 The weight of individual bag shall be 88 gms. +/- 6%. The tolerance of a bale of 500 bags (excluding packing material) will also be +/- 3%.

#### 4.0 MOUTH OF BAG:

4.1 The mouth of bag shall be salvaged, hemmed or heat cut so that the tapes do not fray. The mouth of the bag should be completely open after heat-cut.

### 5.0 STITCHING:

5.1 The bags should be bottom stitched and sewn with two rows of lock/chain stitch with a tape of 20% higher than the denier of tape of bags. The stitching shall be uniform without any loose thread or knot. Joint or center sewn bags will not be accepted. The fold should occur on the opposite side of printing made on the bag. Other details will be as per IS specifications.

### **6.0 BRANDING:**

- 6.1 The bags shall be branded by flexo-printing method in two colours on one side as per the monogram furnished by FAGMIL.
- 6.2 The ink and ingredients to be used for printing shall be smudge free, bright in colour, should not smear in contact with water, harmless to fabric and should be of sack branding quality manufactured by reputed firms. The ink used for printing should be polyamide resin

base and the printing should have abrasion and scratch resistance. The scratch resistance of the bag shall be tested by rubbing with HDPE bag of size 6" x 4" filled with gypsum.

- 6.3 The colour fastness to crocking, light and water should be applicable as per ISO 105 x 12 : 1993, ISO 105 BO2 : 1994 and ISO 105 E01 : 1994 (revision upto date) respectively.
- Any deviation from the above in terms of branding, would make the supplies liable for rejection.
- 6.5 Each bag, MUST, in addition to the printing of our monogram, bear the initials of the supplier on the bottom left hand corner, and the abbreviated month and year of manufacture, on the bottom right hand corner. For this purpose, each month would be given a serial-wise "Alphabetical code" commencing with January with the alphabetical code "A" and December with the code "L" etc. The year would be denoted by the last digit i.e. 2001 would be denoted by 01 and 2002 by 02. Bags manufactured, for example in December, 2001 would carry the code L-01 and April, 2002 would carry the code D-02 etc.

### 7.0 COLOUR OF BAG:

7.1 FAGMIL shall specify the colour at the time of placing the Purchase Order. FAGMIL also reserves the right to change the colour, if need be, after giving due notice.

#### **8.0 PACKING:**

- 8.1 The bags will be flat packed in trusses of 500 numbers only. The trusses will be wrapped with HDPE fabric or Hessian of 6.5 to 7.0 oz cloth and properly stitched to withstand handling during transit and storage.
- 8.2 Each truss shall be clearly marked as follows:
  - (a) Purchase Order No. and the month of scheduled delivery.
  - (b) Lot Number.
  - (c) Gypsum.
  - (d) Year and month of manufacture.
  - (e) Vendor's mark.
  - (f) Truss Number.
  - (g) Inspection Agent's seal.
- 9.0 All other specifications not specified in the foregoing paras will be as per IS: 9755 2016, as revised up-to-date.
- **10.0** Calcium Carbonate (CaCo3) Content Limit:

Maximum limit ash content should be as per limit prescribed under IS:9755-2016 for non-UV stabilized sacks.

Supplier should use minimum of other additive master batches like anti fibrillation master batch/CaCO3 fillers. **Determination of Ash Content is as below:** 

### A) PRINCIPLE

The procedure is used to find out the inorganic residue in raffia tape/fabric sample by ashing it in a muffle furnace. A weighed amount of tape/fabric sample is heated to 550°C. The polymer sample (organic portion) is burnt at 550°C until constant mass of inorganic matter is obtained. The residue (inorganic matter) is reported in terms of percentage ash content in a given sample.

### **B) APPARATUS**

- I) Weighing balance accurate to 0.001 g.
- II) Silica crucibles (sufficient volume to accommodate 30 g of sample in such a way that level of the sample after filling the crucible does not cross half the height of crucible).
- III) Bunsen Burner
- IV) Triangle and Tripod
- V) Muffle Furnace (capable of being controlled thermostatically at  $550^{\circ}\text{C} \pm 10^{\circ}\text{C}$ ).
- VI) Desicator containing an effective drying agent (for example silica gel) that does not react chemically with ash components.
- VII) Gloves and Crucible Holder

### C) SAFETY

- I) Burn the sample in an effectively ventilated hood.
- II) Keep the hood closed and do not inhale the fumes of combustion.
- III) Wear gloves and use sample (crucible) holder, to introduce crucible in the furnace.
- IV) Sample should be folded properly to accommodate it in silica crucible.

### D) PROCEDURE

- I) Heat the clean crucible at  $550^{\circ}\text{C} \pm 10^{\circ}\text{C}$  for 10 to 15 min and cool it in a desicator.
- II) Weigh the empty crucible to nearest 0.001 g.
- III) Weigh  $30 \pm 2$  g of raffia tape/fabric sample in the crucible (nearest to 0.001 g).
- IV) Heat the crucible directly on burner so that the sample burns slowly and loss of ash is avoided. Continue burning until no more smoke is evolved.
- V) Transfer the crucible in the muffle furnace, which is already maintained at approx. 550°C and keep the crucible inside for about 2 h.
- VI) Remove the crucible from the furnace and cool it to the room temperature in a desicator. Weigh it and record the weight to accuracy of 0.001 g.
- VII) Keep the crucible in the muffle furnace for another half an hour, cool in a desicator and weigh again. Repeat the procedure until constant mass is obtained.
