i) The tenderer should have minimum turnover of Rs. 19.70 Lacs in any one of the immediate preceding three financial year's i.e.2017-18, 2018-19 & 2019-20 in its own name.

SECTION-II

DEFINITIONS, INTERPRETATIONS AND DECLARATION BY THE CONTRACTOR

DEFINITIONS:

In the contract (as hereinafter defined) the following words and expression shall have the meaning hereby assigned to them, except where the context otherwise requires.

- **2.1.1 Agent** shall mean the Agent for Jhamarkotra Mines so notified by the company in this behalf.
- **2.1.2 Alteration/Variation order means**, any order given in writing by the Engineer-In-Charge to the Contractor from time to time to effect additions to or deletions from and/or alteration in the work/s.
- **2.1.3 Appointing Authority** wherever the expression is used shall mean the Managing Director of the Company.
- **2.1.4 Approved shall** mean approved in writing by the Company/Engineer-In-Charge/Officer-in-Charge.
- **2.1.5** Commencement of work shall be reckoned from the date of issue of letter of acceptance including the stipulated mobilization period.
- **2.1.6 Completion Certificate** shall mean the certificate to be issued by the Engineer-in-Charge when the work/s has been completed to his satisfaction as per terms of the contract.
- **2.1.7 Contract Document** shall mean collectively tender documents, telex/letter of acceptance, agreed variations, if any and other documents constituting the tender and acceptance thereof.
- **2.1.8** Contract Rate or "Schedule Rate" or "Rate of Remuneration" means rate(s) entered in figures and words in schedule/s by the Contractor and/or rate(s) accepted by the Company as payable to the Contractor for execution /performance of all contractual obligations as per terms of the contract.
- **2.1.9 Contract** shall mean the agreement between the Company and the Contractor for execution of the work/s including therein all documents such as invitation to tender, instructions to Contractor, general conditions of contract, special conditions of contract, job specification, general requirements, time schedule for completion of work, letter of acceptance awarding the work, alteration/variation order, agreed variations, if any etc. Any subsequent changes made in any of these documents, would be deemed to be a part of the Contract.
- **2.1.10 Contractor** shall mean the person or persons, firm or company, who's tender, has been accepted by the Company and shall include his/its/their legal representatives, administrators, successors, executors and permitted assignee.
- **2.1.11 Day** shall mean period of twenty-four hour from 6:00 AM morning of any particular date to 6:00 AM morning of immediate next date.
- **2.1.12 Engineer-In-Charge** or "**Officer-In-Charge**" shall mean the Officer so designated for the overall supervision, coordination, direction and administration of the contract work from time to time by the Company.
- **2.1.13** "Group General Manager (Contract)" shall mean the Group General Manager for contract division of RSMML or his successors in office so designated by the company.
- **2.1.14 Head of the SBU & PC- Rock Phosphate** or "**Group General Manager**" shall mean Group General Manager for the SBU & PC Rock Phosphate of RSMML or his successor in the office so designated by the Company.
- **2.1.15** Letter of acceptance shall mean intimation by a letter to Contractor that his/its tender has been accepted, in accordance with the provision contained in the letter/Fax
- **2.1.16 Managing Director** shall mean the Managing Director of Rajasthan State Mines and Minerals Limited.
- **2.1.17 Mine Haulage Road** shall mean all the access in the mine including ramps, haulages at ore stack yard, waste dump yard etc.

- **2.1.18 Mines Manager** shall mean the Mining Engineer so designated under Mines Act, 1952 for different Rock Phosphate Mines of the Phosphate Division of Rajasthan State Mines and Minerals Limited.
- **2.1.19 Mines** shall mean Jhamarkotra Rock Phosphate Mines of the Company under SBU & PC Rock Phosphate situated in the district of Udaipur.
- **2.1.20 Month** shall means the period of calendar month.
- **2.1.21 Notice** or "**Notice in writing**" or "**written notice**" shall mean a notice written, typed or printed sent (unless delivered personally or otherwise proved to have been received) by registered post to the last known business address or registered/Head/local office of the addressee and shall be deemed to have been received in the ordinary course of post.
- **2.1.22** Ore or "Rock Phosphate Ore" or "Phosphorite" shall mean all types of meta-sedimentary rock phosphate with variable P₂O₅ having "Apatite" as main constituent mineral along with other associated impurities.
- **2.1.23 Road Roller** mean diesel operated road roller of the capacity as required for this tender for execution of the scope of work.
- **2.1.24 RSMML** or **Company** shall mean "Rajasthan State Mines & Minerals Limited," having its registered office at C-89/90, Jan path, Lal Kothi Scheme Jaipur (Rajasthan) and Corporate Office at 4, Meera Marg, Udaipur (Rajasthan) including its successors and assignees or its representatives authorised to act on its behalf for the purpose of contract.
- 2.1.25 Shift shall mean the notified period of eight hours and as specified as per and in terms of Mines Act etc.
- **2.1.26 Site** shall mean the land or other place on, under, in or through which the work/s are to be carried out and other land or place or area/s provided by the Company for the execution of the contract.
- **2.1.27 Specifications** shall mean directions, various technical specifications, provisions and requirements attached to and referred to in the contract, which pertain to the method and manner of performing the work/s and the materials to be furnished /used required to be used/consumed and/or provided for executing work/s as may be amplified or modified by the Company or the Engineer-in-Charge from time to time and notified/communicated to the Contractor during the course of performance of this contract and provide for the unforeseen conditions or in the best interest of the work/s. It shall also include the latest addition including all agenda or corrigenda or relevant rules, regulations regulation codes.
- **2.1.28 Temporary Works** shall mean and include all temporary work/s of every kind for the execution of the main work as incidental and ancillary thereto.
- **2.1.29 Tender** shall mean the offer submitted by the Contractor against this inquiry for acceptance by the Company.
- **2.1.30 Working Hour** shall mean the net working hour for which the road roller and/or manpower has been engaged for execution of the work for maintenance of Mine haulage road and other related work as per the directions of the Engineer-In-Charge

INTERPRETATIONS:

- 2.2.1 Wherever it is mentioned that the Contractor shall do or perform or cause to be done certain work/s or provide certain facilities or discharge certain obligation/s or make certain provision/s etc. it is expressly agreed and understood that each and every such work/s, facility, obligation/s or provisions etc. shall be made and/or provided by the Contractor and liability discharged to the satisfaction of the Company at the cost and consequences of the Contractor.
- 2.2.2 Several clauses and documents forming the contract are to be taken as mutually explanatory. Should there be any discrepancy, inconsistency, error or omission in the contract or for any of the matter/s, the same shall be referred to in writing by the Contractor to the Managing Director of the Company whose interpretation/s, decision in writing shall be conclusive, final and binding on the Contractor.
- 2.2.3 All headings and marginal notes to the various clauses of the contract are solely for the purpose of giving a concise indication and not a summary of the contents thereof, and they

- shall never be deemed to be part thereof or be used in the interpretation or construction thereof, or of the provisions of the contract.
- 2.2.4 In the contract, unless otherwise stated specifically, the singular shall include the plural and vice versa, wherever the context so requires, the words importing person/s shall include incorporated companies, registered association, body of individuals or partnership firm.
- 2.2.5 General conditions of contract shall be read in conjunction with the Special Conditions of Contract, Specification of work and any other documents forming part of this contract wherever the context so requires.
- 2.2.6 Notwithstanding the sub-division/s of the various clauses of the contract into the separate parts/sections, every part of such shall be deemed to be supplementary to and complementary of each and every other part and shall be read with and into the contract so far as it may be practicable to do so.
- 2.2.7 Where any portion of the General Conditions of the contract is repugnant to or at variance with any provisions of the Special Conditions of Contract, then, unless a different intension appears, the provisions of Special Conditions of the contract shall be deemed to over-ride the provision of the General Conditions of the Contract and shall to the extent of such repugnancy or variations, prevail.
- 2.2.8 No Director or official or employee of the Company shall in any way be personally bound or liable for the acts or obligations of the Company under the contract or answerable for any default or omissions in the observance or performance of any of the acts, matters or things which are herein contained.
- 2.2.9 No verbal agreement or inference from conversation with any officer or employee of the Company before, during or after the execution of the contract shall in any way affect or modify the terms or obligations contained herein.
- 2.2.10 No amendments to the contract shall be valid unless specifically made as an amendment to the contract and signed by the authorized representative of the parties.

DECLARATION BY THE CONTRACTOR

- 2.3.1 The Contractor has also ascertained the location and situation of area/site where the Contractor would be required to undertake the work including existing/proposed approach road/s and other data, information, particulars etc. appreciating all pros and cons, availability of source of water in the area, availability of land and its location/distance from site camp, stores, etc. and all such other information, whether technical/commercial or otherwise.
- 2.3.2 The Contractor has also assessed and satisfied himself as to the nature, condition, quantum, extent, scope and magnitude of the work, involved in the contract, type and nature of various types of Rock Phosphate ore, working conditions of the area/s, availability of power supply, water supply, men and machinery requirement, availability of land etc. The Contractor do hereby agrees and undertakes not to raise any dispute and/or objection at any stage on any ground whatsoever.
- 2.3.3 The Tenderer/ Bidder would give a declaration that they have not been banned / suspended or de-listed by RSMML. If this declaration is not given, the bid will be rejected as non-responsive.

Section-3

INSTRUCTIONS TO THE TENDERER

INSTRUCTIONS TO TENDERER & GENERAL CONDITIONS:

- 3.1 Tender is to submitted online at https;//eproc.rajasthan.gov.in in electronic form as prescribed in the tender form. Tender fees & processing fees will not be refunded in any case.
- 3.2 The bidder should go through the website https://eproc.rajasthan.gov.in & the link "help for contractors "," information about DSC", FAQs & the bidder manual kid " to know the process for submitting the electronic bids at web site. The complete bid document has been published on the web site https://eproc.rajasthan.gov.in for the purpose of downloading. The uploaded bid document shall be considered valid for participation in the bid process subject to submission of required cost of tender document e-Tendering processing fee.
- 3.3 All communications/correspondences/documents including the bid document should be physically signed, stamped on each page before uploading & also signed digitally by the designated authorized representative of the bidder.
- **3.4** A scanned copy of EMD, e-Tendering processing fee & cost of tender document must be enclosed along with the technical bid proposal failing which the bid will be summarily rejected.
- 3.5 The demand draft towards the cost of tender document fees, earnest money deposit & processing fees along with original affidavits as per format of tender document should be kept in a sealed envelope addressed to Group General Manager (Contract), RSMML, Corporate office, Udaipur. This envelope should be marked with NIT number & work, name & address of the contractor; telephone no. etc. is to be written on the top for clarity. This envelope should be submitted in the office the Group General Manager (Contract),RSMML, Corporate office, Udaipur on or before the date & time as mentioned in the notice inviting tender. The company shall not be responsible for any postal delay. In case of non receipt of the same prior to the time of scheduled submission of the tender, the offer of the tenderer shall be rejected.
- 3.6 The tenderer in quoting his rate, shall for all purpose, whatsoever, be deemed to have himself independently obtained all the relevant & necessary information for the purpose of preparing his tender. The correctness or completeness of the details, given in the tender documents is not guarantee d. The tenderer is required to satisfy him in all respect before the submission of offer.
- 3.7 The tenderer shall be deemed to have examined the tender document, to have obtained his own information in all matter whatsoever that might affect the carry out of the works at the scheduled rates & to have satisfy himself to the sufficiency of his tender. Any error in description or quantity or omission in the contract document shall not vitiate the contract or release to the contractor from executing the work comprised in the contract according to specifications at the scheduled rates. The tenderer is deemed to know the scope, nature & magnitude of the works & requirement of the materials, equipments, tools & labour involved, wage structures, conditions of the service of the company's staff/workmen doing similar & same type of work etc & as to what all works he has to complete in accordance with the contract document irrespective of any defect, omissions or errors that may be found in the contract documents. The contractor shall be deemed to have visited site, availability of water, electric power, labour etc, transportation facilities, probable

- sites for labour accommodation & store go-downs etc & all other factors involved in the execution of works.
- 3.8 All the provisions of Rajasthan Transparency in Public Procurement Act & rules made there under & modification to be issued by the competent authority from time to time will automatically be ipso-facto applicable.

TENDER PROCEDURE:

- **3.9** (i) e-Tender portal https;//eproc.rajasthan.gov.in shall be used for all procedure related to the bidding.
 - (ii) The prospective bidders should register themselves in the e-tender portal & submit the bid electronically through the e-tender portal.
 - (iii) The bidders are requested to download the e-tender help manual & user manuals from the portal for reference.
 - (iv) It is mandatory for the bidders to possess a valid Digital Signature Certificate to complete the e-tender Bid process as per the provision of Government of India IT Act
 - (v) The technical bid form & price bid form will be available in prescribed format for down loading. The registered bidders can log into the e-Tender system & download the bid forms.
 - (vi) The bid form should be filled & submit using the Digital Signature Certificate. The supporting documents as required in support of tender should be scanned & uploaded in the e-Tender system.
 - (vii) The bid form should not changed or altered or tampered by the bidder. If the bid form found tampered, the bids will be summarily rejected.

TENDER DOCUMENT FEES:

3.10 The tender document fees as mentioned in The NIT shall be paid by way of DD in favour of RSMML payable at Udaipur.

E-TENDERING PROCESSING CHARGES:

3.11 For each & every bid submitted a non-refundable processing charge Rs.1000/should be paid by way of Demand Draft or Banker's Cheque drawn in favour of "MD RISL "payable at Jaipur. The payment by way of Demand Draft or Banker's Cheque should be deposited physically at office of GM (Contract), RSMML, Corporate office, 4, Meera Marg, Udaipur, Rajasthan-313001 on or before the date & time of submission of the tender.

ONE BID PER TENDERER:

3.12 Each tenderer shall submit only one tender, either individually or as a partnership firm or a private/public limited company or a co-operative society.

COST OF BIDDING:

3.13 The tenderer shall bear all costs associated with the preparation and submission of his offer, and the company will in no case be responsible or liable for those costs, under any conditions.

GENERAL INSTRUCTIONS FOR FILLING THE TENDER:

- **3.14** All uploaded document shall be digitally signed by the tenderer or by a person holding power of attorney authorized him/her to sign on behalf of tenderer before submission of the tender.
- 3.15 Tender in which any of the particulars & prescribed information is missing or incomplete in any respect &/or prescribed conditions are not fulfilled may be liable for rejection.
- **3.16** Canvassing in connection with tenders is strictly prohibited for tenderer submitted by the tenderers, who resort to canvassing, will be liable for rejection.
- 3.17 Tenderers in their own interest are advised to read the tender document completely & carefully, to avoid submission of incomplete bid. Tender, in which any of the particulars & prescribed information is missing or incomplete in any respect &/or prescribed conditions are not fulfilled are liable for rejection, at the sole discretion of the company.
- 3.18 The company takes no responsibility for delay, loss or non-receipt of required document sent through post/courier service. Offers through any other mode other than prescribed shall not be accepted.

CLARIFICATIONS OF CONTENTS OF TENDER DOCUMENT:

- 3.19 In case an intending tenderer require any clarification in connection with, or any point covered by, the tender documents, or as to any matter or work to be done or not to be done by him in the event the contract for the work is awarded to him, he must submit a request for such clarification in writing so as to reach the company at least seven days in advance of the last date fixed for submission of tender. Copies of any such clarifications furnished by the company will be supplied to all other intending tenderer and such clarifications will constitute addenda/corrigenda to, and be read as part of the tender documents.
- 3.20 The company will not be bound by any verbal/oral clarification or interpretation of the tender document or of any matter(s) connected with works to be executed in accordance with the tender documents, which may be made by any of its employee, representatives or agent.
- 3.21 Any neglect or failure on the part of the tenderer in obtaining necessary and reliable information upon the foregoing or any other matters affecting the contract shall not relieve him from any risks or liabilities or the responsibility from completion of the works at the scheduled rate/s & time and in strict accordance with the contract document/s.

ADDENDA/CORRIGENDA:

- 3.22 Addenda/corrigenda to Notice Inviting Tender or to this tender document may be issued to clarify documents or to reflect modification in the specifications or terms & conditions or scope of work or for any other reasons.
- 3.23 Addenda/corrigenda to these tender documents, if issued by the company, shall form an integral part of this tender document and must be signed and submitted along with the bid.

CURRENCIES OF THE BID AND PAYMENT:

3.24 The unit rates and prices shall be quoted by the tenderer entirely in Indian Rupees.

SUBMISSION OF TENDERS:

- 3.25 The tenders shall be submitted online as prescribed above in the tender document. The "Techno-commercial Bid" should contain the following;
 - i) Power of Attorney in favour of the authorized representative signing the tender, as required.
 - ii) Attested Certificate of Incorporation/Memorandum & Article of Association/ Partnership Deed duly certified by the Company Secretary/Gazetted Officer as the case may be. In case the tenderer/contractor makes any change in the constitution of the firm after submission of the offer; they shall have to inform the company at the earliest.
 - iii) Copy of PAN Card (Income Tax Number).
 - iv) Attested copy of the Audited/CA Certified Balance Sheet for the financial years prescribed in the tender conditions in support of the turnover.
 - v) Undertaking that no condition is mentioned in Part II 'Price Bid' and conformation to the effect that the price quoted in Part II 'Price Bid' of the tender will be firm during contract period except variation in rate of service tax. Even if any condition/s, other than like discounts, are mentioned those would be ignored, at the risk & cost of the tenderer.
 - vi) "Exceptions and deviations statement" to be submitted by the tenderer in Form-C. enclosed.
 - vii) Provident Fund Account Number of establishment and its effective date or undertaking as per Annexure "C.".
 - viii) Duly filled form A, B Annexure D,E,G of tender document.
- Public/ Magistrate in support of above required details and any declaration given by the tenderer without requisite supportive documents will not be considered. It may be noted that the bid shall be examined on the basis of documents submitted, as per above required details, furnished along with it. A tenderer shall be fully responsible for consequences including rejection of his tender or cancellation of the contract if the required attested documents/ attested copies of documents are not submitted along with the techno- commercial bid or any information/document is found to be false/fabricated/misleading. The authorized signatory of the tenderer should put his signature along with its stamp on each page of the Techno-commercial bid and should also record the date.

PART II 'PRICE BID':

- 3.27 The 'Price Bid' shall be submitted on line in the prescribed BOQ format only. It is suggested to the tenderer carefully the instructions mentioned in the Performa at Form-D / BOQ for quoting the price offer.
- **3.28** The rates are to be quoted in Rupees as per the price format.

3.29 While quoting the price under this part, the tenderer shall specifically confirm that the prices quoted are for the scope of work detailed in technical specification of the tender document.

DEADLINE FOR SUBMISSION OF BIDS:

3.30 The company may extend the deadline for submission of bids by issuing an amendment, in which case all rights and obligations of the company and of the tenderers, which were previously subjected to the original deadline, will then be subjected to the new deadline.

LATE BIDS/DELAYED BIDS:

3.31 No bid will be accepted by the company after the deadline prescribed in NIT due to any reason whatsoever.

OPENING OF THE TENDER:

- 3.32 The Techno-Commercial Bid) of the offer will be opened as per NIT
- **3.33** If the date fixed for opening of tenders happens to be a holiday for any reason, the tenders will be opened on the next working day at the same time.

EXCEPTIONS AND DEVIATIONS:

3.34 Tenderers are advised to submit quotations based on the terms and conditions and specifications contained in the tender document and not to stipulate any deviations. Bids containing stipulations of deviation to the terms and conditions are liable to be ignored. In case, it is absolutely unavoidable to deviate from tender conditions, then the tenderers should mention the deviations at their risk of rejection only in the 'form -C . Deviations mentioned anywhere else in the bid shall be ignored without any consequences.

BID SECURITY/EMD:

- 3.35 The tenderer must pay Earnest Money/Bid Security as per detailed out in NIT in the form of Crossed Demand Draft/Banker's Cheque (having validity of three months) in favour of RSMML and drawn on any Nationalized/Scheduled Bank at Udaipur and attach the same in original with the technical bid of the tenderer, failing which the bid is liable to be rejected. No interest shall be paid by the company on the earnest money so deposited by the tenderer. The earnest money of the tenders whose bid is not found to be acceptable on the basis of pre-qualifying criteria and/or on evaluation of their techno-commercial bids (or disqualified bidders) will be refunded at the earliest. The earnest money of the tenderer, who are technically successful but not awarded the work, shall be refunded after issuance of LOA to successful tenderer and its acceptance by him. The earnest money deposited by the successful tenderer will be refunded after submission of SD if it in form of BG, if EMD in the form of cash then it will be appropriate towards a part of SD but shall stand forfeited if the tenderer fails to furnish security deposit and/or fails to commence the work within stipulated period.
- 3.36 The earnest money of a tenderer shall be forfeited in the following cases;
 - i) If the tenderer withdraws or modifies the offer after submission of the tender within the validity period.

- ii) If the successful tenderer does not submit the prescribed Bank Guarantee (BG) &/ or DD as security deposit within one month of the date of work order/LOA issued in favour of tenderer.
- iii) If the successful tenderer does not execute the agreement, in the prescribed form within one month of the date of work order/LOA issued in favour of tenderer.
- iv) If it is established that the tenderer has submitted any wrong information/ forged documents along with the tender or thereafter.

VALIDITY:

- 3.37 Tender submitted by tenderer shall remain valid for acceptance for a period 120 days, from the date of opening of the tender (Part-I of the offer). An offer with a validity period of less than 120 days is liable to be rejected. The tenderer on its own shall not during the aid period of 120 days or in extended period, cancel and/or withdraw his tender nor shall he make any variation therein. In case of tenderer revoking, canceling, modifying and/or withdrawing his bid during the validity of bid, the earnest money deposited by him along with tender shall stand forfeited & tender will not be considered for further evaluation.
- 3.38 In exceptional circumstances, prior to expiry of the original time limit, the company may request the tenderer to extend period of validity for a specified additional period. The request and the tenderer responses shall be made in writing. A tenderer if agreeing to the request will not be required or permitted to modify his bid.

EVALUTATION OF BIDS AND DETERMINATION OF RESPONSIVENESS:

- **3.39** Prior to the detailed evaluation of Bids, the Company will determine whether each Bid;
 - i) Meets the eligibility criteria;
 - ii) Has been properly signed, dated & sealed;
 - iii) Is accompanied by the required securities; and
 - iv) Is substantially responsive to the requirements of the bidding documents.
- **3.40** A substantially responsive bid is one, which confirms to all the terms, conditions, and pacification of the biding documents without material deviation or reservations. A material deviation or reservation is one:
 - i) Which affects in any substantial way the scope, quality or performance of the work; and /or
 - ii) Which limits in any substantial way, inconsistent with the bidding documents, the company's right or the bidder's obligation under the contract; and /or
 - **iii)** Whose rectification/acceptance would affect unfairly the competitive position of the other bidders presenting substantially responsive bids?

EVALUATION OF TECHNO-COMMERCIAL BID:

3.41 The techno-commercial bids of substantially responsive tenderer will be evaluated from all aspects The RSMML reserves the right to assess the capability and competency of the tenderer based upon the information provided by the tenderer in the techno-commercial bid and the information that may otherwise be available to and/or gathered by the RSMML. The decision of the RSMML as to which tenderer is capable & competent to carry out the work shall be final. The tenderer should,

- therefore, see that he has required level of technical, financial & managerial competence & experience before submitting the tender.
- **3.42** If a bid is not substantially responsive, it may be rejected by the company at its sole discretion.
- 3.43 The tenderer shall be prepared to furnish clarification/information and attend meetings /discussion as required by the company from time to time.
- **3.44** Price bid (Part-II) only of Techno-Commercially accepted tenders shall only be opened.

NEGOTIATIONS:

- 3.45 Negotiation will be conducted with the lowest tenderer only. In case of non-satisfactory achievement in rates from lowest tenderer, RSMML may choose to make a written counter offer to the lowest tenderer & if is not accepted, RSMML may decide to reject & re-invite fresh tender or to make the same counter offer first to the second lowest tenderer, then to the third lowest tenderer & so on in the order of initial bidding & work order be awarded to the tenderer who accepts the counter offer.
- 3.46 In the case, when the quotations given by the tenderer during negotiation is higher than the original quotation of the tenderer, then the tenderer will be bound by the lower rate originally quoted by the tenderer?
- 3.47 In case of negotiations, representatives of the tenderer attending the negotiations must possess written authority from the tenderer to the effect that he is competent to modify/ amend the submitted tender deviations & rates offered by them.

CORRECTION OF ERRORS:

- **3.48** Price Bid (Part–II) of substantially responsive will be checked by the Company for any arithmetical errors. Errors will be corrected by the Company as follows;
 - a) Where there is discrepancy between the amounts in figures and in words, the lower of the two would be taken; and
 - b) Where there is a discrepancy between the unit rate and the line item, total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern; and
 - c) Discrepancy in totaling or carry forward in the amount quoted by the contractor shall be corrected. The tendered sum so corrected and altered shall be substituted for the sum originally tendered and considered for acceptance instead of original sum quoted by the tenderer.
- 3.49 The amount stated in the bid will be adjusted by the company in accordance with the above procedure for the correction of errors and, shall be considered as binding upon the bidder.

PROCESS TO BE CONFIDENTIAL:

3.50 Information, relating to the examination, clarification, evaluation and comparison of bids and recommendations for the award of a contract shall not be disclosed to the bidders or any other person not officially concerned with such process. Any effort by a bidder to influence the company's processing of bids or award decision may result in rejection of his bid.

3.51 The tenderer may note that indulgence in submitting unsolicited offers or submitting unsolicited correspondence after submission of bid is liable to debar him from participating in RSMML tenders.

NOTIFICATION OF AWARD AND SIGNING OF AGREEMENT:

- 3.52 The tenderer, whose bid has been accepted, will be notified of the award by the company, through postal communication or through facsimile confirmed by registered letter/speed post/E-mail/Fax. This letter (hereinafter and in Conditions of Contract called the "Letter of Acceptance") will state the sum unit that the company will pay to the contractor in consideration of the execution and completion of the works by the contractor as prescribed in the contract (hereinafter and in the Contract called "the Contract Price").
- 3.53 The notification of award will constitute the formation of contract. The execution of agreement as per clauses below would be the formalization of agreement that was commenced with the issuance of LOA.

INTERFERENCE WITH PROCUREMENT PROCESS:

- **3.54** In case the bidder;
 - i) Withdraws from the procurement process after opening of financial bid
 - ii) Withdraws from the procurement process after being declared the successful bidder
 - iii) Fails to enter procurement contract after being declared the successful bidder
 - iv) Fails to provide performance security or any other document or security required in terms of the bidder documents after being declared the successful bidder without valid ground.

shall, in addition to the recourse available in the biding documents or the contract be punished under RTPP Act with fine which may extent to fifty Lac rupees or ten percent of the assessed value of procurement, whichever is less.

SIGNING OF THE CONTRACT AGREEMENT:

- 3.55 The successful tenderer shall be required to execute an agreement on non-judicial stamp paper of appropriate value under Indian Stamp Act with the company within 30 days from the date of intimation regarding acceptance of tender, LOA etc. The cost of execution of agreement including non-judicial stamp paper shall be borne by the contractor.
- **3.56** The contract agreement shall consist of
 - (1) an agreement on non-judicial stamp paper of appropriate value,
 - (2) tender document, along with the addend/corrigenda, if any
 - (3) Letter of Acceptance &/or Detailed Letter of Acceptance
 - (4) Agreed variations, if any &
 - (5) any other document as mutually agreed.

RIGHTS OF COMPANY:

- **3.57** The Company reserves the right;
 - i) To reject any or all the tenders, in part or in full, without assigning any reason, there to,
 - ii) Not to accept the lowest tender or assign reasons for not accepting the lowest tender.

- iii) To increase / decrease the quantity and period of contract, without any additional obligation on it.
- iv) Not to carry out any part of work.
- v) To reject the offer, if is established that the tenderer has submitted any wrong / misleading information or forged documents along with offer or thereafter.
- 3.58 The company may exercise any of the above right at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the RSMML's action.

REFUSAL / FAILURE:

3.59 In the event the tenderer, after the issue of communication of acceptance of tender by the company (LOA), fails/refuses to accept the award and/or commence execution of the work as herein before, the tenderer shall be deemed to have abandoned the contract and such an act shall amount to and be construed as the contractor's calculated and willful breach of contract, and in such an event the company shall have full right to claim damages/compensation thereof in addition to the forfeiture of Earnest Money/Security Deposit.

Section- IV GENERAL CONDITIONS OF CONTRACT (GCC)

INTERPRETATION OF CONTRACT DOCUMENT

- 4.1 Except if and to the extent otherwise provided by the contract, the provisions of the general conditions of the contract and special conditions of the contract shall prevail over those of any other documents forming part of the contract.
- 4.2 Several documents forming the contract are to be taken as mutually explanatory. Should there be any discrepancy, inconsistency, error or omission in the contracts or any of the matter may be referred to the Officer-In charge whose decision shall be final and binding.
- 4.3 In case of any inconsistency or contradiction between the provisions of General Conditions of Contract and Special Conditions of Contract, the Special Conditions of Contract shall prevail unless and until provided otherwise.

SECURITY DEPOSIT

- 4.4 The successful tenderer shall furnish a Security Deposit of 10 % of Total contract value to be ascertained on the basis of the contract rate of remuneration payable to the contractor and tendered quantity for the total period of the contract in following manner
 - i. The successful tenderer shall furnish Security Deposit @ 10% of Total contract value through Demand Draft in favour of RSMML, Udaipur / Bank Guarantee, within 30 days of the issuance of such communication of acceptance of tender/LOA, for due fulfillment of all or any of the terms & conditions of the contract. The Bank Guarantee shall be provided only in the approved format of the company from a PSU bank (except SBI) /ICICI/Axis/HDFC Bank having its branch at Udaipur on non-judicial stamp paper of 0.25% of BG value subject to maximum of Rs. 25000/-or on appropriate value under Indian Stamp Act prevailing on the date of issuance of BG. No amendment in this format shall be acceptable to the company. The Bank Guarantee shall be valid for the entire contract and/or extended period, if any, plus a grace period of six months. The Company shall be entitled to encash the same and appropriate the whole of the amount or part thereof against its claims /dues or sums payable as contained herein.
 - ii. The successful tenderer may also opt to furnished SD by Fixed Deposit Receipt (FDR) equivalent to 10% of Total contract value issued from any Public sector bank (except SBI) /ICICI/Axis/HDFC Bank having its Branch office at Udaipur. FDR shall be in the name of RSMML on account of Successful bidder and discharged by him in advance. The accepting authority shall ensure, before accepting the Fixed Deposit Receipt, that the successful bidder furnishes an undertaking from the bank to make payment/premature payment of the Fixed Deposit Receipt on demand to the Company without requirement of consent of the successful bidder. In the event of forfeiture of the security deposit, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit without protesting by the contractor/him"
 - "The successful tenderer at the time of signing of the contract agreement, may submit an option for deduction of security from his each running @ 10% of the amount of the bill. Further, in such case, the amount of bid security of successful bidder may be adjusted in arriving at the amount of the performance security, or refunded if the successful bidder furnishes the full amount of security deposit."

- 4.5 The entire Security Deposit shall be refunded after six months of the expiry of contract, provided the Contractor has fulfilled all contractual obligation and rendered "No claim and No Dues Certificate" to the Company.
- 4.6 The Security Deposit shall be liable to be forfeited wholly or partly at the sole discretion of the Company, should the Contractor either fail to fulfill the contractual obligations or fail to settle in full, his dues to the Company. In case of premature termination of the contract, the Security Deposit will be forfeited and the Company will be at liberty to recover the loss suffered by it from the Contractor.
- 4.7 The Company may deduct from the Security Deposit any sum due and any other sum that may be fixed up by the Company as being the amount of loss or losses or damages suffered by it due to delay in performance and/or non-performance and/or partial performance of any of the terms of the contract.
- 4.8 All compensation or other sums of money payable by the Contractor to the Company or recoveries to be made under the terms of this contract may be deducted from any sums which may be due to the Contractor from the Company on any account and in the event of the such amount being insufficient the Contractor shall within ten days of such shortfall make good in cash, failing which the balance amount shall be recovered by way of invoking the bank guarantee furnished as security.
- 4.9 In the event of bank guarantee amount being insufficient, then the balance recoverable amount shall be deducted from any sum, then due or which at any time thereafter may become due to the contractor. The Contractor shall pay to the company on demand any balance remaining due.
- 4.10 In case the Bank Guarantee is invoked for any reason/s, the contractor is required to furnish a fresh Bank Guarantee in the same format for the same amount and for the same period as the original Bank Guarantee within a period of 30 days from the date of invoking of original Bank Guarantee.
- 4.11 In the event of security amount at any time during the currency of the contract falling short of the specified amount, the Contractor shall forth with make good the deficit on demand, so that the total amounts of Security Deposit will not at any time be less than the amount so specified. The Company may recover the same by way of additional deductions from bills.
- **4.12** No interest is payable on S.D. amount.
- 4.13 In case of enhancement of quantum of work, due to any reason, the contractor shall furnish additional security amount. This security will be recovered from the payment due to the contractor.

PROVIDENT FUND

- 4.14 The contractor shall be wholly responsible for complying with the fulfillment of the provisions of the Employees Provident Fund and Miscellaneous provisions Act, 1952 including subsequent amendments & notifications, in respect of the employees engaged for the work.
- 4.15 The Contractor shall have to get himself registered (if not already registered) with the Regional Provident Fund Commissioner (RPFC) under the Employees Provident

- Fund and Miscellaneous Provisions Act, 1952. Tenderer is required to submit the copy of the PF Registration Number received from RPFC office before starting the work, failing which the contract is liable to be terminated.
- 4.16 The tenderer who are not coming under the purview of EPF & MP Act but are required to deposit the PF due to applicability of Contract Labour (R&A) Act may deposit amount of PF deducted from salaries of the labour/employees and employer's contribution with PF Trust of RSMML along with 1.10% administrative charges. An affidavit (as per Annexure-C) for this purpose will be required to be furnished on a stamp paper of appropriate value with the Techno Commercial (Part -I) of the offer.
- 4.17 However, each running account / Final bill must be submitted alongwith the name of the labour/employee deployed for the work, wages / salaries paid to them, amount of PF deducted from salaries of the labour/employees and employer's contribution, amount deposited in RPFC office/Trust against each employee's name and copy of the challan and ECR for the amount deposited in RPFC office/Trust till previous month, failing which no payment will be made for Running Account bill submitted by the contractor to the Engineer-In-Charge.
- **4.18** Payment due to the contractor shall be made after verifying the copy of ECR & payment challan received from contractor through the EPFO website.

ASSIGNMENT & ADDITIONAL CONTRACTS

4.19 The contractor shall not, at any time, transfer, assign or sublet this contract or any part thereof to any other agency without written consent of the Company. But such consent of the Company, if given shall not relieve the Contractor from any liability or obligation under this contract and the Contractor shall be responsible for all acts, defaults and neglects of the sub-contractor, his agent and employees fully as if those are the Contractor's own acts. The RSMML shall have a right to engage any other contractor for similar or other kind of job as may be deemed necessary by the RSMML.

RECORDS, REGISTERS, ETC.

4.20 The contractor shall maintains all records, registers, details etc., as required by the RSMML and/ or under the various Acts, Enactments, Statutes, Rules, Regulations, etc., as applicable to this contract and make available the same to the RSMML and/or its authorised representative at such place & time as may be directed.

STATUTORY OBLIGATIONS

- 4.21 The RSMML shall be entitled to deduct Income Tax and such other taxes, at source from the bills of the contractor as may be required by any department of State/Central Government or any other Statutory Body.
- 4.22 The contractor shall comply with such terms & conditions as may be imposed by the statutory authorities like the DGMS, DMG, IBM, Environment and pollution Control Board etc., during the period of this contract. The contractor shall not be entitled to any claim for damages that may arise out of imposition of the aforesaid terms & conditions by such statutory authorities.

- 4.23 The Contractor shall comply with all statutory obligations including the provisions of the Mines Act, Labour Laws, Payment of Wages Act, Minimum Wages Act, Provident Fund Act, Gratuity & Bonus Acts, Motor Transport Workers Act, Motor Vehicle Act, Workmen's Compensation Act, Contract Labour (Regulation & Abolition) Act, 1970, RTPP Act or any other act or acts or laws or rules with statutory modifications thereof as are in force or as may be applicable during the currency of this contract. The Contractor shall be responsible to submit/file all or any returns that may be necessary and/or required to be furnished by the Company or by the Contractor to the State or Central Government or any other Government authorities or local authority or body.
- 4.24 The Contractor in whose favor the tender is awarded shall be required to furnish necessary information under Contract Labours (Regulation & Abolition) Act, 1970, Mines Act and Rules & Regulations made there under to the GM (P&A) of the company before starting the work. The Contractor shall obtain license under the above act/s.
- 4.25 The contractor, in addition to the above, shall be wholly responsible and liable to comply with the provisions of the various Acts, statutes, Rules, Regulations, Instructions, Judgments, decisions, as existing and/or may be applicable in respect of the Mines and/or working thereof, during the period of this contract. If due to failure of the contractor to comply with any or all its obligations stipulated herein or elsewhere in these terms and conditions, any liability devolves on the RSMML, then the contractor shall be liable to meet and pay such liability and all costs, expenses, charges, risks etc., shall be recovered immediately from the bills/security money, etc., of the contractor. Non-compliance of this clause by the contractor will also constitute a breach of agreement on the part of the contractor.

4.26 TAXES

- a. The rate quoted by bidder will be exclusive of Good and Service Tax(GST). However the rates will be inclusive of any other levies and duties as applicable on this contract (Up to last date of submission of the bid).
- b. The rates quoted shall be on 'firm price' basis during the pendency of the contract period and the contractor shall not be eligible for any escalation (except as mentioned in the tender document) in the rates on what so ever ground.
- c. Timely deposition of GST and filing of requisite tax returns of relevant period would be the sole responsibility of the contractor. The contractor will also ensure that necessary credit on this account is available to RSMML in the next month. In-case of any discrepancy, where credit is not available to RSMML, then company is free to deduct/recover/retain such amount from the bills of contractor or any other amount due to him/or from security deposit, as the case may be.
- d. In case of reversal of input tax credit (ITC), imposition of penalty on account of payment of GST and default in filing of returns toward the payment for the work, contractor is liable to pay all such dues to the company, failing which RSMML is

- free to deduct/recover/retain such amount from the bills of contractor or any other amount due to him/or from security deposit, as the case may be.
- e. Further, the contractor shall submit an undertaking with monthly bills bearing GSTIN and HSN/SAC code that total GST has been deposited and returns have been filed for relevant tax period.

VARIATION IN STATUTORY TAXES, DUTIES & LEVIES:

- 4.27 Any fresh imposition /withdrawal or variation in statutory duties, taxes or levies made by statutory authorities after the last date of submission of bids, will be reimbursed to contractor or recovered by the Company, as the case may be. The reimbursement to/recovery from the contractor will be made against submission of supporting documents and for only such taxes/duties/levies that are directly applicable to the contract and reflected in his running bills.
- **4.28** The company shall fully entitle to deduct income tax and/or any other levies at sources as per the rules and instructions as may be applicable for this purpose from time to time.

COMPANY NOT LIABLE TO PAY COMPENSATION:

4.29 The Contractor shall have no claim against the Company for any business loss, idle charges compensation upon failure, delay, omission etc. on the part of the Company to carry out any or all the provisions of the contract for any reason whatsoever. The Company's decision in the matter shall be final and binding on the Contractor.

NO CLAIM IF WORK IS ABANDONED OR POSTPONED:

4.30 The Contractor have no claim, whatsoever against the Company if the work or any part thereof covered by the contract is postponed to any later date and/or withdrawn in part in the overall interest of the Company or for security or for any other reason/s. The Company's decision in this regard shall be final and binding on the Contractor.

NO COMPENSATION FOR ALTERATION IN OR RESTRICTION OF WORK:

- 4.31 If at any time after the commencement of the work the company shall for any reason or whatsoever required not to do the whole work or part thereof as specified, to be carried out, the Engineer-in-Charge shall give notice in writing of the fact to the contractor, who shall have no claim to any payment or compensation whatsoever on any account or profit or compensation or advantage/s which he might have derived from the execution of the work in full, but which he did not drive in consequences of the full amount of the work not having been carried out, nor shall have any claim or compensation by reason of any alternations having been made in the original specifications, and instructions which shall involve any curtailment of the work as originally contemplated.
- 4.32 Any modification of the contract required after the same is signed shall be made in writing with mutual consent of both the parties and shall be signed by them. Such amendment shall be deemed as part of the agreement.

LIABILITITES IN RESPECT OF CONTRACTORS ROAD ROLLER, ETC.

- 4.33 The contractor shall be responsible for maintaining and operating the road roller deployed by it for the contracted work in such a way that the road roller operate at full capacity and with due regards to safety and ensure compliance of the applicable statutory rules & regulations.
- 4.34 The contractor shall bear all costs, expenses, etc., that may be incurred on purchase, maintenance, overhauling, running and operating the machines.
- 4.35 If the machines/ equipments deployed by the contractor cause any accident or causes injury or death to any person working the mines or elsewhere or cause any damage to any property, then it will be the responsibility of the contractor to bear all sort of compensation to the person(s) affected or to the heirs of the deceased and pay all costs, damages, compensation, losses etc., occasioned on account of such accident/injury/damage.

LIABILITY FOR ACCIDENT TO PERSONS

4.36 Besides the liabilities of the Contractor under the "Workmen's Compensation Act", Fatal Accident Act, M.V.Act, "Mines Act" the following shall also apply to the Contractor.

On the occurrence of any accident resulting in death or bodily injury to a workman employed by the contractor, the Contractor shall be liable for intimating within 8 (eight) hours of happening of such accident/s in writing to the Engineer-in-Charge the fact of such accident in addition to the Mines Manager. The Contractor shall indemnify the Company, against all claims/compensation, loss or damage sustained by the Company resulting directly or indirectly from his failure to give intimation in the matter aforesaid, including the penalties or fines, if any, payable by the company as consequences of workmen's Compensation Act, Fatal Accident Act, Motor Vehicle Act, Mines Act or otherwise to conform to the provisions of the said Act/s in regard to such accident.

4.37 WAGES:

- i. The Contractor shall furnish copies of wage payments to the Engineer-in-charge on or before 15th of each month in respect of the preceding month and maintain proper records thereof for the aforesaid purpose to the satisfaction of the Engineer-in-charge.
- **ii.** The contractor will make payment to the labour for the paid holidays declared by the Company from time to time.
- iii. The contractor shall have to make all payments through Bank Account of the workers/labourers/staff etc. engaged by him every month latest by the 7th day of the following month or in the presence of the Sr. Manager (P&A) or any other officer who may be nominated by the RSMML and a certificate to that effect shall be obtained by its from such an officer as per requirement of the contract Labours (Regulation & Abolition) Act, 1970. The minimum wages applicable at present are to be followed
- iv. If the contractor fails to pay to the workers/staff/labours any dues, the RSMML may make arrangements for payment thereof after giving 15 day's notice to the

- contractor and deduct the amount along with expenses from its bills and/or from its security or in such other manner as may be deemed fit by the RSMML.
- v. The provisions of Contract (R&A) Act 1970 and Workman Compensation Act 1923, Minimum Wages Act 1948 etc. should be kept in view, while detailing matters like wages, working hours, overtime etc. The Compliance of the provisions of these and other applicable acts and rules made thereof has to be ensured by the Contractor at his own cost.

WAIVER

4.38 Any waiver by Company of any breach of the terms and condition of the contract shall not constitute waiver of any subsequent breach of the same.

FORCE MAJEURE:

4.39 Neither the Contractor nor the Company shall be considered to be in default in the performance of their respective obligations under this contractor if such performance is prevented or delayed because of the conditions constituting force majeure which shall include but not limited notice/s from the Directorate of Mines Safety Office other Statutory Authority, Civil Commotion, Fire accidents, epidemics, War, acts of God or because of any law, order, proclamation or ordinance of any Government or any authority thereof or forced stoppage of mining, sand storms/other causes and for failure of transportation or for any other cause beyond reasonable control of the party affected, provided notice of such cause is given in writing by the party affected within 14 days of the happening of the event. In case it is not possible to serve the said notice within the said period of 14 days then within the shortest possible period. Power cuts/partial power failure/interruption shall not be construed as force majeure for this purpose and the same shall not affect in any way the performance of the Contract. As soon as the cause of force majeure has been removed, the party whose ability to perform its obligation has been affected shall notify the other of such cessation. Should one or both the parties be prevented from fulfilling their contractual obligations by state of force majeure lasting for a continuous period of three months both the parties shall consult each other and decide about the future course of action regarding the contract?

SERVICE OF NOTICE ON CONTRACTOR:

4.40 Any notice hereunder may be served on the Contractor or his/its duly authorised representative at the work site or may be served by registered mail directly to the address furnished by the Contractor. Proof of issue of any such notices shall be conclusive of the fact that the Contractor having been duly informed of all contents therein. The contractor shall furnish to the Company, the name, designation and addresses of his/its authorised agent at the work site and at Udaipur.

SERVICE OF NOTICE AND COMMUNICATION WITH THE COMPANY AND THE OFFICER-IN-CHARGE

4.41 Notice and communication addressed to the Company or the Officer-in-Charge, as the case may be, shall be deemed to have been duly delivered.

- (a) In the case of the Company, if dispatched by registered AD/Speed post to the Company's Group General Manager at Jhamarkotra Mine, Udaipur and copy to authorised representative at the Jhamarkotra Mine, Udaipur, and
- (b) In the case of the Officer In charge, if dispatched or left at or posted to the address of his/its authorised representative, in the case of posting on the day on which they would have reached such address in the ordinary course of business, and in other cases on the day on which they were delivered to or left at such address.
- 4.42 Notice and communication addressed to the Company shall be valid only if duly signed by the Contractor or his duly authorised partner or his principal officer acting for him on his behalf.

TERMINATION:

- 4.43 If the Contractor fails to execute the work or any part thereof with such diligence as will ensure its completion within the time specified in the contract, or extension thereof, or fails to complete the said work within such time or fails to perform any of his obligations under the contract or in any manner commits a breach of any of the provision of the contract, it shall be open to the Company in its option, by written notice to the contractor:-
 - (a)To determine the contract; in which event the contract shall stand terminated and shall cease to be in force and effect on and from the date notified by the company in this behalf, whereupon the contractor shall stop forthwith all or any of the contract work, then in progress and the Company may on its part, may take over the work remaining incomplete by the Contractor and the contractor and his sureties if any, shall be liable to the company for any excess cost occasioned by such take over and completion by the Company or by appointing any other agency over and above the rates of remuneration payable under the contract.
 - (b) Without determining the contract, to take over the work of the Contractor or any part thereof and complete the same through any other agency at the risk and cost of the Contractor and the Contractor, and his sureties shall be liable to the company for any excess cost/additional cost occasioned by such work having been so taken over and completed by the Company and/or through any other agency over and above the remuneration payable under the contract.
- 4.44 Before determining the contract, as aforesaid, and provided that, in the judgement of the company the default or defaults committed by the Contractor is or are curable or may be cured by the Contractor if any opportunity is given to him to do so, the Company may, by notice, in writing, call upon the Contractor to cure the default within such time as may be specified in the notice.

In the event of the Company proceeding in the manner herein above prescribed-

- (a) The whole of the Security Deposit furnished by the Contractor or retained by the Company shall be liable to be forfeited, without prejudice to the right of the Company to recover from the Contractor, the excess cost referred to aforesaid.
- (b) The money that may have become due to the Contractor on account of work executed by him/its already shall not be payable to him/its until after the expiry of six calendar months reckoned from the date of determination of contract or from the taking over of the work or part thereof by the company as the case may be, during which period the responsibility for faulty execution of work, under the contract rest exclusively with the Contractor and shall be subject to deduction of all amounts due from the Company to the Contractor, whether under the terms of the contract or otherwise, authorised or required to be recovered or retained by the Company.
- 4.45 The Company shall also have the right to proceed in the manner prescribed in subclauses above, in the event of the contractor abandoning the execution of the contract work for a continuous period of one month, or becoming bankrupt or insolvent, or compounding with his creditors or assignees the contract in favour of his creditors or any other person or persons, or being a firm or a corporation goes, into voluntary liquidation, provided that in the said event, it shall not be necessary for the Company to give any prior notice to the Contractor.
- 4.46 Termination of the contract as aforesaid shall not prejudice or affect the rights of the Company which may have accrued up to the date of such termination.

APPEALS:

4.47 Subject to section 40, of Rajasthan Transparency in Public procurement Rules 2013, if any bidder or prospective bidder is aggrieved that any decision, action or omission of the procuring entity is in contravention to the provision of this act or the rules or guidelines issued there under, he may file an appeal to designated First and Second Appellate Authority with in a period of ten days from the date of such decision or action, omission as the case may be clearly giving the specific ground on which he feel aggrieved on the form no. 1 (see rule 83) –Memorandum of Appeal under the Rajasthan Transparency in public procurement Act -2013 with prescribed fees.

DISPUTE, JURISDICTION

- 4.48 The place of the contract shall be Udaipur, Rajasthan. In cases of any differences, the same shall be resolved by mutual discussions and agreement. However the decision of the company shall be final and binding.
- 4.49 No courts other than the courts located at Udaipur, Rajasthan shall have jurisdiction over any matter concerning any aspect of the work under this tender.
- **4.50** The contractor shall not stop or abandon the work due to and during the pendency of such disputes or differences.

Section-V

Special Conditions of Contract (SCC)

APPLICABILITY

5.0 These terms and conditions are in addition to the General terms & conditions specified in earlier Sections of this tender document. These special terms & conditions as detailed in this section in the following clauses shall prevail upon the General terms & conditions, should there be any discrepancy or conflict or contradiction between the two.

Chapter 1 - SCC

Special Instructions for the Tenderers

5.1 BRIEF DESCRIPTION OF PLACE & WORK:

- a) Jhamarkotra Rock Phosphate Mine located near village Jhamarkotra, Tehsil Girwa in Udaipur District, Rajasthan is being worked by M/s Rajasthan State Mines and Minerals Limited (A Government of Rajasthan Enterprise). Jhamarkotra Mines is situated at an approximate distance of 27 Kms from the town of Udaipur in Rajasthan.
- b) Mining operation at mine is being carried out by mechanized opencast method. Dumper of 85 tonnes payload capacity (max) ply on mine haulage roads, ramps etc. Departmental operation is being carried out in D & E block. Interconnection of various benches at different levels is through the ramps of gradient around 1 in 16. New ramps are prepared wherever new benches are opened for going to deeper horizons. All access roads made and used for movement of drill machines, for dewatering pumps utility vehicles and for all other ancillary activities also cover under name of Mines Haulage Road(MHR)
- c) Haul roads and ramps are kept free from the lumps/boulders/potholes and other undulations/bumps etc. for smooth mining operation.

5.2 PREQUALIFICATION CRITERIA:

The tenders shall be pre-qualified on the basis of the following criteria:

i) The tenderer should have minimum turnover of Rs.19.70 Lacs in any one of the immediate preceding three financial year's i.e.2017-18, 2018-19 & 2019-20 in its own name.

The tenderer should submit duly attested copy of Audited Balance Sheet, CA certificate & Profit & Loss account in support of turnover.

Tender is to be submitted online at https://eproc.rajasthan.gov.in electronic form as prescribed in the tender. The tender fees & processing fees will not be refunded in any case.

The bidder should go through the website https://eproc.rajasthan.gov.in& the link "help for contractors "," information about DSC", FAQs & the bidder manual kit " to know the process for submitting the electronic bids at website. The complete bid document has been published on the website www.rsmm.com / eproc.rajasthan.gov.in& on sppp.raj.nic.in for the purpose of downloading.

The uploaded bid document shall be considered valid for participation in the bid process subject to submission of required cost of tender document, e-Tendering processing fee, EMD etc. & the same shall be reached to the office of undersigned on or before the time specified for online submission of tender.

The tender shall be pre-qualified on the basis of documents furnished/uploaded along with Technocommercial bid in support of above. The decision of the company will be final and binding in this regard. The company reserves its right to call for any additional information so as to check the eligibility of the tenderer.

The tenderer has to deploy the requisite make & model of the equipment required to perform the entire scope of work & compliance of the terms & conditions of tender thereof & to achieve the production target, as given by the company from time to time.

The price bid of only those bidders shall be opened who qualify in technical bid as per criteria laid in tender & only qualified bidders will be informed about price opening.

Offers furnished through any other mode shall not be considered. The Company reserves the right to accept or reject/cancel any or all offers without assigning any reason whatsoever. Also the company does not bind itself to accept the lowest price offer. The Company shall not be responsible for any postal delay or loss of offer.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified, if it is established that tenderer has:

- a. made misleading or false representation in the form(s), statement(s) and attachment(s) submitted in proof of the pre-qualification requirements; and/or
- b. it is established from our records that the tenderer has poor performance by way of abandoning the works, not completing the contract properly, inordinate delays in completion, or financial failures etc.

5.3 EVALUATION OF PRICE BID & CRITERIA FOR DECIDING L-1

The price bids of the techno-commercially qualified tenderers will be evaluated to determine the lowest bidder. The tenderer with the lowest quoted rate for providing road roller and manpower etc. shall be decided as the successful tenderer i.e. L-1 tenderer.

5.4 ARRANGEMENT FOR DIESEL

The Contractor has to make its own arrangements for diesel procurement.

5.5 LAND FOR CONTRACT'S FIELD OFFICE

- i. The company shall at its own discretion and convenience and duration of the execution of the work shall make available land for temporary construction of contractor's field office, maintenance workshop etc. The contractor shall at his/its own cost construct all such temporary structures or buildings with suitable water supply, electricity and sanitary provisions etc. in the place/s and as per the plan/s approved by the Engineer in charge.
- ii. On completion of the entire contract work undertaken by the contractor such temporary structure/s etc. shall be removed by the contractor at his/its cost and site cleared as per the directions of the Engineer in charge. If the contractor fail to comply with such directions, the Engineer in charge may at the expense/s of the contractor, will get removed all such works and dispose off the same in such manner as he deems fit and get the site cleared. In such event the contractor shall have no claim whatsoever in respect thereof.
- iii. The company reserves the right to ask the contractor at any time during the pendency of the contract to vacate the land, site, temporary buildings etc. by giving seven days notice on security reasons or on material interest by providing alternative site. The company reserves the right to take over the said temporary structures/buildings in lieu of reasonable compensation.

5.6 DETAILS TO BE FURNISHED AT THE TIME OF COMMENCEMENT OF WORK

Following details are required to be furnished by the successful tenderer to the Officer-Incharge at the time of commencement of work at mines;

- i) Attested copy of Letter of Acceptance for the work.
- ii) Details of the personnel who will be engaged for execution of the work & their bank details
- iii) Details of vehicle along with its technical specification/purchase invoices/Registration Certificates/insurance.

5.7 REPORTS

The contactor shall furnish the statement of work done by him in the form of report(s), in the format prescribed by the Officer-In-Charge, on daily basis and/or at specified intervals by the company, to the Officer-In-Charge or to his authorized representative

Chapter 2 - SCC Scope of Work

SCOPE OF WORK

- **5.2.1** Scope of work for "Repairing and Maintenance of Mine Haulage Road(MHR) through diesel operated 8-10 tonnes Road Roller along with Operator and average fifteen (15) Labours at Jhamarkotra Rock Phosphate Mine, Udaipur (Rajasthan)" generally shall include but not limited to the followings:
 - i) Operation of diesel operated 8-10 tonne road roller on the different mine haulage roads/ramps etc. as per the directives of Engineer-In-Charge.
 - ii) Deployment of average 15 No. (fifteen) labours per day with all necessary tools and tackles, up to the satisfaction of the Engineer-In-Charge for
 - a) Cutting, lifting, transporting, unloading of the suitable filling material and levelling thereof to repair the Mine Haulage road/ramps (MHR).
 - b) Arrange to unload the fine over burden by dumpers and spread it for road repairs and engage roller for its compaction.
 - c) Removing the lumps of rock form the MHR and make it clear from such obstructions which cause the cut on the tyre of HEMM plying over there.
 - d) Removing lumps of rock from haul roads generated during operation of road repairing machines like graders/dozers etc.
 - e) Other road repair works as instructed from time to time.
 - f) Cutting and trimming of babool bushes and other vegetation grown along haul roads which obstruct clear visibility on haul roads.
 - g) Preparing drains in haul roads to drain the rain/accumulated water to keep haul roads dry.
 - iii) Out of total average 15(fifteen) labours, required number of labours may deputed in production shifts A/B/C for purpose of road repairs and picking up lumps/boulders which may cause damages to tyres of vehicles plying on Haul Roads of mines.
 - iv) Such labours deputed in production shifts will perform their work under direction and control of concern shift in charge, who will verify their attendance.
 - v) Out of total average 15(fifteen), required number of labourers may also engaged for cutting, trimming of bushes and trees along other transport roads within Jhamarkotra Mines premise with tool and tackles as and when so required.
 - vi) Contractor shall make its own arrangement for water near different working sites.
 - vii) All incidental and contingency work associated with above specified scope of work, including deployment of additional manpower whenever required and as per the direction of Engineer-In-Charge, shall be carried-out by the contractor at its own cost.

5.2.2 Special Conditions:

- The Contractor shall carry out the work in General shift or any other notified shift of eight hours in day light hours between 6:00AM to 7:00 PM, on all working days other than the weekly day of rest, i.e. MONDAY and other holidays declared by the Company, except some of labours which were deputed in production shifts as mentioned in tender.
- b) Contractor shall deploy and operate diesel operated road roller so as to ensure average working of minimum six hour per day.

- c) Road Roller deployed by contractor should be equipped with hour meter shows engine running hours of Road Roller for the purpose of recording actual working hours of Road Roller.
- d) In addition to operator of road roller, contractor has to deploy average 15 nos. of unskilled labours per day including labours deputed in production shifts as mentioned in tender for the road repairing and maintenance work of MHR, along with the requisite tools and tackles.
- e) Average of daily working of road roller and number labours deployed as above will be computed on monthly basis.
- f) Contractor shall ensure deployment of additional manpower whenever require to meet out the contingency work.
- g) In case of emergency, the contractor may be asked to work on Monday(s) or on Holiday(s) without any additional financial implication to the company.
- h) The work shall be carried out strictly as per the directives of Engineer-In-Charge or his authorized representative.
- i) At the time of blasting all labourers including operator should vacate the danger zone of blasting and road roller should also be shifted to safety distance.
- j) Departmental mechanized mining operation is to be there in the nearby faces, in such circumstances safety of the men and machine of the contractor shall be the responsibility of the contractor.
- k) There may operation of other heavey dumpers and other machinery on haul roads, so contractor should take due care in operation of road roller and working of labours. Safety of the men and machine of contractor shall be the responsibility of contractor.
- 1) Contractor shall ensure that road roller should not cause any hindrance to the departmental mining operation.
- m) Contractor should be remain in touch with the Engineer-In-Charge for ensuring safe working.
- n) All labourers and operator should undergo vocational training at VTC of Jhamarkotra Mines as per VT Rules. Company will impart training to the labours but the payment of wages for that training period shall be borne by the contractor.
- o) Before the deployment of labours into the mines they have to undergo medical examination as per provisions of Mines Rules and cost of such examination shall be borne by the contractor.

RESOURCES, MANPOWER, FACILITIES, ETC.

- **5.2.3** The contractor will have to bring and deploy requisite machinery, labourers, tools, tackles, equipment, etc., required to execute the contract at its own cost and to the entire satisfaction of the RSMML.
- **5.2.4** The contractor shall make its own arrangements at its own cost for facilities like fuel, lubricants, water, and diesel etc., required for satisfactory execution of the contract.

INCIDENTAL & CONTINGENT WORKS

5.2.5 The contractor will have to make its own arrangements for all incidentals or contingent works including deployment of additional manpower whenever required and as per the direction of Engineer-In-Charge, related to the contracted work at its own cost & expenses and the same would not qualify for any extra payment.

EMPLOYMENT OF MANPOWER AND THEIR CONDUCT

- 5.2.6 The labours/operator etc., required for execution of the contractual work will be employed by the contractor and he will be wholly responsible to bear all wages, emoluments, charges and for discharge of all other legal obligations including all compensations payable under the workmen's compensation Act, 1923 in respect thereof. The RSMML will not, in any manner and at any time or at the termination of this contract, be responsible to bear any liability or part thereof in respect of the labours/ labours/operator etc., to be engaged by the contractor for the contracted work.
- **5.2.7** Contractor shall not be allowed to engage Juvenile and Females for this work.
- 5.2.8 The Contractor shall be responsible for the proper conduct and behaviour of all the labours/ labours/operator and others and shall exercise a proper degree of control over them and in particular and without prejudice to the aforesaid generally the Contractor shall be bound to prohibit and prevent any employees from trespassing or acting any way detrimental or prejudicial to the interest of the community or of the properties or occupiers of lands and properties in the neighbourhood and in the event of such employee so trespassing, the Contractor shall be responsible thereof and relieve the Company of all consequent claims or actions for damages or injury or any other grounds, whatsoever.

MISCELLANEOUS LIABILITIES

- 5.2.9 The contractor shall be responsible for making all arrangements at its cost and expenses for:
 - i. Tools, equipments, machinery and any other requirement for accomplishing the work satisfactorily.
 - ii. Drinking water for the staff/labour/workers etc at the working site.
 - iii. Safety and discipline of the labours/workers/ staff employed.
 - iv. Providing safety boots, dust masks and other protective equipment's as may be/ are required under the law and as may be directed by the RSMML from time to time, to the labourers/workers/ staff etc deployed at work site.
- 5.2.1.10 The RSMML shall not in any manner be responsible for any or part of the above obligations of the contractor. If any expenditure is incurred by the RSMML on the above items that will be recovered from the contractor's bills/security deposit.
- 5.2.1.11 The entire responsibility on account of accident/damage or personal injury which may occur to Contractor's equipment/appliances or his employees shall be exclusively borne by the Contractor and no claim whatsoever shall be entertained by the Company on this account.

Insurance:

5.2.1.12 Insurance of the Road Roller and persons engaged by him will be the contractor's responsibility. The contractor is required to take Workmen compensation policy or any other better insurance policy for persons employed by him at his own cost and renewed it from time to time to cover entire contract period. Contractor also required taking insurance policy for road roller as required under MV Act. The insurance policy is to cover the claims towards the injury caused to the persons & property of the company or to injury to any third persons/property.

Chapter 3 – SCC

PERIOD OF CONTRACT, QUANTUM OF WORK, COMPENSATION FOR FAILURE TO COMMENCE THE WORK AND/OR DELAYED OPERATION ETC.

PERIOD OF CONTRACT

- **5.3.1** The period of contract for the work envisaged under this tender shall be Two years from the date of issuance of Letter of Acceptance. The company may extend the period of contract for 1 year on the same rate terms & conditions at its sole discretion in line with the provision of RTPP Act.
- 5.3.2 The period of contract shall commence from the date issuance of letter of acceptance /Detailed Letter of Acceptance. The Contractor shall commence the work within a period of 15 days from the date of issue of LOA/DLOA; this period shall be termed as Mobilization Period. The work shall be executed strictly as per time schedule by deploying adequate personnel, equipment, tools, tackles etc.
- **5.3.3** However, the company reserves the right of termination of contract at any time without assigning any reason by giving a clear notice of thirty days. Such termination shall not entitle the contractor for any claim whatsoever.

OUANTUM OF WORK

5.3.4 Contractor shall execute the work of Repairing and Maintenance of Mine Haulage Road through Diesel Operated 8-10 Tonne Road Roller along with operator and Average fifteen(15) Labours at Jhamarkotra Rock Phosphate Mine as specify in chapter – 2 SCC Scope of work.

FAILURE, COMPENSATION AND PREDETERMINED COMPENSATION

5.3.5 For Delay in commencement:

In case the Contractor fails to commence the work within 15 days from the date of issuance of LOA/DLOA, the company shall recover a pre determined and agreed compensation @ 0.5% of the total contract value on weekly basis from the contractor if the delay is on account of contractor. In the event the compensation exceeds 2% of contract value, then other provisions of tender including termination of contract, forfeiture of EMD/SD, withdrawal of DLOA shall apply at sole discretion of Company.

- **5.3.6** If the contractor is unable to do the job as per the requirement, terms and conditions or fails to complete the contract due to any reason, the company will get the work done, in full or its part thereof, from any other agency at the risk and cost of the contractor. The Contractor and his sureties shall be liable to the company for any excess cost/additional cost occasioned by such work having been so taken over and completed by the Company and/or through any other agency over and above the cost at the rates specified in the schedule of quantities and rates.
- **5.3.7** Besides getting the work done from any other agency as mentioned above, contractor is also liable to pay the predetermined compensation as dealt hereunder.
- **5.3.8** If the contractor fails to-
 - **A.** Operate road roller for the average working hours of six (6) hours in a day that is to be computed on monthly basis, the Contractor shall be liable to pay predetermined compensation to the company at the rate of Rs. 600/- per hour for

such shortfall. Calculation for such shortfall shall be on monthly basis, an example is cited hereunder.

For e.g.

Say there are 25 working days in a month.

Then minimum working hours to be worked by road roller in mine for work, in a month shall be $25 \times 6=150$ hours

If the actual working hours of road roller in mine in that month is less than 150 hours and is, say, 130 Hours,

Then compensation will be Rs. $(150-130) \times 600 = 12000/$ -.for that month

Contractor shall not be allowed to make good the shortfall of one month in another month.

B. Deploy average 15 labours per day, which is to be computed on monthly basis, the Contractor shall be liable to pay predetermined compensation to the company at the rate of Rs. 600/- per man day for such shortfall. Calculation for such shortfall shall be on calculated on monthly basis, an example is cited hereunder.

For e.g.

Say there are 25 working days in a month

then minimum man days to be worked in mine, in that month

shall be 25 X 15=375 man days/month

If the actual man days provided by the contractor in that month is less than 375 and, say350 man days in that month

Then compensation will be Rs. (375-350) X 600 = 15000/-.for that month Contractor shall not be allowed to make good the shortfall of one month in another month

- **5.3.9** Besides, failure of the contractor to work as per scheduled targets will also entitle the Company to get the work done by making alternative arrangements at the cost and expense of the contractor and to recover from it the full difference of cost in making restoration of working up to the quantity of work allotted to the another agency.
- **5.3.10** However, compensation for shortfalls in the contractual targets could be reduced or waived off if adequate justification or grounds exist for such a reduction or waiver based on the written request by the contractor for the same. Further if concerned Engineer In charge clarifies that any such shortfall is due to the reasons beyond the control of contactor, predetermined compensation as above would not be imposed.
- **5.3.11** The compensation, if levied, shall be recovered immediately from the bills of the contractor.
 - a) The contractor shall be liable to pay to the RSMML all costs, damage, charges, losses, etc., suffered or incurred or occasioned or sustained by the RSMML or

- by any other third party due to the negligent act or omission or un-workmen like performance of the contractor or its workmen or due to the breach of any of the terms of the contract or failure to carry out the work in accordance with contract by the contractor or its workmen. The decision of the RSMML in this respect shall be final and binding on the contractor. The recovery for any amount under this clause may be affected by the RSMML either from the running bills or from the security deposit or set off against any other dues of the contractor, or by reference to an arbitrator, at the discretion of the RSMML.
- b) The contractor shall make such satisfaction and pay compensation as may be assessed by a lawful authority in accordance with the law enforced on the subject for all damages, injury or disturbances which may be done by the contractor and shall indemnify and keep indemnified fully and completely, the RSMML against all claims which may be made by any person or persons in respect of any such damages, injury or disturbances and all cost and expenses in connection therewith.
- c) Any amount due and payable to the contractor, including security deposit refundable to them under the contract, may be appropriated and set off by the RSMML against any claim or dues of the RSMML arisen or arising out of this contract or any other contract against the contractor.
- **5.3.12** The compensation so paid/and/or adjusted by the company shall not relieve the contractor from his/its obligations to complete the work under the contract or from any other obligations and liabilities under the contract.

RIGHT TO REVIEW PERFORMANCE

- **5.3.13** The company reserves the right to review and assess the performance of the work at any time during the contract period. In case of poor or unsatisfactory performance and/or breach of any terms and conditions of the contract, the company in its absolute rights and discretion may take appropriate action including termination of the contract.
- **5.3.14** The company shall have absolute right to determine and ascertain the damages or losses suffered by it due to poor performance or breach of the terms and recover the costs thereof from the contractor from the security deposit or any sum due to the contractor from the company. The Company shall also have absolute right to get the work done from any other agency at the risk and cost of the Contractor, in case, the contractor fails to perform the work continuously for more than 2 days.

Chapter 4 – SCC Payments to the Contractor

RATE OF REMUNERATION & PRICE VARIATION

- **5.4.1** The Contractor, in lieu of the services rendered for the work under Scope of Work and in view of terms and conditions mentioned herein, shall be entitled to remuneration. Accepted monthly rate shall be considered as the rate for remuneration to the contractor.

- **5.4.5** No exemption or reduction of customs duties, excise duties, sales tax, service tax or any port duties, special Road Tax, Road tax, transport charges, stamp duties or Central or State Government or local body or Municipal taxes or duties, cess taxes or charges (from or any other body), whatsoever will be granted or obtained element of all of which expenses shall be deemed to be included in and covered by the contract rate or schedule of rate. The Contractor shall also obtain and pay for all permits or other privileges necessary to complete the work.

Any person participating in a procurement process shall:

- (a) Not offer any bribe, reward or gift or any material benefit either directly or indirectly in exchange for an unfair advantage in procurement process or to otherwise influence the procurement process.
- (b) Not misrepresent or omit that misleads or attempts to mislead so as to obtain a financial or other benefit or avoid an obligation.

(1) Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued thereunder, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

- (2) The officer to whom an appeal is filed under para (1) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it of within thirty days from the date of appeal.
- (3) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

(4) Appeal not to lie in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) Determination of need of procumbent;
- (b) Provisions limiting participation of bidders in the bid process;
- (c) The decision of whether or not to enter into negotiations:
- (d) Cancellation of a procurement process;
- (e) Applicability of the provisions of confidentiality.

(5) Form of Appeal

- (a) An appeal under para (1) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.
- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorized representative.

(6) Fee for filing appeal

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of Scheduled Bank in India payable in the name of Appellate Authority concerned.

(7) Procedure for disposal of appeal

- (a) The first Appellate Authority or Second Appellate Authority as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and document, if any, to the respondents and fix date of hearing.
- (b) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall:-
 - (i) hear all the parties to appeal present before him; and
 - (ii) peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- (d) The order passed under sub-clause(c) above shall also be placed on the State Public Procurement Portal.

Additional Conditions of Contract

1. Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.
- ii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

2. Procuring Entity's Right to Vary Quantities

- (i) At the time of award of contract, the quantity of Goods, works or services originally specified in the Bidding Document may be increased or decreased by a specified percentage, but such increase or decrease shall not exceed twenty percent, of the quantity specified in the Bidding Document. It shall be without any change in the unit prices or other terms and conditions of the Bid and the conditions of contract.
- (ii) If the Procuring Entity does not procure any subject matter of procurement or procures less than the quantity specified in the Bidding Document due to change in circumstances, the Bidder shall not be entitled for any claim or compensation except otherwise provided in the Conditions of Contract.
- (iii)In case of procurement of Goods or services, additional quantity may be procured by placing a repeat order on the rates and conditions of the original order. However, the additional quantity shall not be more than 50% of the value of Goods of the original contract and shall be within one month from the date of expiry of last supply. If the Supplier fails to do so, the Procuring Entity shall be free to arrange for the balance supply by limited Bidding or otherwise and the extra cost incurred shall be recovered from the supplier.
