LIMITED ENQUIRY TENDER DOCUMENT

GENERAL, SCOPE OF WORK, TERMS AND CONDITIONS

General:-

Jhamri Dam is located at a distance of about 40 kilometres from Udaipur besides a way from Udaipur to Jagat. Jhamri dam is a secured property of RSMML.

At present, very dense wild vegetation has grown up all over the area in side Jhamri Dam. Also, heaps of shredded leaves and cow dung is scattered all over the area causing smell and unpleasant environment. The external road leading to Jhamri dam has also shrunk due to wild vegetation grown over the berm, which needs to be removed

Objective of this work is to get the area cleaned and cutting of wild vegetation all over the area including edges of inside roads and walkable approach to dam body from over the hill. Also, moving of lawns is essentially required so as to create an acceptable environment for visitors of Jhamri Dam.

Scope of work:-

- 1. Cutting of unwanted bushes all along both side of the approach road to Jhamri Dam (from approx. 1 km before Jhamri Dam gate) and from Jhamri dam gate to the Dam body.
- 2. Bushes along road should be cleaned to such extent so as to provide clear vision to the motor vehicle driver. Preferably and to the extent possible these unwanted bushes should be uprooted.
- 3. Mowing of grass lawns. Grass lawns near Jhamri Dam guest house as well as the gardens at/near fish gardens are to be mowed with grass mower.
- 4. Branches of all the planted plants are to be pruned off evenly.
- 5. All the walkable portion such as lawns, walking pathways etc, should be cleaned off of the organic waste such as heaps of shredded leaves, wild fruits, cow dung, animal/bird's excreta etc.
- 6. All the deposited dust/waste should be removed from all paved area such as interlocking blocks, stone paved walkways & steps, wall copings, roads etc. so as to provide drainage to the flowing water in case of rain,
- 7. Cleaning of fish fountain.

- 8. Bush cutting along the pathway over the hill up to the Jhamri Dam body from fish garden.
- 9. Arrangement of all labour.
- 10. Arrangement of all tools-tackles for cleaning, handling and disposal of rubbish, cutting/trimming/pruning etc. of bushes and plants.
- 11. Arrangement of lawn mower and any other power equipment required for work.
- 12. Contractor has to deploy a JCB whenever and wherever, it is required to do so to get faster results in this limited time.

Time Schedule:
