- 2.2 The qualified Bidder as per the prequalification criteria who has offered lowest price in Annexure-D will be considered as successful bidder.
- 2.3 In case, Negotiation is required, then it will conducted with the lowest Bidder only.

3) <u>Prequalification Criteria</u>

- 3.1 Bidder should not have been blacklisted by any Government organization. An undertaking in this regard is to be submitted by the bidder.
- 3.2 Bidder should enclose copies of Pan Number and GST number. In case the bidder is not having GST Registration no. then an undertaking is to be furnished.
- 3.3 Bidder has to sign & submit a duplicate copy of this document as a token of acceptance of the terms & conditions of this limited tender.
- 3.4 Bidder should enclose copy of purchase orders in evidence of clientele served for similar work.
