- 1) The Tenderer should have successfully executed at least one similar nature work of in value not less than Rs. 1.25 lacs in any one of the immediate preceding three financial years i.e. 2021-22, 2022-23 & 2023-24 in tenderer's name. Attested Copy of CA audited Balance Sheets and Profit & Loss Account/ TDS Certificate/Form-16 in support of turn over.

The tender shall be pre-qualified on the basis of documents furnished along with Techno-commercial bid, duly attested copy of audited balance sheet for the last three preceding financial year's 2021-22, 2022-23 & 2023-24 in support of turnover. The decision of the company will be final and binding in this regard.

It is to be noted that, in case of Company registered under Companies Act, turnover of the Company shall only be considered. The Company reserves its right to call for any additional information so as to check the eligibility of the tenderer.

Joint ventures/consortium/partnership are allowed to participate in this tender subject to the joint/several responsibility, in such cases the cumulative turnover of partners/members will be considered.

The price bid of only those bidders shall be opened who qualify in technical bid as per criteria laid in tender & only qualified bidders will be informed about price bid opening.

The tenderer who have been suspended/ banned by the company shall not be eligible to participate in this tender during the currency of suspension/banned period.

Offers furnished through any other mode shall not be considered. RSMML will not entertain any claim on account of postal delay/non-receipt. It also reserves the right to reject/cancel any or all tenders without assigning any reason whatsoever.

## **SECTION – I**

### **DEFINITIONS, INTERPRETATIONS**

**DEFINITIONS:** In the contract (as hereinafter defined) the following words and expression shall have the meaning hereby assigned to them, except where the context otherwise requires:

1. **"Agent"** shall mean the Agent for Giral Lignite Mines so notified by the company in this behalf.
2. **"Alteration/Variation order"** means, any order given in writing by the Engineer-In-Charge to the Contractor from time to time to affect Alteration/Variation from given Scope of Work. Such an order will be without any financial implication to the Company.
3. **"Approved"** shall mean approved in writing by the Company/Engineer-In-Charge.
4. **"Appointing Authority,"** wherever the expression is used shall mean the Managing Director of the Company.
5. **"RSMML"** or **"COMPANY"** shall mean "Rajasthan State Mines & Minerals Limited," having its registered office at C-89/90, Janpath, Lal Kothi Scheme Jaipur (Rajasthan) and Corporate Office at 4, Meera Marg, Udaipur (Rajasthan) including its successors and assignees or its representatives authorized to act on its behalf for the purpose of contract.
6. **"Contract Document"** shall mean collectively drawings, plans, specifications, agreed variations, if any and other documents constituting the tender and acceptance thereof.
7. **"Contractor"** shall mean the person or persons, firm or company, who's tender, has been accepted by the Company and shall include his/its/their legal representatives, administrators, successors and executors.
8. **"Contract"** shall mean the agreement between the Company and the Contractor for execution of the work/s including therein all documents such as invitation to tender, instructions to Contractor, general conditions of contract, special conditions of contract, job specification, general requirements, time schedule for completion of work, drawings, letter of acceptance /telegram awarding the work, alteration/variation order, agreed variations, if any etc. Any subsequent changes made in any of these documents, would be deemed to be a part of the Contract.
9. **"Completion Certificate"** shall mean the certificate to be issued by the Engineer-in-Charge when the work/s has/have been completed to his satisfaction as per terms of the contract.
10. **"Contract Rate"** or **"Schedule Rate"** or **"Tendered Rates"** or **"Rate of remuneration"** means rate entered in figures and words in schedule/s by the Contractor and accepted by the Company as payable to the Contractor for execution /performance of all contractual obligations.
11. **"Commencement of work"** shall be reckoned from the date of issue of letter of acceptance including the stipulated mobilization period.
12. **"Engineer-in-Charge"** shall mean the Officer so designated for the overall supervision, coordination, direction and administration of the contract

work from time to time by the Company and shall also include the Head of SBU & PC – Lignite.

13. **“Managing Director/Management”** shall mean the Managing Director of Rajasthan State Mines and Minerals Limited.
14. **“General Manager (contract)”** shall mean the Group General Manager (Contract) of RSMML or his successor in the office so designated by the Company.
15. **“Head of SBU & PC – Lignite”** shall mean Group General Manager for the SBU & PC – Lignite of RSMML or his successor in the office so designated by the Company.
16. **“Mines Manager”** shall mean the Mining Engineer so designated under Mines Act, 1952 for different Lignite Mines of the Lignite Division of Rajasthan State Mines and Minerals Limited.
17. **“Letter of Acceptance”** shall mean intimation by a letter/telegram to Contractor that his/its tender has been accepted, in accordance with the provision contained in the letter/telegram.
18. **“Mines”** shall mean Kasnau Kasnau-Matasukh Lignite Mines of the Company under SBU & PC Lignite situated in the district of Nagaur.
19. **“Notice in writing or written notice”** shall mean a notice written, typed or printed sent (unless delivered personally or otherwise proved to have been received) by registered post to the last known business address or registered/Head/local office of the addressee and shall be deemed to have been received in the ordinary course of post.
20. **“Site”** shall mean the land or other place on, under, in or through which the work/s are to be carried out and other land or place or area/s provided by the Company for the execution of the contract.
21. **“Specifications”** shall mean directions, various technical specifications, provisions and requirements attached to and referred to in the contract, which pertain to the method and manner of performing the work/s and the materials to be furnished /used required to be used/consumed and/or provided for executing work/s as may be amplified or modified by the Company or the Engineer-in-Charge from time to time and notified/communicated to the Contractor during the course of performance of this contract and provide for the unforeseen conditions or in the best interest of the work/s. It shall also include the latest addition including all agenda or corrigenda or relevant rules, regulations, regulation codes.
22. **“Tender”** shall mean the offer submitted by the Contractor against this inquiry for acceptance by the Company.
23. **“Temporary Works”** shall mean and include all temporary work/s of every kind for the execution of the main work as incidental and ancillary thereto.

## SECTION - II

### Instructions to the Tenderer & General Conditions

#### 1. Scope of Work

The scope of work of “Annual Maintenance Contract for operation of Nimbla Tube well at Giral Lignite Project, Barmer” is as under:-

- a) Tenderer shall have to deploy a qualified person at Nimbla Tube well, who will operate the tube well for sufficient supply of water at Mines on daily basis.
- b) Tenderer shall ensure that the patrolling of pipelines from Nimbla to Giral mines (10-12KM) at site on daily basis to attend leakages of pipelines.
- c) The consumable items as per **Annexure-I** i.e CI Joints, Nut-bolts, rubber mats, O rings, all type valves and PVC pipes shall be arranged by the contractor.  
*The fixed nature of items like Submersible pump, Star-Delta Starter , Flat 3-Core cable and Booster pump shall be provided by the RSMML in case of failure/irreparable of those items.*
- d) The expenses related to hiring of Loring M/c for loading/unloading of pipes into tube well shall be bear by the contractor during any fault occur in submersible pump.
- e) Electric Winding and any Electrical faulty work will be done by the contractor.
- f) The tenderer shall have make own arrangement for required tools & tackles for executing the maintenance work.
- g) Tendered shall have ensure that the cleaning of GLR (Ground Level reservoir) available at Nimbla tube well and Mines site on routine basis.
- h) Tenderer deployed persons should have quit healthy, soft spoken and good behavior.
- i) Tenderer shall have submit documents related to deployed persons i.e. identity proof, valid mobile number, Police Verification Certificate & Medical Certificate to the RSMML.
- j) Tenderer deployed person should have well knowledge about electrical equipment, Mono-Block pump, submersible pump, PVC pipes & Cement pipe.
- k) All safety precautions as per government directives w.r.t. COVID-19 i.e. Social Distancing, Use of Face Mask and Hand Sanitizer etc, needs to be strictly followed while carrying out the work at our site.
- i) The safety of manpower deployed by the party will be in the scope of party itself and RSMML will not be liable for any compensation against any kind of mishappening /accident occurred during the execution of the work. The personal safety equipments used during execution of the work will have to be arranged by the contractor.

## **2. PRE-QUALIFICATION OF TENDERER:**

The Tenderer should have successfully executed at least one similar nature work of in value not less than Rs. 1.25 lacs in any one of the immediate preceding three financial years i.e. 2021-22, 2022-23 & 2023-24 in tenderer's name. Attested Copy of CA audited Balance Sheets and Profit & Loss Account/ TDS Certificate/Form-16 in support of turn over.

## **3. BID SECURITY / EARNEST MONEY DEPOSIT**

- (a) Earnest Money Deposit as per NIT is to be furnished by Demand Draft / Pay Order / Banker's Cheque in favour of "Rajasthan State Mines & Minerals Ltd." payable at Jaipur. This DD/ Pay Order should be enclosed and submitted with the Techno- Commercial offers. Offers without Earnest Money Deposit are liable to be rejected/ ignored. The Earnest Money Deposit shall not bear any interest.
- (b) The Earnest Money Deposit of the successful tenderer can also be appropriated towards security Deposit, if the contractor so desires. The Earnest Money Deposit of the disqualified tenderers, who have been disqualified in the techno-commercial evaluation, shall be refunded at the earliest. The Earnest Money Deposit of the other tenderers shall be refunded after issuance of LOA/DLOA to the successful tenderer.
- (c) Offers without Earnest Money Deposit shall be summarily rejected. The Company shall not accept Earnest Money Deposit in any other form like cheque, Bank Guarantee, FDR's etc.
- (d) The Earnest Money Deposit shall be forfeited in the following cases :
  - i.) If the tenderer withdraws or modifies the offer during the validity period of the offer.
  - ii.) If the tenderer does not deposit the prescribed security deposit in the prescribed time period.
  - iii.) If the tenderer does not execute the agreement in the prescribed format within the specified time.
  - iv.) If the tenderer provides false information/forged documents/false attestation of documents in the offer or thereafter to claim eligibility/ qualify for the contract.
  - v.) If the tenderer does not commence the work within the stipulated period and also not accept the offer made by the company or subsequent to acceptance of his/their offer by the company.

## **4. TWO PART TENDER:**

Tenderers are required to submit their tenders in three separate sealed envelopes: duly superscripted on each i.e. containing "Techno Commercial Bid" other containing "Price Bids" and these sealed envelopes i.e. the envelope containing "Techno Commercial Bid" and the envelopes containing "Price Bids" should be placed in an envelope which should also be sealed and superscripted with the Tender No., Name of the tenderer and the Due Date in bold letters.

**5. Documents to be attached with the TECHNO-COMMERCIAL bid:**

Following documents are to be enclosed alongwith the offer:

- a) Tenderer descriptive form (Annexure II).
- b) A bid security of Rs.10,000/-.
- d) Duly Attested Photocopy of Partnership Deed & Registration Certificate of the firm & copy of Memorandum and article of Association in case of a Company.
- e) Power of Attorney in favour of constituted attorney authorizing him to sign tender documents.
- f) Duly attested copy of turnover of Rs.1,25,000/- in any one of the last three preceding financial years i.e. 2021-22, 2022-23 & 2023-24 in the tenderer name.
- g) Copy of tender document duly signed & stamped as token of acceptance.
- i) EMD (Security Money) as prescribed in the Tender.
- j) Undertaking as per Annexure-III that no condition is mentioned in the Annexure -III (Price Bid).
- k) In accordance to recent RTPP Rules, 2013, following annexure have been attached:-
  - Annexure A: Compliance with the code of Integrity and No Conflict of Interest.
  - Annexure B: Declaration by the Bidder regarding Qualifications.
  - Annexure C: Grievance Redressal during Procurement Process and Form No.1
  - Annexure D: Additional Conditions of Contract.
- l) Amendments/Clarifications issued by GoR from time to time regarding RTPP Act, 2012 and RTPP Rules, 2013 may also be applicable.

**6. PRICE BID (ANNEXURE-III):**

Price Offer to be given as follows:

- i. The rates offered should be submitted in the proforma prescribed at Annexure III. The rate quoted by the tenderer should be written both in "figures" & "words". In case of variation i.e. figure and words, the lower of the two would be considered.
- ii. The price bid should be in the prescribed format only.
- iii. The rates quoted shall be firm and fixed, except for diesel/petrol escalation as provided elsewhere in the tender document.
- iv. No additions/modifications/alterations in the terms & conditions of the tender document should be written on the Price Bid or enclosed with the Price Bid. In case any such addition/ modification/ alteration is written or enclosed with the "Price Bid" then the same shall not be considered & may also result into disqualification of the tender. No correspondence in this regard would be entertained.

**7. DELIVERY OF THE TENDER DOCUMENT:**

The tender shall be submitted in two sealed envelopes, on the outer envelope being superscribing "TENDER FOR "Annual Maintenance Contract for operation of Nimbla Tubewell at Giral Lignite Project, Barmar"". The out cover shall be addressed to Manager (Mech.-Contract), RSMML, Khanij Bhawan,

Jaipur. Tenders which do not comply with these instructions may be summarily rejected.

- I The tenders should reach the office of Manager (Mech.-Contract), RSMML, Khanij Bhawan, Jaipur on or before 21.08.2024 upto 03:30 PM.
- II RSMML shall not be liable for any delay & misplacement of tender sent by post / courier.
- III Offer on fax/e-mail will not be accepted.

#### **8. SUBMISSION & OPENING OF TENDER (Techno Commercial Bid):**

The tenderer should submit their sealed offer in the Office of Manager (Mech.-Contract) on 21.08.2024 upto 03:30 PM. The Techno Commercial Bid of the tender will be opened in the office of Manager (Mech.-Contract), RSMML, Khanij Bhawan, Jaipur on 22.08.2024 upto 11:30 A.M. in presence of the tenderers, who wish, to be present either in person or through an authorized representative at the time of opening of the tender.

The opening date of the Annexure- II i.e. PRICE BID shall be informed separately to those successful bidders who have qualified in the Techno Commercial Bid.

#### **9. Period Of Contract**

The contract period shall be two (02) year from the date of issue of Work-Order. The contract period shall be extended up to 50% as per RTPP act 2012 & Rule 2013 and all amendments issued by GoR from time to time will be also applicable.

#### **10. Submission of offers**

The sealed offers should be submitted in the office of Manager (Mech.-Contract), SBU & PC-Lignite, RSMML, Jaipur on or before the date and time mentioned in the tender. The offers shall be opened on the date and time mentioned in the tender in the presence of the tenderer or their representatives. Late received offers will not be accepted.

#### **11. Validity of offers**

The tender offers should remain valid and open for acceptance for a period of 120 days from the date of opening of the tender. No modification or revision or withdrawal of the offer shall be allowed during the validity period or the extended validity period, if any. In case any tenderer does so, the Earnest Money deposit of such tenderer shall be forfeited. In case refusal to accept the job offered or failure to commence the work within the stipulated time period, the Earnest Money Deposit shall be forfeited.

#### **12. SECURITY DEPOSIT**

- (a) The rates of Work Performance Guarantee as per the prevailing terms and condition of the Company are @ 10% of total contract value. The successful tenderer shall furnish a Security Deposit through any of the option in favour of RSMML, Jaipur within 15

days of the issuance of Letter of Acceptance. The successful tenderer shall furnish a Security Deposit by following options:

- (b) The contractor shall furnish Security Deposit @ 10% of Total contract value through Demand Draft in favour of RSMML, Jaipur /Bank Guarantee, within 15 days of the issuance of such communication of acceptance of tender/LOA, for due fulfillment of all or any of the terms & conditions of the contract. The Bank Guarantee shall be provided only in the approved format of the company from a PSU bank (except SBI) /ICICI/Axis/HDFC Bank having its branch at Jaipur on non-judicial stamp paper of 0.25% of BG value subject to maximum of Rs. 25000/-or on appropriate value under Indian Stamp Act prevailing on the date of issuance of BG. No amendment in this format shall be acceptable to the company. The Bank Guarantee shall be valid for the entire contract and/or extended period, defect liability period, plus a grace period of three months. The Company shall be entitled to encash the same and appropriate the whole of the amount or part thereof against its claims /dues or sums payable as contained herein.
- (c) The contractor may also opt to furnish SD by Fixed Deposit Receipt (FDR) equivalent to 10% of Total contract value issued from any Public sector bank (except SBI) /ICICI/Axis/HDFC Bank having its Branch office at Jaipur. FDR shall be in the name of RSMML on account of Successful bidder and discharged by him in advance. The accepting authority shall ensure, before accepting the Fixed Deposit Receipt, that the successful bidder furnishes an undertaking from the bank to make payment/premature payment of the Fixed Deposit Receipt on demand to the Company without requirement of consent of the successful bidder. In the event of forfeiture of the security deposit, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit without protesting by the contractor/him.
- (d) The Contractor at the time of signing of the contract agreement, may submit an option for deduction of security from his each running and final bill @ 10% of the amount of the bill. Further, in such case, the amount of bid security of successful bidder may be adjusted in arriving at the amount of the performance security, or refunded if the successful bidder furnishes the full amount of security deposit.
- (e) The Security Deposit shall be liable to be forfeited wholly or partly at the sole discretion of the Company, should the Contractor either fail to fulfill the contractual obligations or fail to settle in full, his dues to the Company, In case or premature termination of the contract, the Security Deposit will be forfeited and the Company will be at liberty to recover the loss suffered by it from the Contractor.
- (f) The Company may deduct from the Security Deposit any sum due and any other sum that may be fixed up by the Company as being the amount of loss or losses or damages suffered by it due to delay in performance and/or non-performance and/or partial performance of any of the terms of the contract.
- (g) All compensation or other sums of money payable by the Contractor to the Company or recoveries to be made under the terms of this contract may be deducted from any sums which may be due to the Contractor from the company on any account and in the event of

the such amount being insufficient the Contractor shall within ten days of such shortfall make good in cash, failing which the balance amount shall be recovered by way of invoking the bank guarantee furnished as security.

- (h) In the event of Bank Guarantee amount being insufficient, then the balance recoverable amount shall be deducted from any sum, then due or which at any time thereafter may become due to the contractor. The Contractor shall pay to the company on demand any balance remaining due.
- (i) In case the Bank Guarantee is invoked for any reason/s, the contractor is required to furnish a fresh Bank Guarantee in the same format for the same amount and for the same period as the original Bank Guarantee within a period of 10 (Ten) days from the date of invoking of original Bank Guarantee.
- (j) In case of enhancement of quantum of work, due to any reason, the contractor shall furnish additional security amount. This security will be progressively recovered from the payment due to the contractor.
- (k) The entire Security Deposit shall be refunded after the expiry of contract & completion of defect liability period, provided the Contractor has fulfilled all contractual obligations and he has rendered "No claim and No Dues Certificate" to the Company.
- (l) In the event of security amount at any time during the currency of the contract falling short of the specified amount, due to enhancement of quantum of work, or due to any reason, the Contractor shall furnish additional security amount, so that the total amounts of Security Deposit will not be at any time less than the amount so specified. The Company may recover the same by way of additional deductions from the payment due to the contractor.
- (m) No interest is payable on S.D. amount.

### **13. ADDITIONAL PERFORMANCE SECURITY.-**

In addition to Performance Security as specified in rule 75 of RTPP Act & rules, an Additional Performance Security shall also be taken from the successful bidder in case of unbalanced bid. The Additional Performance Security shall be equal to fifty percent of Unbalanced Bid Amount. The Additional Performance Security shall be deposited in lump sum by the successful bidder before execution of Agreement. The Additional Performance Security shall be deposited through e-Grass, Demand Draft, Banker's Cheque, Government Securities or Bank Guarantee. Explanation : For the purpose of this rule,-

- I. Unbalanced Bid means any bid below more than fifteen percent of Estimated Bid Value.
- II. Estimated Bid Value means estimated value of the work as mentioned in bidding documents.
- III. Unbalanced Bid Amount means positive difference of eighty five percent of Estimated Bid Value minus Bid Amount Quoted by the bidder.
- IV. The Additional Performance Security shall be refunded to the contractor after satisfactory completion of the entire work. The

Additional Performance Security shall be forfeited by the Procuring Entity when work is not completed within stipulated period by the contractor.

**14. Award of Contract**

The company shall communicate to successful tenderer (L-1 bidder) to accept their tender offer/work order.

**15. Rate and Tax deductions at source**

The company shall be fully entitled to deduct income tax and/or any other taxes levied at source as per the rules and instructions as may be applicable for this purpose from time to time.

The rate quoted by contractor shall be inclusive of all applicable taxes, duties as on applicable on the date of submission of the tender except GST. If GST is applicable on the contractor, the same shall be reimbursed by the company.

**16. Terms of Payment**

- i. For payment purposes the contractor shall raise the monthly bill in triplicate along with the supporting documents to receive its remuneration from the RSMML and the bills shall be duly verified by the Engineer In-Charge. The rates as accepted by the Company shall only be considered for billing purpose. The contractor shall submit an undertaking with bills bearing GSTIN and HSN/SAC code that "total GST has been deposited and returns have been filed for relevant tax period".
- ii. Payment will be made through RTGS/NEFT. All bank charges / commission , if any shall be borne by the supplier.

**17. Right of Company**

The Company reserves the right-

- i. To accept or reject any or all the tenders, in part or in full, without assigning any reason, there to,
- ii. Not to accept the lowest tender or assign reasons for not accepting the lowest tender.
- iii. To increase/decrease the quantity and period of contract, without any additional obligation on it.
- iv. Not to carry out any part of work.
- v. To reject the offer, if is established that the tenderer has submitted any wrong/ misleading information or forged documents along with offer or thereafter.

The company may exercise any of the above right at any time prior to the award of contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the RSMML's action.

**20. Termination of the Contract**
