RSMML (RECRUITMENT AND PROMOTION OF WORKMEN FROM CATEGORY IX/IX-S TO E-1 CATEGORY OF EXECUTIVE POSTS) RULES, 2012

- 1. Short title and commencement These rules shall be called Rajasthan State Mines & Minerals Limited (Recruitment and Promotion of Workmen from Category IX/IX-S—to E-1 Category of Executive Posts) Rules, 2012. These rules shall come into force w.e.f. 01.04.2012.
- 2. Applicability These rules shall be applicable to the workmen of the Company working in Category IX/IX-S (PB-2) 9300-34800 and Grade Pay 4800/- / 5400/- with appropriate designation of that category, but shall not apply to the following categories of workmen:
 - (i) Workmen on deputation;
 - Workmen appointed on contract/ ad-hoc basis or working on fixed remunciation or on consolidated pay;
 - (iii) Workmen drawing grade pay of Category IX due to stagnation promotion:
 - (iv) Apprentices; and
 - (v) Workmen appointed on stipendiary basis.
 - 3. Cadres of promotion Promotion of eligible workmen from Category IX/IX-S to E-1 Category of Executives shall be made in all cadres subject to availability of vacancy.
 - 4. Qualification & Experience —

 Minimum qualifying experience for promotion of workmen from Category IX to

 E-1 category of executive The minimum qualifying experience for promotion from

 Category IX to E-1 category of executives shall be in accordance with Schedule-1

 annexed to these rules.
 - 5. Basis of Promotion The basis of promotion shall be as follows -
 - (i) A list of all eligible candidates of the organisation shall be prepared in order of seniority for the regular post in Cat.IX on the basis of date of holding of the post on regular basis..

- (ii) The workmen of category IX/IX-S possessing above qualification and experience and having good service record shall be called for written test followed by personal interview.
- (iii) The minimum passing marks for promotion would be 45%.
- (iv) The Selection Committee shall prepare panels of the selected candidates as per seniority. This panel would remain valid for a period of one year.
- (v) 33% of the posts available in E-1 category in each cadre shall be filled up by promotion and the balance 67% shall be filled up by direct recruitment.
- (vi) In case of non availability of eligible candidates in IX/IX-S category of workmen for promotion to E-1, the vacancy will be kept un-filled for two years only. Thereafter in case of requirement the vacancy will be filled up through direct recruitment.
- (vii) The number of vacancies falling under each quota shall be determined by the management at the beginning of the financial year, taking into account, as far as possible the vacancies likely to accrue during that financial year.
- 6. Selection Committee The Selection Committee shall comprise of the following :-
 - 1 Managing Director
 - 2. Concerned Head of the Department/Unit Head
 - 3. One technical officer nominated by the M.D.
 - 4. Head of the Personnel & Administration Department
 - 7. The workmen promoted from category IX/IX-S to E-1 category of executive win be governed by the Service Rules and all other rules as applicable to the executives of the Company, from time to time, from the date of promotion.
 - 8. On promotion to higher posts, the concerned workmen shall continue to discharge the job of existing category/posts.
 - 9. Probation Candidates promoted to E-1 category would be on probation as per rule 12 of the RSMML (Service) Rules, 1975 (Officers). In case the performance of the probationary executive is not found satisfactory, even after extension, he would be reverted back to his post in workmen category which he was holding immediately prior to his promotion in E-1 category. Upon such reversion, the pay of the workmen would be notionally fixed in category IX/IX-S, as the case may be, assuming that he is continuing in category IX/IX-S.
 - 10. The Managing Director shall be competent to interpret these rules and his decision shall be final and binding.
