## OFFICE - ORDER

The Management is pleased to order that the existing rate of dearness allowance payable to the employees governed under provisions of 7<sup>th</sup> Pay commission shall be revised 4% D.A from 46% to 50% w.e.f. 01.01.2024.

The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. pay drawn in the Pay Matrix of the prescribed Levels and shall not include any other type(s) of pay like special Pay or Personal Pay etc.

The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

The mode of payment of increased D.A. & arrears in respect of the employees of the State Government on deputation with RSMML shall be regulated as per order No.F.6(3)FD (Rules)/2017 dated 14.03.2024 as under (Copy enclosed):-

A. For employees governed under provisions of Rajasthan Government Servants General Provident Fund Rules, 2021.

The amount of increase in DA for the period from 01.01.2024 to 29.02.2024 shall be credited to the GPF Account as under:-

- (i) For the employees recruited before 01.01.2004 - GPF Account.
- (ii) For the employees who were recruited on or after 01.01.2004 - GPF - 2004.

Cash payment shall be admissible from 01.03.2024 i.e. salary for the month of March, 2024 payable on 01.04.2024.

B. For employees governed under provisions of Contributory Pension Scheme.

The revised DA @ 50% payment shall be admissible from 01.01.2024 i.e. salary for the month of March, 2024 payable on 01.04.2024. The arrear amount of increase DA for the period from 01.01.2024 to 29.02.2024 shall also be paid in cash.

This bears approval of the competent authority.
