ORDER

Sub: Implementation order of Modified Lock Down (04-17, 2020) declared by Home Department, GOR vide order No.P.33(2)Home-9/2019 dated 02.05.2020.

The lockdown imposed in the entire country has been extended up to May 17th, 2020 vide Order No.40-3/2020-DM-I-(A) dated May 01, 2020 issued by Ministry of Home Affairs, GOI and thereafter by the Home Department, GOR alongwith detailed guidelines vide its order dated 02.05.2020.

In compliance of above cited order dated 02.05.2020 of Home Department, GOR the lockdown period at this establishment is hereby extended further for the period of two weeks from 04.05.2020 to 17.05.2020.

In continuation to our earlier Order No.RSMML/CO/Pers/10(1)/2015-1092 dated 17.04.2020, regarding implementation guidelines of modified lockdown, the new modified implementation of guidelines issued by Home Department, GoR for modified lockdown period (i.e. 04.05.2020 to 17.05.2020) vide order No.P.33(2)Home-9/2019 dated 02.05.2020 shall also applicable at **all Company offices i.e. Corporate Office, Registered Office, SBU Offices- Jaipur, Jodhpur, Bikaner, Jaisalmer, Barmer.**

Operation of all mines will be as per our earlier Order No.RSMML/CO/Pers/10(1)/2015-1084 dated 31.03.2020 and Order No.RSMML/CO/Pers/10(1)/2015-1087 dated 08.04.2020 subject to the permission given by the competent authority and conditions laid down therein. However, the directions issued vide our earlier order No.1092 dated 17.04.2020 and above will applicable to the mines also.
